REGULAR MEETING

Chair Jeff Cogen convened the meeting at 9:36 a.m. with Vice-Chair Deborah Kafoury and Commissioners Diane McKeel and Judy Shiprack present and Loretta Smith excused.

Also in attendance were Henry H. Lazenby, Jr., County Attorney, and Marina Baker, Assistant Board Clerk.

R.1 Second Reading to Consider ORDINANCE Amending Commissioner District Boundaries in Compliance with Multnomah County Home Rule Charter. Presenters: Steve March and Shannon Grzybowski, Auditor's Office.

Commissioner Shiprack moved and Vice-Chair Kafoury seconded approval of the second reading.

Dr. March explained that no changes were made to the Ordinance since the first reading. He offered to review the Ordinance, but the Board was satisfied with the full presentation given at the first reading. He responded to Board questions and comments.

The second reading was approved and Ordinance No. 1185 was adopted.

R.2 Approval of Multnomah County and International Brotherhood of Electrical Workers Local 48 AGREEMENT. Presenter: Jim Younger, Labor Relations Manager; Alan Keser, Local 48.

Commissioner Shiprack moved and Vice-Chair Kafoury seconded approval of R.2.

Messrs. Younger and Keser provided the explanation and responded to Board questions and comments. The Board thanked the Local 48 for their collaboration in putting together this agreement.

The agreement was unanimously approved.

Vice-Chair Kafoury moved and Commissioner Shiprack seconded approval of R.3.

Chair Cogen provided the introduction. Ms. Nichols gave an explanation and introduced the other speakers. Ms. Madrigal thanked the Board for considering this Proclamation. She spoke about her personal experience with breastfeeding and the challenges and successes she underwent. Ms. Kaplan spoke about the services the County Health Department provides to the community. Mr. Brown and Ms. Wachsmuth spoke about the benefits of breastfeeding and services provided to mothers. Ms. Manhas spoke about her personal experience and the services and accommodations provided to County employees.

Ms. Madrigal read the Proclamation into the record and showed a video called "Multnomah County: Helping moms do what's best for baby."

The Commissioners spoke about personal experiences and thanked the presenters.
