RESOLUTION NO. 2012-142

Authorizing Cancellation of Uncollectible Personal Property Taxes for Tax Years 1989/90 through 2011/12

The Multnomah County Board of Commissioners Finds:

- a. Certain personal property taxes have been delinquent and the Multnomah County Tax Collector and County Attorney have determined that said taxes are wholly uncollectible and have requested the Board for an order directing that the taxes be cancelled pursuant to ORS 311.790.

The Multnomah County Board of Commissioners Resolves:

1. That the Multnomah County Tax Collector is directed to cancel those certain personal property taxes which are listed and appended hereto and incorporated herein, for tax years 1989/90 through 2011/12 for the reason that the same are found to be uncollectible.
