General Information

1. What action are you requesting from the Board?

Adoption of a resolution requesting Governor's declaration of state of emergency and declaring an emergency requiring immediate Board action

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

USDA Farm Service Agency for Clackamas/Multnomah Counties requested that the Boards of each county begin the process to declare these counties as disaster areas due to crop production losses resulting from three months of low temperatures and excessive rain from April through June. Farm Service Agency estimates the percentage of yield loss for affected crops as follows:

- Marion berries and other cane berries 30%-50%
- Strawberries 25%-40%
- Late planted vegetables and field corn 20%-40%

This action is expected to result in the Governor seeking a disaster declaration by the U.S. Secretary of Agriculture. Such a declaration will make affected producers eligible for Farm Service Agency (FSA) low interest Emergency loans and will make an increased number of growers eligible for the Supplemental Revenue Program from the Farm Service Agency. Additionally, FSA borrowers who

are unable to make loan payments timely due to disaster conditions may qualify for rescheduling of payments.


