Thank you Chair and thank you commissioners for allowing my testimony today. My name is De'Andre Frison, and I'm a Counselor in training with **VOA**.

VOA has generously helped me in paying for my education, and at this point, I have completed all my coursework to be a Certified Alcohol and Drug Counselor through a paid practicum at Volunteers of America, I expect to have earned all my hours to be certified by June.

VOA has supported me in my journey beginning first as a client, then a professional mentor and now a counselor. CPR is made up of individuals who genuinely care about me and my future.

I was raised in NE Portland with very few positive role models to look up to. I got into serious trouble at an early age. By 18, I was in prison. While in prison, I met VOA staff from the Community Partners Reinvestment Program, and for me, CPR was the missing piece to the puzzle.

I wanted to do the right thing, but I never had someone to firmly guide me on the right path. I was only 21 years old when I started attending weekly CPR classes in prison, and when I came home, CPR staff continued to support me in learning valuable life skills that I needed to help turn my life around.

It took an enormous amount of hard work and perseverance. I understand the fear and defiance that keep so many of these young men---and almost kept me---from arriving where I'm at now.

At 25, I was hired as a CPR Mentor through a Second Chance Act grant. I was a professional mentor for over 5 years working with VOA and Bridges to Change.

My goal is to be hired as a fulltime CPR Counselor delivering the HEAT curriculum. I believe that CPR and HEAT are some of the most successful interventions we have for young men who have had the same upbringing and life experiences as I have.

- The HEAT curriculum helps young African American men understand their own identity and learn what it is to be a man
- CPR staff like myself and Choo Fair serve as role models who speak a common language with these young men struggling to do the right thing
- Choo was recently pardoned by the Governor of Oregon. And our clients really respect him because he comes from a similar background and he's become successful.
- We work hand in hand with DCJ Probation Officers – these PO's really work with these young men when they make mistakes rather than just putting them in jail.

CPR, VOA and DCJ have helped young African American men like Choo and I overcome some of our most difficult obstacles. They believe in us just like we believe in the young men we serve today in the CPR program.

Thank you, Chair and thank you commissioners for allowing my testimony today. My name is Kathy Sevos, and I'm the Director of Reentry and Transition Services at ***Volunteers of American Oregon***.

Today, De'Andre Frison and I are here to highlight the strong work of the **Multnomah County Department of Community Justice** and their commitment as a long-term partner. VOA works together with DCJ on ***Multnomah County's Justice Reinvestment Program (MCJRP)*** saving millions of dollars and impacting thousands of lives.

It was a pleasure to give many of you a tour of the **Treatment Readiness Dorm** at the ***Inverness Jail*** in March, a true partnership with both DCJ and the Multnomah County's Sherriff's Office.

VOA first gained our expertise at the Inverness Jail by operating the ***Community Partners Reinvestment or CPR Program***, replicating our successful prison reentry program – this partnership with DCJ extends over the past 18 years.

The CPR Program is unique and is the only program that delivers treatment, recovery and reentry services to high-risk young men ages 18 to 25:

- both inside prisons, jails and youth detention facilities as well as here in the community - creating a continuum of care for up to a year post-release.
- CPR utilizes evidenced based practices and curriculum designed to engage young, developing brains and create relationships before release to reduce their risk to re-offend
- Data demonstrate 50% of 18-25 year olds in Multnomah County return to prison within 3 years
- Comparatively, in a 5-year independent evaluation by PSU, CPR participants had only 32% recidivism.

Multnomah County and the Oregon Department of Corrections, who fund the pre-release component of our program, have been key partners since launching CPR in 2000.

Together we have continued to be responsive to our diverse population enhancing programming with innovative, culturally-specific services for African-American and Latinos, including those supervised by DCJ's gang unit.

- Young men under 25 are the most likely to join gangs and commit violent crimes in our community.
- Currently, 46% of participants in CPR's Jail program are young men of color
- Astoundingly, 76% of our participants in prison right now awaiting release to Multnomah County are young men of color
- And 66% of our CPR prison population is gang impacted.

To further support these young people of color in our community, CPR and DCJ have embarked on a new partnership bringing the transformative HEAT curriculum (Habilitation Empowerment Accountability Therapy) to Multnomah County.

Through innovative programming like the HEAT curriculum designed specifically for young African Americans

- We are successfully engaging some of our most dangerous gang members who typically present with little motivation for treatment and denial around their level of dependency.
- 100% of our HEAT participants are young gang involved, African-American men who need role models.
- We are also exploring adapting HEAT for Latinos ages 14-25.

CPR and Multnomah County have together developed innovative services so young men can thrive, raise their own families and break the intergenerational cycle of gang association and incarceration.

Although CPR is not funded in the budget at its current level, it is our understanding that the Department is identifying ways to restore full funding for this critical, effective program.




