**BOARD BRIEFING/WORK SESSION**

Chair Ted Wheeler convened the meeting at 10:05 a.m., with Vice-Chair Jeff Cogen and Commissioners Lisa Naito and Maria Rojo de Steffey present, and Commissioner Lonnie Roberts arriving at 10:08 a.m.

**B-1 Justice Mapping Briefing. Presented by Eric Cadora, Co-Founder of the Justice Mapping Center in Brooklyn, New York.**

COMMISSIONER NAITO COMMENTS AND INTRODUCTIONS.

Commissioner Lonnie Roberts arrived at 10:08 a.m.

ERIC CADORA, CO-FOUNDER OF THE JUSTICE MAPPING CENTER IN BROOKLYN, NEW YORK PRESENTATION OF COMPUTER MAPPING OF NEW YORK CITY, PHOENIX, HOUSTON, LOS ANGELES COUNTY, SOUTH CENTRAL LOS ANGELES AND LAS VEGAS TO HELP UNDERSTAND, EVALUATE, AND COMMUNICATE CRIMINAL JUSTICE AND OTHER SOCIAL POLICY INFORMATION; HELP REVEAL PATTERNS AND REALITIES; CREATE PLACE-BASED MEASURES OF PERFORMANCE THAT BUILD SHARED GOALS AMONG SEPARATE AGENCIES; AND PROVIDE COMPELLING VISUALIZATIONS OF POLICIES THAT ARE EASILY UNDERSTOOD BY A WIDE VARIETY OF CONSTITUENTS. .MR. CADORA RESPONSE TO BOARD QUESTIONS AND COMMENTS REGARDING RECIDIVISM; REVOCATIONS TO PRISON; JAIL PRISON POPULATIONS; PRISON COSTS; RETURN ON PUBLIC SAFETY INVESTMENT; NEED FOR CIVIL INSTITUTIONS RATHER THAN CRIMINAL JUSTICE AND RECONNECTING YOUTH WITH SOCIAL STRUCTURES; AND NEED FOR INNOVATIVE SOLUTIONS.

The meeting was recessed at 10:59 a.m. and reconvened at 11:04 a.m. with all Commissioners present.

**WS-1 Budget Work Session. Presented by Bill Farver, Karyne Dargan and Invited Others.**

BUDGET DIRECTOR KARYNE DARGAN PRESENTED UPDATED BUDGET AMENDMENTS AND NOTES, AND ADVISED THAT THE DEPARTMENT HANDLING THE 2010 CENSUS WILL PROVIDE FUNDING SO THE NAITO BOARD AMENDMENT IS NOT NECESSARY. MS. DARGAN EXPLAINED THE BUDGET NOTE TITLED "SHERIFF'S OFFICE AUTHORIZATION FOR OVER-STAFFING CORRECTIONS DEPUTIES" HAS BEEN REVISED EXCLUDING THE WORD "CORRECTIONS" BECAUSE THE BUDGET NOTE RELATES TO LAW ENFORCEMENT DEPUTIES AS WELL AS CORRECTIONS DEPUTIES. MS.

DARGAN EXPLAINED PROGRAM OFFER 72025, THE PUBLIC SAFETY BOND FUND, REIMBURSES THE GENERAL FUND \$425,000 FOR A LOAN MADE IN FISCAL YEAR 2007 FOR JUMPER RAILS AT INVERNESS JAIL.

IN RESPONSE TO A QUESTION OF CHAIR WHEELER, DEPUTY BUDGET DIRECTOR MARK CAMPBELL EXPLAINED THAT PROGRAM OFFER 72022, TAX ADMINISTRATION ACCOUNTING ADJUSTMENT, CHANGES THE COUNTY'S PAYMENT TO PORTLAND FOR BUSINESS INCOME TAX COLLECTION TO AN EXPENSE RATHER THAN A REDUCTION FROM THE REVENUE DISTRIBUTION, WHICH IS A CHANGE IN ACCOUNTING PRACTICE WHICH HAS NO NET EFFECT ON REVENUES OR EXPENSES BUT PROVIDES MORE TRANSPARENCY IN BUSINESS INCOME TAX COLLECTIONS.

MS. DARGAN DISCUSSED TECHNICAL AMENDMENTS, STAFF AMENDMENTS, REVENUE AMENDMENTS AND CARRYOVER AMENDMENTS. IN RESPONSE TO A QUESTION OF COMMISSIONER ROJO, MS. DARGAN ADVISED THE \$10,000 IN PRIVATE DONATIONS FOR THE SAUVIE ISLAND BRIDGE OPENING CELEBRATION MAY BE EXPENDED IN FISCAL YEAR 2008 AND OR FISCAL YEAR 2009. COMMISSIONER ROJO ADVISED SHE WANTS TO PROVIDE CARRYOVER FUNDS FROM HER OFFICE TO THE COMMISSION ON CHILDREN, FAMILIES AND COMMUNITY BUDGET SO THAT THE COMMISSION ON CHILDREN, FAMILIES AND COMMUNITY YOUTH STAFF MAY ATTEND A CONFERENCE IN JULY.

DEPUTY BUDGET DIRECTOR MARK CAMPBELL PRESENTED UPDATE ON STATE FORECAST. CHIEF OPERATING OFFICER BILL FARVER DISCUSSION AND RESPONSE TO BOARD COMMENTS REGARDING CHAIR WHEELER'S JUNE 2, 2008 BUDGET MEMO RECOMMEND-ATIONS TO RECONCILE THE BOARD'S PRIORITIES WITH AVAILABLE RESOURCES USING ONE TIME ONLY FUNDING IN THE AMOUNT OF \$108,000 FOR HOMELESS YOUTH; A BUDGET NOTE EARMARKING \$450,000 FROM FACILITIES CONTINGENCY FOR THE COURTHOUSE 2010 PROJECT; FUNDING FOR 4.20 FTE CORRECTIONS HEALTH NURSES AND REDUCING 2010 CENSUS FUNDS TO \$25,000. COMMISSIONER ROJO ADVISED SHE WOULD REDUCE HER AMENDMENT TO \$100,000 FOR FUNDING PARTICIPATORY RESEARCH FOR COMMUNITIES OF COLOR.

COMMISSIONER NAITO AND MR. FARVER DISCUSSED BUDGET NOTE REGARDING USE OF ADDITIONAL CONTINGENCY. COMMISSIONER ROBERTS AND CHAIR WHEELER DISCUSSED DEBT BUY DOWN OF THE MCCOY AND MEAD BUILDINGS. MR. FARVER CLARIFIED COMMISSIONER ROBERTS' PUBLIC SERVICES PATHWAYS AMENDMENT, STATING THE COUNTY SHOULD REQUEST THAT WORK SYSTEMS, INC. PROVIDE ONGOING FUNDING IF THE OPEN MEADOWS COLLABORATION IS SUCCESSFUL. COMMISSIONER COGEN ADVISED HE IS OKAY WITH THE CHANGE TO HIS 2-1-1 AMENDMENT AND HAVING THE DEPARTMENT OF COUNTY MANAGEMENT DEVELOP A CONTRACT FOR 2-1-1. COMMISSIONER NAITO ADVISED SHE WILL WORK ON WORDSMITHING HER BUDGET NOTE REGARDING THE HEIGHT ADJUSTMENT

OF THE DOWNTOWN COURTHOUSE PROJECT AND FACILITIES THIS AFTERNOON. CHAIR WHEELER, MR. FARVER AND COMMISSIONER ROBERTS DISCUSSED THE EXPECTED HIGHER NUMBER OF BOOKINGS DURING THE SUMMER AND THE POSSIBILITY THE COUNTY MAY NEED TO CONTINUE FIELD BASED WORK RELEASE THROUGH THE SUMMER MONTHS TO PROVIDE AN ADDITIONAL MARGIN TO AVOID REPEATED MATRIX RELEASES.

AT THE SUGGESTION OF MS. DARGAN, COMMISSIONER ROBERTS WITHDREW HIS PREVIOUS FIELD BASED WORK RELEASE AMENDMENT AND PROPOSED AN AMENDMENT TO FUND THE FIELD BASED WORK RELEASE PROGRAM FOR AN ADDITIONAL NINE MONTHS. COMMISSIONER NAITO ADVISED SHE WANTS A BUDGET NOTE FOR CONTINGENCY FUNDS TO PROVIDE CAPITAL FUNDING FOR THE PLANNED SUB-ACUTE MENTAL HEALTH FACILITY. MR. FARVER DISCUSSED OTHER PUBLIC SAFETY RELATED ISSUES FROM CHAIR WHEELER'S JUNE 2, 2008 BUDGET MEMO RECOMMENDATIONS. MS. DARGAN DISCUSSED THE VOTING PROCESS FOR THURSDAY.

COMMISSIONER ROBERTS THANKED THE BOARD FOR THEIR HARD WORK ON THE BUDGET AND ADVISED HE WILL NOT SUPPORT THE BUDGET BECAUSE OF HIS CONCERN OVER THE LACK OF FUNDING FOR THE EAST COUNTY NEIGHBORHOOD DISTRICT ATTORNEY PRO-GRAM, THE SPECIAL INVESTIGATIONS UNIT AND THE SHERIFF'S OFFICE BUDGET.

COMMISSIONER NAITO EXPRESSED HER APPRECIATION FOR THE WORK OF THE BUDGET OFFICE STAFF, HER STAFF AND CAROL WESSINGER OF THE LOCAL PUBLIC SAFETY COORDINATING COUNCIL. COMMISSIONER NAITO ACKNOWLEDGED HER SUPPORT OF FUNDING FOR PUBLIC SAFETY, HOMELESS YOUTH, DOWNTOWN COURTHOUSE, SUB-ACUTE FACILITY AND CORRECTIONS HEALTH NURSES, AND ADVISED THIS WAS THE SMOOTHEST BUDGET PROCESS SHE HAS GONE THROUGH.

COMMISSIONER ROJO EXPRESSED HER APPRECIATION FOR ALL MULTNOMAH COUNTY STAFF, ADVISING THIS IS HER LAST BUDGET BUT SHE WILL BE BACK NEXT YEAR ADVOCATING FOR SENIORS AND SEXUAL MINORITY YOUTH. COMMISSIONER ROJO ADVISED THIS WAS THE SMOOTHEST AND EASIEST BUDGET EVER.
