Each year, Multnomah County Animal Services reunites approximately 1,500 pets with their owners and cares for almost 7,000 homeless and stray pets. Our services depend on license fees and we want to thank you for being a responsible pet owner. Pets wearing license tags can be easily reunited with owners. Our records indicate that licensing for the following pet(s) is now due:

Pet	Status & Fees
Charger Lic# 228139 RabiesExp 4-2014	Regular 1 Yr (\$30) -- 2 Yr (\$50) -- 3 Yr (\$65)

The rabies vaccination must be valid for the entire licensing period. Your license fee has been reduced if your pet is spayed/neutered. Senior citizens (65 yrs and older) will also receive a discount.

Please keep in mind that licensing pets is required by the county ordinance and we are required by law to issue a **Notice of Infraction** to persons who fail to fulfill their license obligations. If you no longer own the pet, please report this on our web site or on the enclosed form.

- In person at the shelter during regular business hours: 1700 W Columbia River Hwy, Troutdale, OR 97060 (Tuesday - Sunday; please call for hours)

- At your local vet. Go to MultCoPets.org and from the "Licensing" menu, select "License Vendors". Select a nearby license vendor and bring them this letter.

Thank you in advance for your cooperation. I look forward to a fair and expeditious review of this matter.



Can Francesconi be the comeback kid?

After failed mayoral bid, politico seeks county chair post

When Jim Francesconi first ran for Portland City Council in 1996, he was the social justice-minded community organizer, the friend to the injured worker and disadvantaged, the outsider pounding on the doors of City Hall.

But after eight years on the City Council, Francesconi's political career fizzled after he cozied-up to downtown business leaders, raising an unprecedented \$1 million in an unsuccessful bid for mayor.

A decade after that embarrassing defeat, Francesconi is back seeking the Multnomah County chair post, one of two main contenders along with former county commissioner and state lawmaker Deborah Kafoury.

Multnomah County voters

might well wonder which Francesconi will show up to run the county if he wins.

Will it be the activist Catholic committed to workers, the poor and dispossessed? Or will it be the friend of Portland's business elite known to some as the "\$1 million man?"


Right out the gate in this race, Francesconi adopted a message sounding like his old self, saying the rising gap between rich and poor is the key issue of our time.

"We're leaving a lot of people behind," Francesconi told community leaders in Gresham's Rockwood neighborhood at a recent roundtable discussion. "We

need to talk about the fact that poverty's almost doubled in the last 11 years in the county."

Francesconi's failed bid for mayor led to some deep soul-searching, he says. "It made me wiser and stronger and clearer about what I care about."

As his decades-long record of community activism attests, Francesconi has never been content to just practice law and retreat to private life. His wife, who initially didn't want him to

youth and others, working out of St. Andrew Catholic Church on Northeast Alberta Street and Eighth Avenue. Francesconi met his wife and lifelong partner in the Jesuit program, and joined the St. Andrew congregation, where he remains an active member.

Years later, Francesconi's Catholicism factored into the 2004 mayor's race, when he came out in favor of civil unions for same-sex couples, but not gay marriage. That same year, Democratic standard-bearer John Kerry, a Catholic running for president, staked out the same position.

But that was a year when some local governments, including Multnomah and Bentson,
