Filling a Vacancy in the Legislative Assembly, Oregon House of Representatives, District 42.

**The Multnomah County Board of Commissioners Finds:**

- a. Effective May 31, 2014 there is a vacancy in Oregon State Senate, District 42, due to the resignation of Representative Jules Bailey.
- b. Pursuant to state law, the Democratic Party Precinct Committeepersons of House District 42 met to choose nominees to fill the vacancy.
- c. The nominees chosen were: Rob Nosse, Marisha Childs, and Shane Jackson.
- d. In accordance with procedures established by the Secretary of State, the Multnomah County Board of Commissioners considered the nominations at a regular board meeting at 9:30 a.m. on June 26, 2014.
- e. At the conclusion of the public meeting the Commissioners voted to appoint Rob Nosse to fill the vacancy, said nominee having received the highest number of votes as indicated on the vote tabulation attached as Exhibit A.


**The Multnomah County Board of Commissioners Resolves:**




