

### Vector Control and Code Enforcement Advisory Committee

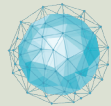
This committee is a group of nine citizens appointed by the Multnomah County chair to provide recommendations to the Health Department's Vector Control and Code Enforcement programs.

## 2016 Public Health Heroes Multnomah County Health Department Advisory Boards/Governing Councils

### Community Budget Advisory Committee

This committee helps to ensure that the Health Department's financial investments align with its mission and strategic priorities.

### Community Health Council

This council provides leadership and governance for the county's community health centers: including primary care, dental, early childhood services, school-based health centers and pharmacy services.

### Adult Mental Health and Substance Abuse Advisory Council

This council makes recommendations to the Multnomah County Mental Health and Addiction Services Division about the adult system of care. The council ensures that consumers and their families can provide input on mental health and addiction services available in their community.

### Multnomah County Public Health Advisory Board

This board provides broad stakeholder input from a variety of community sectors on work related to reducing health inequities and improving population health in Multnomah County.

### Nurse Family Partnership Advisory Council

This council seeks to capture the voice and experience of clients and community partners to help Multnomah County's Health Department with enrollment efforts, referrals, and stakeholder engagement for the Nurse Family Partnership program.

### Healthy Birth Initiative Community Action Network

This network's mission is to build on community assets to reduce social and life-course problems that contribute to poor birth outcomes and infant mortality within the African American community in Multnomah County.

### ACHIEVE Coalition

Action Communities for Health, Innovation and Environmental Change, also known as the ACHIEVE Coalition, was formed in 2009 to conduct community assessments to help improve health equity through policy implementation. Their focus rests on tobacco education, nutrition policies, affordability and access to healthy food, and encourages physical fitness.
