Approval of Area 93 Transfer Plan Agreement between Multnomah County and Washington County

The Multnomah County Board of Commissioners Finds:

- a.* It is in the interest of the State of Oregon to facilitate efficient and well-planned urban development on land included within an urban growth boundary.
- b.* It is preferable for county services to be provided by the county in which the territory receiving the services is located.
- c.* The portion of Multnomah County referred to as Area 93 was included within Metro's urban growth boundary in 2002. "Area 93" is the area depicted in Attachment A, Exhibit A and legally described in Exhibit B.
- d.* Area 93 is immediately adjacent to an urbanized portion of Washington County and separated from urbanized portions of Multnomah County and the City of Portland and more than one-half mile from the City of Portland's urban service district.
- e.* In 2013, the legislature enacted into law HB 3067 which provides for the transfer of Area 93 from Multnomah County to Washington County.
- f.* This law provides that the transfer of the Area 93 is contingent upon Multnomah and Washington Counties agreeing to a transfer plan.
- g.* Section 2 of HB 3067 (2013) provides that a group of two commissioners from each County shall be appointed to meet to establish the terms of the plan for the transfer of Area 93. A majority of this group presents the plan to their respective County Boards for a vote.
- h.* Washington County Chair Andy Duyck, and Commissioner Greg Malinowski, and Multnomah County Chair Jeff Cogen and Commissioner Deborah Kafoury, met on July 25, 2013 and agreed to a transfer plan (the "Agreement"), attached as Attachment A.
- i.* Attachment B is the Commissioners' Recommendation of the Area 93 Transfer Plan.

The Multnomah County Board of Commissioners Resolves:

1. The Multnomah County Board approves and adopts the transfer of Area 93 from Multnomah County to Washington County, as described in the attached Agreement, Attachment A.
2. Multnomah County will ensure the transfer of records and actions as identified in the Agreement prior to the effective date of January 1, 2014.
3. The Counties will continue to work together to ensure a seamless transfer.
4. Washington County and Multnomah County will submit the approved Agreement to the Governor within 10 days of both counties approving the Agreement.
