General Information

1. What action are you requesting from the Board?

The Department of Community Services is requesting the Board approve a budget modification DCS-03-17 for the reclassification of 2.00 FTE Animal Care Technician positions to 2.00 FTE Program Specialist positions in the DCS Animal Services Division as determined by the Classification Compensation (Class Comp) Unit of Central Human Resources. The study performed by Class Comp was performed with new vacant positions approved in the FY 2017 budget.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

There has been a need for these positions to create, implement, facilitate, and monitor the process of feline and canine evaluation, training and enrichment. The positions will work closely with the Animal Shelter staff and volunteers to foster an environment to re-home or place shelter cats and dogs. Management requested the Class Comp Unit of Central Human Resources review the position classifications. The job descriptions were submitted to Central Human Resources to determine the appropriate classification of these positions. Class Comp determined that the Project Specialist was the appropriate classification for the duties assigned.

The positions (718002;718003) are currently budgeted as Animal Care Technician classifications. The budget modification detail sheets will delete the Animal Care Technician classifications and

create the Program Specialist classifications in DCS Animal Services Division in response to Class Comp's decision.
The changes impact program offer 91007B-17 DCS Animal Services.

3. Explain the fiscal impact (current year and ongoing).

The reclassification of positions (718002;718003) to Program Specialists will be budget neutral in the current year.

In subsequent fiscal years, the reclassified position will be subject to approved cost of living adjustments (COLA) and step and merit increases in accordance with collective bargaining agreements and county personnel rules. Increased costs will be funded within the Department County General Fund budget.
