ORDER ESTABLISHING
COUNTY ROAD NO. 4974

At this time the Board of County Commissioners of Multnomah County, Oregon, having duly determined to institute proceedings to relocate, widen and establish a section of SE 242nd Avenue, No. 608 and No. 691, from the southeast corner of Section 15, T1S, R3E, W.M., northerly to the east one-quarter section corner of said Section 15, as a county road to be known SE 242nd Avenue No. 4974, and more particularly described as follows:

Beginning at a point in the centerline of SE 242nd Avenue, County Road No. 608 and No. 691, which is also the southeast corner of Section 15, T1S, R3E, W.M.; thence northerly along the most practicable route and grade to the one-quarter section corner which is common to Sections 14 and 15, T1S, R3E, W.M.

The right-of-way is to be 60 feet in width, 30 feet on each side of centerline, together with all necessary slope, drainage, wall and utility easements.

The proposed road is in Sections 14 and 15, T1S, R3E, W.M., Multnomah County, Oregon, and the Board being satisfied that the relocation, widening and establishment of said road will be of public benefit for the following reason: To provide a thoroughfare having a safer and more convenient configuration and alignment. It is therefore

ORDERED that, pursuant to the authority vested in the Board of County Commissioners by ORS 368.001 et seq., said Board hereby declares its intention to relocate, widen and establish the above-described county road, reserving the right to discontinue the proceedings if considered desirable. It is further

ORDERED that June 29, 1989, at 9:30 A.M. in Room 602, Multnomah County Courthouse, be set as the time and place at which the board will hear objections to, and remonstrances against, the proposed relocation, widening and establishment of said road; and it is further

ORDERED that the County Engineer, or a duly qualified deputy, is hereby directed to give legal notice of said hearing as provided in ORS 368.401-368.416, and that notice be forwarded by mail, postage prepaid, to each record owner of land, on or over which the proposed road, or a portion thereof, is to be laid out, located and established, at the last known post office address of such owner, and if the address of such owner be unknown to the person mailing such notice, that it be mailed to the address given on the latest tax roll in the office of the Tax Collector of said county, and if the address is unknown to the person mailing such notice and cannot with reasonable diligence be ascertained, and cannot be found in such latest tax roll, then such notice is to be addressed to such owner at Gresham, Oregon, and it is further

ORDERED that this document be duly recorded in the Deed Records of Multnomah County, Oregon, after adoption.
