I then contacted Deborah Huff at DART and discussed the new information with her and it was determined that the Tax issue was from the previous owner and that the new owner was working on paying the outstanding taxes. DART has changed their position and stated that the Big Bear Market is in compliance and should not be penalized for the previous owners tax issue.
