The Multnomah County Health Department has operated health centers in local schools for more than 30 years. The County currently operates 13 school-based health centers in Gresham and Portland. These centers provide comprehensive preventive, primary and mental health care for children ages 5 to 18 from throughout the county. The goal is to keep youth healthy and ready to learn.

This health center will be an important asset for Centennial families and those families in the surrounding Gresham community. Studies demonstrate that school-based health centers decrease school absences, tardiness and discipline or behavior problems. Adolescents are 10 to 20 times more likely to access mental health services at school verses a community clinic. These centers focus on prevention and early intervention. We also provide services to school-aged youth regardless of whether they have private health insurance, public

health insurance, or no insurance at all.
