General Information

1. What action are you requesting from the Board?

Approval of IGA #4400002953 with the City of Troutdale ("City") authorizing a financial contribution from the City to the County for replacement of the Beaver Creek Culvert at Stark Street. It also authorizes a financial contribution from the County to City for City sanitary sewer and water line for Stark Street Beaver Creek Culvert.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

The Stark Street Beaver Creek Culvert project is a Federally Funded project scheduled for 2016 – 2017. Beaver Creek is an important fish bearing tributary to the Sandy River system. A County culvert currently exists on the creek at Stark Street that is nearing the end of its useful life and also makes it difficult for fish to pass through the culvert. This project will replace the aging, narrow concrete culvert at Stark Street with a new culvert to improve fish passage. The project is within the City of Troutdale's jurisdiction and will require movement of an existing water line and sanitary sewer line.

3. Explain the fiscal impact (current year and ongoing).

City of Troutdale will transfer \$100,000 so that the County will perform design services. The County will reimburse the City the cost associated with design and construction

services related to the existing waterline and sanitary sewer line. The balance of the project is funded through ODOT in a previous IGA and from the County Road Fund.

4. Explain any legal and/or policy issues involved.

5. Explain any citizen and/or other government participation that has or will take place.
For several years, County staff has been discussing this project with the Oregon Department of Fish and Wildlife (ODFW), the City of Troutdale and others, with all parties supporting the improvements. The last public meeting was held on December 9, 2015. The sewer line replacement will coincide with the Beaver Creek/Stark Street Culvert Project. The timeline for the project is from mid-May to early October 2017. Appropriate advance notice will be provided to the Public, the City of Troutdale and other involved agencies.
