PUBLIC HEARING

Vice-Chair Lonnie Roberts convened the hearing at 7:00 p.m., with Commissioners Lisa Naito and Maria Rojo de Steffey present, and Commissioner Serena Cruz and Chair Diane Linn excused.

The Multnomah County Board of Commissioners is providing an additional opportunity for public input on the proposed Multnomah County Ordinances listed below. Please fill out a speaker form available at the hearing and present it to the Clerk. Testimony will be limited to three minutes per person.

PH-1 Proposed ORDINANCE Adopting the West of Sandy River Rural Area Transportation and Land Use Plan and Wildlife Habitat and Stream Corridor ESEE Report as Part of the Multnomah County Comprehensive Framework Plan, Zoning Code Chapter 36 as Part of the Multnomah County Code of Ordinances Volume II: Land Use, and Zoning Map Amendments in Continuation of the County Rural Area Planning Program and the Reorganization Efforts of Ordinance Nos. 910 and 953 to Revise, Amend, Restate, Codify and Repeal Certain Existing Code Provisions

PH-2 Proposed ORDINANCE Amending MCC Chapter 29 to Add Grading and Erosion Control and Flood Hazard Regulations Needed to Implement the Policies of the West of Sandy River Rural Area Transportation and Land Use Plan and to Comply with Metro Functional Plan Title 3 Requirements for Water Quality Protection

VICE-CHAIR ROBERTS EXPLAINED THE PROCESS FOR TONIGHT'S HEARING; ADVISED THERE WOULD BE AN ADDITIONAL OPPORTUNITY FOR PUBLIC TESTIMONY ON THURSDAY, OCTOBER 31, 2002; AND THAT IF AMENDMENTS WERE INTRODUCED AND APPROVED AT THAT HEARING, A THIRD HEARING AND OPPORTUNITY FOR PUBLIC TESTIMONY WOULD BE SCHEDULED FOR THURSDAY, NOVEMBER 7, 2002.

LAND USE PLANNING AND TRANSPORTATION DIRECTOR KATHY BUSSE EXPLAINED THAT TONIGHT'S HEARING IS NOT ON THE ISSUE OF EXPANSION OF THE URBAN GROWTH BOUNDARY, THAT METRO CONDUCTED THOSE

HEARINGS; AND THAT TONIGHT'S HEARING IS NOT ON THE ISSUE OF THE SPRINGWATER PROPECTUS, THAT THE CITY OF GRESHAM IS CONDUCTING THOSE HEARINGS. MS. BUSSE EXPLAINED THAT TONIGHT'S HEARING IS THE PRODUCT OF A THREE YEAR EFFORT BY A SIXTEEN MEMBER TASKFORCE, THE PLANNING COMMISSION AND THE COMMUNITY INVOLVEMENT PROCESS AT SIX OR MORE PUBLIC HEARINGS. MS. BUSSE THANKED ALL INVOLVED AND INTRODUCED LAND USE PLANNING AND TRANSPORTATION STAFF CHUCK BEASLEY AND APRIL SIEBENALER.

CHUCK BEASLEY PRESENTED AN OVERVIEW OF THE WEST OF SANDY RIVER RURAL AREA TRANSPORTATION AND LAND USE PLAN AND WILDLIFE HABITAT AND STREAM CORRIDOR ESEE REPORT, INCLUDING INFORMATION ON GRADING AND EROSION CONTROL AND FLOOD CODE CHANGES, FARM PRACTICES, FOREST EXEMPTIONS, EFFORTS TO ASSURE CONSTRUCTION OF A DWELLING ON BUILDABLE LOTS, STATE TRANSPORTATION REQUIREMENTS, TRAFFIC PLANNING FOR BALANCED USE; I-84 ACCESS, AND EXISTING DEVELOPMENT IN SEC-WR OVERLAY ZONE; AND RESPONDED TO A COMMENT BY COMMISSIONER NAITO REGARDING COORDINATING WITH METRO'S ADOPTION OF GOAL 5 AND TITLE 3 LEGISLATION IN THE NEXT FIVE YEARS. IN RESPONSE TO A QUESTION OF COMMISSIONER ROBERTS, MR. BEASLEY ADVISED PROPERTY OWNERS WOULD NEED TO USE NATIVE PLANTS IN CERTAIN AREAS, AS LISTED IN THE EAST OF SANDY RIVER RURAL AREA TRANSPORTATION AND LAND USE PLAN.

TED WILSON TESTIMONY IN OPPOSITION TO 200' STREAM SETBACK. CHRISTINE HOWELL TESTIMONY IN OPPOSITION TO THE WORD "RIPARIAN" AND AGAINST RIPARIAN RESTRICTIONS. ROYCE BELCHER TESTIMONY IN OPPOSITION TO THE COMPREHENSIVE FRAMEWORK PLAN AS IT PERTAINS TO FARM MANAGEMENT BECAUSE OF ECONOMIC ISSUES. JOHN HALL, THOMAS BACHHUBER AND LEA ANN SHEPHERD TESTIMONY IN OPPOSITION TO 200' STREAM SET BACK; SALMON PROTECTION IN BEAVER CREEK WHICH HAS NOT CONTAINED SALMON IN 100 YEARS; AND THE COUNTY TAKING A STRONGER STAND THAN THE STATE. JOHN WINTORS TESTIMONY IN OPPOSITION TO RESTRICTIONS. IN RESPONSE TO A COMMENT MADE BY MR. WINTORS, COMMISSIONER NAITO ADVISED SHE HAS RELATIVES LIVING BEHIND THE IRON CURTAIN AND TAKES EXCEPTION TO THIS PROCESS BEING COMPARED TO COMMUNISM AND EXPLAINED THE BOARD SCHEDULED TODAY'S HEARING HERE IN EAST COUNTY IN ORDER TO LISTEN TO CITIZEN TESTIMONY BEFORE VOTING ON THE ISSUE IN A PUBLIC MEETING. BOB LEIPPER TESTIMONY IN OPPOSITION TO THE COMPREHENSIVE FRAMEWORK LAND USE PLAN RELATING TO SIGNIFICANT ENVIRONMENTAL CONCERN ISSUES; AND COMMENTED THAT THE BOARD IS GIVING AN ILLUSION THAT CITIZENS HAVE AN IMPACT ON THE OUTCOME OF THIS LEGISLATION. CINDY BENNINGTON TESTIMONY IN OPPOSITION TO THE COMPREHENSIVE FRAMEWORK PLAN; FARM VEHICLE TURNOUTS AND LAND USE RESTRICTIONS FROM THE STATE,

METRO AND COUNTY. TED WILSON TESTIMONY IN OPPOSITION TO THE COMPREHENSIVE FRAMEWORK PLAN.

COMMISSIONERS ROBERTS, NAITO AND ROJO THANKED EVERYONE FOR ATTENDING TONIGHT'S HEARING.

Chair Diane Linn convened the meeting at 9:36 a.m., with Vice-Chair Lonnie Roberts and Commissioners Lisa Naito, Serena Cruz and Maria Rojo de Steffey present.

B-1 Fiscal Year 2003 Budget Update; Fiscal Year 2004 Budget, Process and Stakeholder Workshops. Presented by Tony Mounts.

TONY MOUNTS PRESENTATION. MR. MOUNTS AND DAVE BOYER RESPONSE TO BOARD QUESTIONS. ED WEEKS PRESENTATION ON HOW THE WORKSHOPS WILL BE ASKED TO PERFORM EXERCISES TO BALANCE THE BUDGET WITH HYPOTHETICAL DATA. CHAIR LINN RESPONSE TO COMMISSIONER NAITO REMINDER THAT THE BOARD REMEMBER TO REPRESENT THE VULNERABLE THAT ARE NOT ABLE TO TESTIFY, ADVISED SHE WILL HELP THOSE PEOPLE ENGAGE IN THE PROCESS. IN RESPONSE TO QUESTIONS OF COMMISSIONER CRUZ, JOHN BALL ADVISED AN ALCOHOL AND DRUG PROGRAM UPDATE IS SCHEDULED FOR THURSDAY, NOVEMBER 7, 2002 AND EXPLAINED THE COUNTY HAS BEEN BACKFILLING THE PROGRAM BUT CANNOT CONTINUE TO DO SO; THAT THEY ARE ATTEMPTING TO BALANCE THE PROGRAM; THAT THEY HAVE TAKEN APPROPRIATE STEPS, BUT HAVE NOT IMPLEMENTED THEM AT THIS TIME. IN RESPONSE TO COMMENTS OF CHAIR LINN REGARDING IMPACT ON THE GENERAL FUND, COMMISSIONER CRUZ EXPRESSED CONCERN THAT BUDGETARY DECISIONS ARE BEING MADE AT THE STAFF LEVEL WITHOUT BOARD INPUT.

The meeting was recessed at 10:35 a.m. and reconvened at 10:40 a.m.

B-2 Update on Community Partnership Agreement - County Business Income Tax. Presented by Kathy Turner, Dave Boyer and Invited Guests.

CHAIR LINN ADVISED A CITY OF PORTLAND POSITION PAPER WAS DELIVERED AFTER HOURS LAST NIGHT AND THERE HAS BEEN NO TIME EVALUATE IT OR TO DETERMINE WHETHER IT IS THE POSITION OF THE COUNCIL OR THE MAYOR OR THE FINANCIAL OFFICER. CHAIR LINN STATED SHE IS CONVINCED THAT BUSINESS INCOME TAX REFORM IS NECESSARY AND THAT SHE IS CONVINCED THIS TAX PENALIZES BUSINESSES. COMMISSIONER NAITO ADVISED SHE HAS SCANNED THE POSITION PAPER AND THAT SHE FEELS BUSINESSES ARE BEING ENCOURAGED TO RELOCATE SO THEY WON'T HAVE TO PAY THE TAX. KATHY TURNER INTRODUCED THE PRESENTERS. COMMISSIONER ROJO EXPRESSED HER DISAPPOINTMENT IN GETTING THE POSITION PAPER FROM SAM AT THE LAST MINUTE AND STATED THAT SHE NEEDS TO HEAR FROM THE CITY OF PORTLAND IF THEY ARE BACKING OUT OF THE BUSINESS INCOME TAX AND IF SO WHY. DAVE BOYER PRESENTATION, ADVISING COUNTY RELIES ON FUNDING FROM THE BUSINESS INCOME TAX. MS. TURNER RESPONSE TO BOARD COMMENTS. KIM KIMBROUGH AND SAM ADAMS PRESENTATIONS. BOARD COMMENTS IN APPRECIATION OF THOSE WORKING ON THIS ISSUE AND IN SUPPORT OF ESTABLISHING A FAIR AND EASY-TO-COMPUTE BUSINESS INCOME TAX.

FOLLOWING EXPLANATION AND UPON MOTION OF COMMISSIONER ROBERTS, SECONDED BY COMMISSIONER NAITO, IT WAS UNANIMOUSLY APPROVED THAT A THIRD READING ON THIS ORDINANCE BE SCHEDULED FOR THURSDAY, DECEMBER 5, 2002. CHUCK BEASLEY EXPLANATION OF HIS OCTOBER 31, 2002 BOARD MEMORANDUM IN RESPONSE TO ISSUES RAISED BY THE CITY OF PORTLAND WATER BUREAU AT THE OCTOBER 24, 2002 HEARING. LORNA STICKEL THANKED THE BOARD FOR THE COUNTY'S RESPONSE; APOLOGIZED FOR THE LATENESS OF THE WATER BUREAU IN PROVIDING ITS INPUT RELATING TO THE ORDINANCE AND ADVISED SHE APPRECIATED WORKING WITH MR. BEASLEY. MS. STICKEL COMMENTED IN SUPPORT OF STAFF RECOMMENDED ORDINANCE AMENDMENTS. IN RESPONSE TO A QUESTION OF COMMISSIONER NAITO, ASSISTANT COUNTY ATTORNEY SANDRA DUFFY ADVISED THAT AMENDMENTS MADE AT THE THIRD READING WILL REQUIRE A FOURTH READING BEFORE ADOPTION. MR. BEASLEY REPORTED ON VISITS, CALLS AND FOLLOW UP WITH CITIZENS WHO PROVIDED TESTIMONY AT THE PREVIOUS HEARING AND RESPONDED TO A QUESTION OF COMMISSIONER ROBERTS REGARDING THE DEFINITION OF TITLE 3, ADVISING HE WOULD BRING A MAP TO THE DECEMBER 5, 2002 HEARING. RUSS PLAEGER OF THE SANDY RIVER WATERSHED COUNCIL, TESTIMONY IN APPRECIATION FOR THE WORK OF THE COMMUNITY TASKFORCE AND PLANNING COMMISSION AND IN SUPPORT FOR ADOPTION OF THE PROPOSED ORDINANCE AS WRITTEN. MR. PLAEGER TESTIFIED THAT THE USE OF NATIVE PLANTS IS AN IMPORTANT ISSUE AND THAT PREVENTION IS LESS EXPENSIVE THAN THE CONTROL OF INVASIVE PLANTS SUCH AS BLACKBERRY BUSHES. MR. PLAEGER ADDED THAT THE SPREAD OF INVASIVE PLANTS NEGATES THE PREVENTION EFFORTS OF OTHERS AND AFFECTS THE QUALITY AND CLEANLINESS OF STREAMS. BOB LEIPPER TESTIMONY IN OPPOSITION, CITING VEGETATION, HOUSE REPLACEMENT AND OTHER ISSUES. TIM CRAIL, FIVE YEAR PLANNING COMMISSION MEMBER, TESTIMONY IN SUPPORT AND COMMENTS ON ISSUES INCLUDING THE PLANNING COMMISSION'S VISION, PLANNED DENSITY, AGRICULTURE, BUSINESSES AND TRAILS. UPON MOTION OF COMMISSIONER CRUZ, SECONDED BY COMMISSIONER NAITO, THE AMENDMENT

INCORPORATING MR. BEASLEY'S PLANNING STAFF RECOMMENDED CHANGES TO THE PROPOSED CHAPTER 36 ZONING CODE LANGUAGE AS OUTLINED IN HIS OCTOBER 31, 2002 MEMORANDUM WAS UNANIMOUSLY APPROVED. THE SECOND READING WAS UNANIMOUSLY APPROVED, AS AMENDED. THIRD READING THURSDAY, DECEMBER 5, 2002.

IN RESPONSE TO A QUESTION OF THE BOARD, ASSISTANT COUNTY ATTORNEY SANDRA DUFFY AND PLANNER CHUCK BEASLEY EXPLAINED THAT THIS ORDINANCE DOES NOT NEED TO BE AMENDED AND DOES NOT REQUIRE AN ADDITIONAL HEARING. NO ONE WISHED TO TESTIFY. ORDINANCE 996 UNANIMOUSLY ADOPTED.

ORDINANCE READ BY TITLE ONLY. COPIES AVAILABLE. COMMISSIONER NAITO MOVED AND COMMISSIONER CRUZ SECONDED, APPROVAL OF FIRST READING AND ADOPTION. ASSISTANT COUNTY ATTORNEY SANDRA DUFFY EXPLANATION, ADVISING THE PLANNING COMMISSION RECOMMENDS NOT DELAYING BOARD ACTION. ATTORNEY DOROTHY COFIELD TESTIFIED OF BEHALF OF HER CLIENTS KAREN RAFNEL AND DENNIS R. HARRIS, EXPLAINING HER CLIENTS REQUESTED A DELAY SO THEY CAN HAVE A PRE-APPLICATION CONFERENCE WITH THE LAND USE PLANNING DIRECTOR OR IN THE ALTERNATIVE, THAT LAND USE PLANNING BE DIRECTED TO WAIVE THE PRE-APPLICATION CONFERENCE REQUIREMENT AND ACCEPT THE LAND DIVISION APPLICATION OF HER CLIENTS. IN RESPONSE TO MS. COFIELD'S TESTIMONY AND FOLLOWING DISCUSSION BETWEEN COMMISSIONERS NAITO AND CRUZ AND MS. DUFFY AND PLANNING DIRECTOR KATHY BUSSE, COMMISSIONER NAITO MOVED AND COMMISSIONER ROBERTS SECONDED, TO GIVE THE PLANNING DIRECTOR DISCRETION TO REVIEW AND DECIDE, BASED ON THE FACTS IN THE CASE OF KAREN RAFNEL AND DENNIS R. HARRIS, WHETHER TO GRANT A WAIVER OR EXCEPTION TO THE REQUIRED PRE-APPLICATION FILING CONFERENCE. COMMISSIONERS CRUZ AND ROJO STATED THEY WERE NOT COMFORTABLE WITH THE PROCESS OF MAKING AN EXCEPTION AT THE DAIS. CHAIR LINN STATED SHE IS VERY COMFORTABLE WITH THE ABILITY OF MS. BUSSE TO DECIDE WHETHER TO GRANT A WAIVER OR EXCEPTION.

FOLLOWING DISCUSSION WITH MS. BUSSE, MS. DUFFY, CHAIR LINN AND COMMISSIONER NAITO, THE BOARD APPROVED THE MOTION TO GIVE THE PLANNING DIRECTOR DISCRETION TO REVIEW AND DECIDE, BASED ON THE FACTS IN THE CASE OF KAREN RAFNEL AND DENNIS R. HARRIS, WHETHER TO GRANT A WAIVER OR EXCEPTION TO THE PRE-APPLICATION FILING CONFERENCE REQUIREMENT, WITH COMMISSIONERS NAITO, ROBERTS AND LINN VOTING AYE, AND COMMISSIONERS CRUZ AND ROJO VOTING NO. LOGAN RAMSEY TESTIMONY IN OPPOSITION TO THE LAND USE BOARD OF APPEALS DECISION; THE VIOLATION OF HIS PROPERTY RIGHTS; THE CITY OF PORTLAND'S ABILITY TO GRANT OR DENY HIM PERMISSION TO DEVELOP HIS PROPERTY; THE INADEQUATE NOTICE IN LAST WEEK'S PAPER; AND THE ENVIRONMENTAL OVERLAY ON HIS PROPERTY. ORDINANCE 997 UNANIMOUSLY ADOPTED. COMMISSIONER ROBERTS REQUESTED THAT LAND USE PLANNING STAFF MEET WITH MR. RAMSEY.
