General Information

1. What action are you requesting from the Board?

We are requesting approval of the Cooperative Improvement Agreement for Highway Safety Improvement Program (HSIP) for Region 1 Rural Safety Improvements. This agreement is with ODOT. Other parties to the Agreement are Clackamas County, Hood River County, and Washington County.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

The safety improvements include installation of delineators, curve warning signs, and/or rumble strips on several rural Multnomah County roads, including NW Cornelius Pass Rd, SE Oxbow Dr, NW Gillihan Loop Rd, E Larch Mountain Rd, and NW Germantown Rd (Exhibit A3). Multnomah County responsibilities under this IGA are to provide any required permits and allow entry onto the County's rights-of-way, review and approve plans provided by the State or its consultant, accept the improvements made, and maintain those improvements.

ODOT, or its consultant, shall conduct the necessary field surveys, environmental studies, traffic investigations, preliminary engineering and design work required to produce and provide final plans, specifications and cost estimates for the Project; identify and obtain all required permits; perform all construction engineering, including all required materials testing and quality documentation; prepare all bid and contract documents; advertise for

construction bid proposals; award all contracts; pay all contractor costs, provide technical inspection, project management services and other necessary functions for sole administration of the construction contract entered into for this Project.

3. Explain the fiscal impact (current year and ongoing).

There is no initial fiscal impact to this Agreement. The State is providing the funding and performing the work required. Future maintenance of the installed features will be funded by County Transportation Division.

4. Explain any legal and/or policy issues involved.

None known.

5. Explain any citizen and/or other government participation that has or will take place.

ODOT is the facilitator of the project; ODOT staff is coordinating with Multnomah County staff for citizen outreach. Accompanying counties include Washington County, Hood River County, and Clackamas County.
