10 Essential Public Health Services

<u>Core Functions*</u>	<u>10 Essential Public Health Services**</u>
Assessment	Monitor health status to identify and solve community health problems Diagnose & investigate health problems & hazards in the community
Assurance	Enforce laws and regulations that protect health and ensure safety Link people to health services; ensure provision when otherwise unavailable Assure competent public & personal health care workforce Evaluate effectiveness accessibility, and quality of services
Policy Development	Engage the community to identify & solve health problems Give people information to make healthy choices Develop p.h. policies & plans that support individual & community efforts
Systems Management	Research for new insights and innovative solutions to health problems



Life Course Health Model

- Today's experiences and exposures influence tomorrow's health.
- Health trajectories are particularly affected during critical periods, such as early childhood.
- The broader community environment strongly affects the ability to be healthy.
- While genetics and personal choice can protect us from or put us at risk for poor health outcomes, health disparities reflect more than genetics and personal choice.
