ORDINANCE NO. 232

An Ordinance establishing a Multnomah County Citizens' Committee to Study and Make recommendations on Revenue Alternatives and Delivery of Governmental Services.

Multnomah County ordains as follows:

Section 1. There is hereby established a Multnomah County Citizens' Committee on Revenue Alternatives and Delivery of Governmental Services in Multnomah County.

Section 2. The Committee shall be composed of fifteen members to be appointed by the County Executive with the approval of the Board of County Commissioners. Committee members shall consist of representatives of David Douglas School District, Centennial School District, Gresham School District, Reynolds School District, Parkrose School District, City of Gresham, City of Troutdale, City of Fairview, City of Wood Village, City of Maywood Park, City of Portland, Errol Heights Community Planning Organization, Cully-Parkrose Community Planning Organization, Hazelwood Community Planning Organization, Powellhurst Community Planning Organization, Wilkes Community Planning Organization, Centennial Community Planning Organization, Rockwood Community Planning Organization, Gresham Chamber of Commerce, Portland Chamber of Commerce, Palatine Hill Water District, Valley View Water District, Parkrose Chamber of Commerce, League of Women Voters, and shall serve without compensation. Prior to any appointment by the County Executive, each organization or governmental entity represented shall be given the opportunity to designate an individual to serve on the Committee.

Section 3. The Committee shall:

- a) Investigate the level of the General Fund subsidy for urban-level services in the unincorporated areas of Multnomah County;
- b) Evaluate demands for urban services in the unincorporated areas of Multnomah County;
- c) Evaluate the structural and fiscal options available for the provision of urban-level services to the unincorporated areas;

- d) Hold public hearings;
- e) Report its recommendations in writing for a comprehensive strategy addressing the structural and fiscal options available for the provision of urban-level services to the unincorporated areas of Multnomah County.

Section 4. Appropriate expenditures for professional staff support, including a contract for conducting a poll are authorized and may be requested. Any request for funds shall set forth responsibility for managing all contractual obligations incurred by the Committee.

Section 5. The Committee shall make an interim report to the Board of County Commissioners on or before August 15, 1980 and shall make its final report to the Board of County Commissioners on or before September 25, 1980.

Section 6. Upon completion of the Board of County Commissioners review of the Committee's report and recommendations, the Committee shall be dissolved.

Section 7. It being necessary for Multnomah County to proceed immediately to develop a plan for revenue alternatives and delivery of governmental services, an emergency is declared to exist and this ordinance shall take effect upon its passage.


