RESOLUTION NO. 2011-041

Authorizing the Repurchase Of A Tax Foreclosed Property By The Former Owner, Paula A. Sitton

The Multnomah County Board of Commissioners Finds:

- a. Paula A. Sitton is the former owner of certain real property described as:

**Lot 4, Clint Park
Together with an undivided 1/4 interest in Tract "A"**

(the Property). On or about September 22, 2008 judgment was entered in Multnomah County Circuit Court foreclosing the delinquent taxes levied against the Property.

- b. On October 6, 2010 the County Tax Collector deeded all right, title and interest in the Property to Multnomah County as authorized under ORS 312.200.
- c. Although the timeline to allow the repurchase by Ms. Sitton, as provided under MCC 7.402 has passed, the County Assessor still recommends the Board approve this proposed repurchase as in the public's best interest because Ms. Sitton initiated the process in a timely manner in compliance with the cited code section and has made a reasonable good faith effort to accomplish the repurchase.
- d. The County has received payment in the amount of \$32,348.22 from Paula A. Sitton, that amount is not less than the amount required under ORS 275.180 and MCC 7.402(C) for a sale to the former owner.

The Multnomah County Board of Commissioners Resolves:

1. The County Chair is authorized to execute a deed, in substantial conformance with the attached deed, conveying the Property to Paula A. Sitton.



BEFORE SIGNING OR ACCEPTING THIS INSTRUMENT, THE PERSON ACQUIRING FEE TITLE TO THE PROPERTY SHOULD CHECK WITH THE APPROPRIATE CITY OR COUNTY PLANNING DEPARTMENT TO VERIFY THAT THE UNIT OF LAND BEING TRANSFERRED IS A LAWFULLY ESTABLISHED LOT OR PARCEL AS DEFINED IN ORS 92.010 OR 215.010, TO VERIFY THE APPROVED USES OF THE LOT OR PARCEL, TO DETERMINE ANY LIMITS ON LAWSUITS AGAINST FARMING OR FOREST PRACTICES, AS DEFINED IN ORS 30.930, AND TO INQUIRE ABOUT THE RIGHTS OF NEIGHBORING PROPERTY OWNERS, IF ANY, UNDER ORS 195.300, 195.301 AND 195.305 TO 195.336 AND SECTIONS 5 TO 11, CHAPTER 424, OREGON LAWS 2007, AND SECTIONS 2 TO 9 AND 17, CHAPTER 855, OREGON LAWS 2009.

The true consideration for this conveyance is \$32,348.22.
