BOARD BRIEFING

Chair Deborah Kafoury called the meeting to order at 11:04 a.m. with Vice-Chair Diane McKeel and Commissioners Jules Bailey, Loretta Smith and Judy Shiprack present.

Also attending were Jenny Madkour, County Attorney and Marina Baker, Assistant Board Clerk.

Chair Kafoury: GOOD MORNING. WELCOME TO THE BOARD BRIEFING THIS MORNING ON THE OREGON HISTORICAL SOCIETY. WE'RE VERY HONORED TO HAVE DISTINGUISHED GUESTS WITH US THIS MORNING. SENATOR, WOULD YOU LIKE TO --

>> I'LL BEGIN. FOR THE RECORD MY NAME IS KERRY TYMCHUK, IT'S A PRIVILEGE TO JOAN THE LEVY OVERSIGHT COMMITTEE CO-CHAIRS, AVEL GORDLY IN PROVIDING THIS ANNUAL REPORT. IT'S BEEN NEARLY FOUR YEARS SINCE THE VOTERS APPROVED THE LEVY THAT PROVIDED FUNDS TO THE OREGON HISTORICAL SOCIETY AND FOR EAST COUNTY. I CAN REPORT THIS VOTE CONTINUES TO MAKE AN INCREDIBLY POSITIVE DIFFERENCE FOR THE OREGON HISTORICAL SOCIETY, AND I BELIEVE A POSITIVE DIFFERENCE FOR MULTNOMAH COUNTY RESIDENTS AND ALL OREGONIANS. AS A RESULT OF THE STABLE FUNDING PROVIDED THROUGH THE LEVY, THE OREGON HISTORICAL SOCIETY HAS BEEN ABLE TO INCREASE SERVICES, STAFF, THE QUALITY OF OUR EXHIBITS, INCREASE THE NUMBER OF OUR PROGRAMS, INCLUDING PROGRAMS THAT ARE REPRESENTATIVE OF THE DIVERSE CULTURE OF MULTNOMAH COUNTY. AS A RESULT ATTENDANTS TO THE MUSEUM AND RESEARCH LIBRARY HAVE DRAMATICALLY INCREASED. WITH MULTNOMAH COUNTY RESIDENTS PROVIDING A GOOD SHARE OF THAT INCREASE. THE MOMENTUM CREATED BY THE LEVY HAS SPUR INVESTMENT BY PRIVATE DONORS AND FOUNDATIONS. KNOWING THAT THE SUREST WAY TO CRUSH YOUR LAURELS IS TO SIT ON THEM, WE'RE COMMITTED TO DOING ALL WE CAN TO MAKE SURE THE FUNDS ARE SPENT WISELY AND EFFICIENTLY. 2015 PROMISING TO BE EXCITING AS WE'RE PLANNING A SIX-MONTH EXHIBIT ON WORLD WAR II. ENTITLED THE WORLD OF WAR, A STATE TRANSFORMED, IT WILL FEATURE RARE ACT FACTS AND DOCUMENTS FROM

THE MARK FAMILY COLLECTION THAT WILL BRING INSIGHT INTO THE LIFE AND CAREERS INTO MULTIPLE PEOPLE. TEMPTS FROM THE OHS COLLECTION WILL TELL HOW THE KAISER SHIPYARDS TRANSFORMED PORTLAND, ABOUT THE TRAGIC INTERNMENT OF JAPANESE AMERICANS AND THE STORIES OF OREGON SOLDIERS WHO RISKED AND GAVE THEIR LIVES FOR THEIR COUNTRY. WITH WORLD WAR II VETERANS PASSING AWAY AT THE RATE OF 555 A DAY, WE SEE THIS AS AN OPPORTUNITY AND A DUTY TO PAY TRIBUTE TO THE GREATEST GENERATION. I WOULD LIKE TO ASK YOUR COMMISSIONERS' HELP IN CONTINUING TO SPREAD THE WORD THAT MULTNOMAH COUNTY RESIDENTS HAVE FREE ADMISSION. THIS PAST SATURDAY WAS A SMITHSONIAN DAY WHERE THE INTERNET OFFERS COUPONS GOOD FOR FREE ADMISSION TO THE MUSEUMS. WE HAD OVER 400 VISITORS AND QUITE A FEW WERE MULTNOMAH COUNTY RESIDENTS. THEY WERE DELIGHTED TO LEARN THEY GET FREE ADMISSION EVERY DAY NOT JUST ON ON SMITHSONIAN DAY. ALL OF OUR ADVERTISEMENT AND MEDIA RELEASES ABOUT EXHIBITS INCLUDE AND WILL CONTINUE TO INCLUDE THE WORDS FREE ADMISSION FOR MULTNOMAH COUNTY RESIDENTS. I WOULD ALSO LIKE TO NOTE THIS NOVEMBER IS THE 100TH ANNIVERSARY OF THE FIRST WOMAN BEING ELECTED TO THE OREGON STATE LEGISLATURE. TO MARK THIS OCCASION, SIX PAST OR CURRENT WOMEN LEGISLATORS INCLUDING CHAIR KAFOURY, WILL JOIN ME AT OHS FOR AN EVENING DISCUSSION ON OCTOBER 22nd WHICH JUST HAPPENS TO BE THE 180th BIRTHDAY OF ABIGAIL SCOTT DUNIWAY. I'VE BEEN ACCUSE THE OF LIKING SHOW AND TELL, I HAPPEN TO BRING WITH ME A FAVORITE ITEM, A HANDWRITTEN LETTER TO ABIGAIL SCOTT DUNIWAY FROM SUSAN B. ANTHONY, THANKING HER FOR HOSTING HER WHEN SHE WAS IN OREGON CAMPAIGNING FOR SUFFRAGE. IT TOOK FIVE TIMES FOR THE OREGON VOTERS TO VOTE FOR SUFFRAGE, FOUR TIMES IT WENT UP TO BALLOT, FOUR TIMES MEN VOTED IT DOWN AND IT WASN'T UNTIL THE FIFTH TIME WHEN IT PASSED. 1912. BUT WE LOOK FORWARD TO A GREAT DISCUSSION WITH CHAIR KAFOURY AND OTHER WOMEN STATE LEGISLATORS ON THE 22nd.

>> GOOD MORNING. MADAM CHAIR AND COMMISSIONERS, IT'S A PLEASURE TO BE BACK BEFORE YOU WITH THE REPORT ABOUT YOUR INVESTMENT, THE COUNTY'S INVESTMENT. THE TAXPAYERS' INVESTMENT IN THIS DESERVING INSTITUTION. AND I WOULD JUST LIKE TO MAKE A COUPLE OF OBSERVATIONS THAT MAY SEEM A LITTLE ODD, BUT I THINK IT'S VERY FITTING. I THINK WHAT WE ARE ACHIEVING THROUGH THE WORK OF -- THAT'S GOING FORWARD AT OREGON HISTORICAL SOCIETY IS THE INTENTIONAL BUILDING OR REBUILDING, IF YOU WILL, OF A CULTURALLY RESPONSIVE ORGANIZATION AND ORGANIZATION THAT IS RESPONSIVE TO THE POPULATIONS AND CULTURES AND STORIES OF ALL OF THE PEOPLE OF OREGON. AND THE WORK THAT'S GOING FORWARD IS SO POWERFUL, BECAUSE IT'S RELATIONSHIP-RICH. IF YOU LOOK AT OUR REPORT, AND YOU LOOK BACK OVER THE YEARS, AND THE -- ALL THE ACCOMPLISHMENTS AND THE THINGS THAT WERE PROMISED, AND YOU LOOK AT THE DETAIL IN EACH OF THE

ACTIVITIES, WHAT YOU SEE ARE THE RESULTS OF -- COME OUT OF THE RESULTS OF RICH RELATIONSHIPS. AND I WANT TO PUT THAT ON RECORD, BECAUSE IT'S A STATEMENT ABOUT THE QUALITY OF LEADERSHIP AT THE ORGANIZATION, AND LEADERSHIP AND STAFF, ALL THE WAY ACROSS THE BOARD. THE OTHER THING I WANT TO SAY THAT MAY SEEM ODD IS I THINK -- I HAVE THE PRIVILEGE OF ATTENDING HARVARD KENNEDY SCHOOL OF GOVERNMENT, WELL OVER A DECADE AGO. AND YOU MAY BE FAMILIAR THAT HARVARD USES THE CASE STUDY APPROACH, OR THE SCHOOL OF GOVERNMENT USES THE CASE STUDY APPROACH TO ARRIVING AT A DEEPER UNDERSTANDING OF MAKING PUBLIC POLICY. I THINK THAT WHAT WE HAVE HERE WITH THE WORK THAT'S GOING FORWARD THROUGH THE OREGON HISTORICAL SOCIETY IS A RICH CASE STUDY EXAMPLE THAT SHOULD BE, COULD BE UNPACKED AT THE HATFIELD SCHOOL OF GOVERNMENT AT PORTLAND STATE UNIVERSITY. I THINK IT'S THE -- IT WOULD BE A WONDERFUL OPPORTUNITY FOR STUDENTS TO ENGAGE IN LOOKING AT HOW THE WILL OF THE VOTERS, THROUGH THEIR SUPPORT OF THE LEVY, THEN TRANSLATES TO THE MAKING OF PUBLIC POLICY THAT THEN TRANSLATES TO THE ENGAGEMENT OF CITIZENS IN BUILDING AND REBUILDING AN INSTITUTION. I HOPE THAT MAKES SENSE TO YOU. IT MAKES SENSE TO ME, IT MAKES ME VERY EXCITED TO THINK ABOUT A PARTNERSHIP THAT COULD GO FORWARD AT PORTLAND STATE THROUGH THE HATFIELD SCHOOL OF GOVERNMENT. WE'RE HAPPY TO BE HERE WITH OUR OTHER PARTNERS FROM OTHER AREAS OF THE COUNTY THIS MORNING, AND YOU'LL BE HEARING FROM THEM AS WELL.

>> GOOD MORNING AND THANK YOU FOR HAVING US. I THINK I'M GOING TO GIVE THE -- MORE TECHNICAL PART OF THE PRESENTATION TODAY, AND I JUST WANTED TO TAKE A FEW MOMENTS AND SHARE WITH THE BOARD ABOUT THE INCREDIBLE WORK OF THIS LAST YEAR. I WANTED TO ASSURE YOU THAT THE LEVY OVERSIGHT COMMITTEE HAS MET ALL OF ITS CRITERIA AROUND REGULARLY HELD MEETINGS, CERTAINLY BEEN A WONDERFUL PARTNER WITH OHS AS FAR AS MEETING THE CRITERIA WITH THE EXPANDED HOURS, THE AUDIT COMMITTEE, AND SO IT'S VERY IMPORTANT TO HEAR THE INSPIRATIONAL AND EXCITING PART OF KERRY'S TALK, AND CERTAINLY THE WILL OF THE COMMUNITY IN REFLECTING OREGON HISTORICAL SOCIETY REFLECTING OUR ENTIRE STATE AS MY FELLOW CO-CHAIR AVEL GORDLY SHARED, BUT ALSO IT'S IMPORTANT FOR YOU TO KNOW WE'RE MEETING THE SPIRIT OF THE MEASURE AS WELL, AND THAT ALL OF THE GOOD WORK AROUND MEETING EXPECTATIONS AND HONORING OUR VOTERS IS TAKING PLACE AS WELL. CERTAINLY IN ADDITION TO ENSURING ALL OF THE CRITERIA AND EXPANDED HOURS AND ALL OF THOSE THINGS ARE BEING MET, I THINK THE COMMITTEE HAS REALLY DONE AN EXCELLENT JOB OF CONTINUING TO BRING UP IMPORTANT ISSUES THAT WE HEAR FROM THE VOTERS, AND HAVING THE IMPORTANT CONVERSATIONS ABOUT HOW TO EXPAND OUTREACH AND CONNECTION TO OTHER PARTS OF THE COMMUNITY, REGULARLY INVITING AND ENCOURAGING KERRY AND HIS TEAM TO

DIVERSIFY THEIR STAFF TO CONTINUE TO REFLECT OUR STATE AND REGION, AND SO THE GOOD AND HARD CONVERSATIONS ARE TAKING PLACE AND GOOD PROGRESS IS TAKING PLACE EVERY YEAR.

Chair Kafoury: DO WE HAVE ANY QUESTIONS OR COMMENTS FROM THE BOARD?

>> WE HAVE PEOPLE TO INVITE UP.

>> I'D LIKE TO PRAISE THE WORK OF YOUR STAFFERS, EMERALD LEFT VERY BIG SHOES TO FILL. I APPRECIATE WORKING WITH AARON. HE DID AN OUTSTANDING JOB.

>> GOOD AFTERNOON. MY NAME IS CHUCK ROLLINS, I'M THE PRESIDENT OF THE CROWN POINT COUNTRY HISTORICAL SOCIETY AND I'D LIKE TO TAKE A FEW MINUTES TO TELL YOU OUT IN THE FIELD HOW THIS LEVY 26-118 HAS AFFECTED OUR COMMUNITY. I HAVE TO BE HONEST WITH YOU, IT'S BEEN OVERWHELMING. I'VE HEARD COMMENTS LIKE I THOUGHT I'D NEVER HEAR BEFORE. THIS IS A TAXI DON'T MIND PAYING. IT WAS REALLY SURPRISING TO US. IT'S NICE TO SEE MONEY COMING BACK INTO THE COMMUNITY AND MAKING A DIFFERENCE. WITH THE FUNDS THAT OUR SOCIETY RECEIVED, WE ARE PURCHASING A HISTORIC AUTO CAMP THAT IS ONE OF THE FEW THAT WERE LOCATED ON THE HISTORIC COLUMBIA RIVER HIGHWAY, AND FOR THE 100-YEAR CELEBRATION WE PLAN TO HAVE A LITTLE MINIATURE AUTO CAMP THAT WILL ALSO TELL THE STORY OF WHAT WE'RE PLANNING TO DO WITH THE SITE. THIS LAST YEAR WE HAD AN ELDER FROM THE WASCO NATION, HE'S THE OLDEST SURVIVING MALE OF THE WASCO NATION. THERE'S ONLY THREE PEOPLE THAT KNOW THAT LANGUAGE. WITH THE FUNDS WE HAVE TODAY WE'RE DOCUMENTING THAT LANGUAGE. IT WILL BE AN AUDIO AND VIDEO, HE IS SHARING THE LANGUAGE, THE STORIES, AND THE TRADITIONS OF THE PEOPLE. UNBEKNOWNST TO US, HERE IN CORBETT AREA, WE WERE REPORT OF THE WASCO NATION, BUT WE DIDN'T KNOW THAT. WE KNOW THAT NOW, AND WITH THESE FUNDS WE ARE FILLING IN THAT GAP. WE'RE ALSO TONIGHT AT McMENAMINS, IN WILSONVILLE, ONE OF OUR MEMBERS IS DOING A STORY ABOUT THE FIRST ASIANS TO COME INTO THE UNITED STATES, THEY WERE DRIFTED OVER IN THE CURRENT AND THEY WERE THE FIRST ASIANS TO COME TO THE NORTHWEST AND THEY SPENT TIME ON THE COLUMBIA RIVER, AND THIS PRESENTATION IS BEING DONE TONIGHT AT McMENAMINS IN WILSONVILLE AND IN TWO WEEKS IT WILL BE AT McMENAMINS HERE AT EDGEFIELD. SO THOSE ARE JUST TWO TEMPTS THAT WOULD NOT BE HAPPENING TODAY WITHOUT THESE FUNDS. BUT WHAT'S BEEN REALLY ENCOURAGING TO US, THIS TAX LEVY IS THE TALK OF THE TOWN. WHAT WE'RE DOING WITH THIS MONEY HAS BROUGHT SO MANY PEOPLE INTO THE FOLD. OUR MEMBERSHIP HAS GROWN, WE'RE GETTING DONATIONS, WE'RE GETTING PROMISES OF DONATIONS, AS OUR PROJECTS MOVE FORWARD. I DO HAVE ONE QUICK -- WE'VE HAD A LOT OF PARTNERSHIPS WITH A LOT OF

DIFFERENT LOCAL GROUPS, AND I WANT TO SHARE ONE QUICK STORY ABOUT ONE OF THEM. IN 1941, IN CORBETT, THE WOMEN GOT TOGETHER AND FORMED A GARDEN CLUB. WHERE THEY WERE PRESERVING PIONEER PLANTS, NATIVE PLANTS, AND JUST PLANTS IN GENERAL, AND THE GOAL WAS TO SHARE THEM WITH CHILDREN AND TEACH THEM ABOUT GROWING PLANTS AND HOW IMPORTANT THAT IS. BUT WE WENT TO THE GARDEN CLUB AND THEY WANTED TO BE A PARTNERSHIP, THEY NEEDED A HOME. WE HAVE THIS LAND WE PURCHASED, SO IT'S A HOME FOR THEM ALSO. THEY ARE NOW BRINGING IN DAHLIAS THAT WERE GOLD MEDAL DAHLIAS, DEVELOPED IN EAST COUNTY, NONE LIKE THEM ANYWHERE ELSE IN THE WORLD. THOSE WILL BE ON DISPLAY, THEY'LL BE TAKEN CARE OF BY THE GARDEN CLUB, AND THEY'LL BE ABLE TO SHOW CHILDREN HOW TO MAKE THESE THINGS HAPPEN. SO THAT'S JUST ONE GROUP. WE'VE PARTNERED WITH A ROCK CLUB AND MANY OTHER ORGANIZATIONS OUT THERE, AND THERE'S SO MANY WONDERFUL THINGS COMING, I COULD TALK TO YOU FOR HOURS. BUT I JUST WANTED TO LET YOU KNOW THESE FUNDS HAVE MADE A POSITIVE DIFFERENCE IN OUR COMMUNITY, I HANDED YOU ALL OUT A BROCHURE, IF YOU HAVE A CHANCE TAKE A LOOK AT IT, IT GIVES YOU AN IDEA WHAT WE'RE UP TO. AND I CAN TELL YOU THIS, THREE YEARS AGO THIS WAS A DREAM. TODAY IT'S BECOMING A REALITY AND IT'S BECAUSE OF THE WORK THAT'S BEING DONE HERE. THANK YOU.

>> Chair Kafoury: THANK YOU.

>> MENTIONING McMENAMINS REMINDS ME THROUGH OUR OREGON ENCYCLOPEDIA, OHS HAS, WE CALL IT OREGON 101. IT'S A NINE-LECTURE SERIES AT THE KENNEDY SCHOOL McAMERICAN MINCE -- McMENAMINS. BILL LANG IS GIVING ONE, DAVID LEWIS FROM THE GRAND RONDHUIS TRIBE GAVE THE FIRST ONE ON THE TRIBE AND CHRONOLOGICALLY NINE LECTURES ON MONDAY NIGHTS OVER THE COMING YEAR. A COMPLETE OREGON HISTORY. AND THEY'RE ALL FREE TO OREGONIANS.

>> MADAM CHAIR AND COMMISSIONERS, I'M DAVE RITMA, PRESIDENT OF THE TROUTDALE HISTORICAL SOCIETY. I ECHO THOUGHTS ABOUT HOW WONDERFUL THIS LEVY HAS BEEN AND FOR TROUTDALE. IT TRULY IS THE TALK OF THE TOWN. I MEAN, TROUTDALE HISTORICAL SOCIETY OPERATES THREE MUSEUMS, THE HARLOW HOUSE, ONE OF THE OLDEST HOUSES IN TOWN, THE DEPOT, AND WE HAVE WHAT WE CALL A BARN MUSEUM, OUR NEWEST BUILDING, AND HOUSES OUR BIGGEST EXHIBITS. FRANKLY, THE LEVY FUNDS HAVE ALLOWED US TO KEEP THEM OPEN MORE, LONGER, AND CURRENTLY WHAT -- WE HAVE A COUPLE OF BIG PUSHES GOING ON USING THE FUNDS. WE HAVE A LARGE PHOTO COLLECTION WE'RE DIGITIZING, MAKING IT MORE AVAILABLE TO THE PUBLIC, EASIER ACCESS, IT'S IRREPLACEABLE REPOSITORY OF THE HISTORY OF OUR AREA. ACTUALLY OUR MISSION IS TO STIMULATE INTEREST IN AND KNOWLEDGE OF THE LOCALITIES PAST. AND ONE OF OUR LONG-TIME GOALS AND THE LEVY FUNDS

HAVE ASSISTED IN THIS, WE'RE ACTIVE IN PROTECTING AND RESEARCHING NATIVE AMERICAN SITES IN AND AROUND TROUTDALE. THERE'S A NEWLY READING COVERED NATIVE AMERICAN TRAIL JUST ACROSS THE SANDY RIVER FROM THE HARLOW HOUSE. WE PRESERVE THROUGH ORAL HISTORIES AND ARTIFACTS, INFORMATION ABOUT THE LIVES AND CONTRIBUTIONS OF JAPANESE-AMERICANS IN OUR COMMUNITY, WE HAVE HIRED AN AFRICAN-AMERICAN, NELL SIMEON, AS OUR EXECUTIVE DIRECTOR, AND THAT IS SOMETHING THE LEVY FUNDS HAVE HELPED US FUND. AND SHE HAS VERY SUCCESSFUL AT RECRUITING NEW MEMBERS FROM DIVERSE CULTURES. PARTICULARLY THE AFRICAN-AMERICAN AND HISPANIC MUSEUM GUIDES FOR OUR MUSEUMS. WE'RE VERY GRATEFUL TO MULTNOMAH COUNTY FOR THE TAXPAYERS, THE WILL OF THE VOTERS ON THIS IS WELL REFLECTED IN OUR GRATITUDE. AND OUR BIGGEST NEW PROJECT THAT WE'RE WORKING ON IS THE HUNDREDTH ANNIVERSARY OF THE HISTORIC COLUMBIA RIVER HIGHWAY THAT WILL OPEN IN 2016, WHICH IS THE 100TH ANNIVERSARY. IT'S CALLED KING OF ROADS, AND WE'RE DOING A FIRST CLASS EXHIBIT THAT WILL BE AN ASSET TO THE ENTIRE REGION. WE CERTAINLY WILL INVITE YOU ALL TO THE OPENING. I COULD GO ON AND ON. WE PUT OUT A NEWSLETTER, WE HAVE MONTHLY PROGRAMS. ALL OF THESE THINGS ARE BEING SUPPORTED BY THIS LEVY. SO THANK YOU SO MUCH, AND PLEASE COME SEE US SOMETIME.

>> OF INTEREST TO THE COMMISSIONERS, A NEW PROJECT WE'RE WORKING ON, I DON'T KNOW IF YOU KNOW GOVERNOR KITZHABER RECENTLY APPOINTED A NINE-MEMBER PANEL AND CHARGED THEM WITH THE MISSION, THE DELICATE MISSION OF RECOMMENDING WHETHER OR NOT JASON LEE AND DR. JOHN McLAUGHLIN SHOULD REMAIN AS OREGON'S REPRESENTATIVES IN NATIONAL STATUARY HALL IN WASHINGTON, DC. EACH STATE GETS TWO STATUES, OR IF ONE OF THEM SHOULD BE REMOVED. AND IF ONE OF THEM SHOULD BE REMOVED, WHICH OREGONIAN SHOULD REPLACE THEM AS A STATUE. THE GOVERNOR APPOINTED ME TO SERVE AS A NONVOTING MEMBER, A NONVOTING ADVISOR TO THE COMMISSION. THEY HAD THEIR FIRST MEETING YESTERDAY, THEIR SECOND MEETING IS NEXT MONDAY IN SALEM, WHERE THEY'LL RECEIVE TESTIMONY ON THE ISSUE OF DR. McLAUGHLIN AND JASON LEE. THEIR HISTORICAL SIGNIFICANCE, THEIR ACHIEVEMENTS, THEIR LIFE, THEIR LEGACY. THEY LOOK TO MAKE A DECISION FIRST AS TO WHETHER EITHER OF THOSE SHOULD BE REPLACED, AND AFTER THAT THEY'LL OPEN IT UP TO DISCUSSION OF WHO SHOULD BE REPLACE THEM. OHS IS GOING TO SERVE AS THE FOCAL POINT, WE'LL HAVE OUR WEBSITE, A SECTION DEVOTED TO THAT ONCE IT COMES UP, WE'LL BE DRIVING PUBLIC COMMENT, REACHING OUT TO SCHOOLS ACROSS THE STATE, THE DEPARTMENT OF EDUCATION AND MAKE THIS A REAL ESTATEWIDE CONVERSATION ON OREGON'S HISTORY, AND THE VALUE AND WHO SHOULD REPRESENT US IN STATUARY HALL. DR. JERRY HUDSON WAS APPOINTED BY THE GOVERNOR TO CHAIR THE COMMITTEE, OTHER MEMBERS

INCLUDE MARGARET CARTER, GAIL CASTILLO, FORMER CONGRESSWOMAN ELIZABETH FURST, BOBBY CONNER FROM THE YUMA TRIBE, AND BRIDGET SMITH FROM THE WARM SPRINGS TRIBE. SO IT'S A VERY DIVERSE COMMISSION, AND THEY'VE GOT A TOUGH JOB AHEAD OF THEM. ALL TO BE DONE BY FEBRUARY 4th, THE DEADLINE SET BY WHEN THE COMMISSION IS SUPPOSED TO REPORT WITH ITS CONCLUSION. BY LAW ONLY THE LEGISLATORS CAN MAKE A DECISION ON REPLACING THE STATUE IN STATUARY HALL.

>> I THINK I'D LIKE TO ASK KERRY TO ALSO TALK ABOUT ONE OF THE MAJOR GIFTS THAT THE OHS RECEIVED THROUGH THE SCANNER.

>> YES. WE JUST RECEIVED THE COMPLETE PHOTOGRAPHIC COLLECTION FROM THE SCANNER FOR THE LAST 40 -- SINCE ITS INCEPTION, AND WE GOT A VERY NICE GRANT TO FUND THE -- TAKING CARE OF THE COLLECTION AND DIGITIZING THE COLLECTION AND MAKING IT AVAILABLE TO ALL OREGONIANS AT OHS. BERNIE AND BOBBIE FOSTER WE HONORED LAST YEAR, AND THEY'VE BEEN GREAT SUPPORTERS OF OHS, AND WE'RE JUST HONORED THEY'VE ENTRUSTED US WITH THIS PRICELESS COLLECTION OF AFRICAN-AMERICAN HISTORY HERE IN PORTLAND. THANKS FOR MENTIONING THAT.

>> ABSOLUTELY. WE WOULD LOVE TO HEAR YOUR QUESTIONS OR COMMENTS, AND AGAIN, IT'S A PLEASURE TO BE WITH YOU AGAIN THIS MORNING.

Commissioner Smith: THANK YOU FOR COMING, THANK ALL THREE OF YOU. I JUST WANTED TO GO BACK FOR JUST A SECOND. I'M NOT GOING TO LET YOU GET OFF, KERRY, ABOUT THAT BLUE RIBBON PANEL AND THE STATUES. SINCE YOU DON'T HAVE A VOTE, DO YOU HAVE ANY IDEAS OF YOUR OWN AS WHO WE SHOULD REPLACE?

>> WHAT I CAN SAY IS BEING STRICTLY NONPARTISAN, THAT WE AT THE -- AT CHAIR HUDSON'S REQUEST, I WROTE TO HISTORICAL SOCIETIES ORGANIZATIONS, AND WELL-KNOWN RESPECTED OREGON HISTORIANS ACROSS THE STATE ASKING THEM FOR THEIR SUGGESTIONS. WE'VE RECEIVED QUITE A FEW, JUST NAMES, PROBABLY THE MOST PREVALENT NAMES MENTIONED INCLUDE ABI GAIL SCOTT DUNIWAY, CHIEF JOSEPH, SENATOR HATFIELD, BEATRICE CANBY, --

>> [INAUDIBLE]

>> OSWALD WEST, EDITH GREEN. PEOPLE ARE REALLY TAKING AN INTEREST IN THIS, I THINK, AND THE COMMISSION IS CHARGED WITH INVOLVING THE STUDENTS ACROSS OREGON, AND WE'VE REACHED OUT TO THE OREGON DEPARTMENT OF EDUCATION TO -- THEY'RE GOING TO EMAIL ALL SOCIAL STUDIES TEACHERS IN OREGON TO KEEP THEM INFORMED AND TO DRIVE

THE KIDS TO THE WEBSITE WHERE THEY COULD VOTE OR REGISTER THEIR OPINION. YOU DO HAVE TO BE DECEASED TO BE A STATUE IN STATUARY HALL, SO THAT ELIMINATES A LOT OF PEOPLE.

Commissioner Smith: LAST QUESTION -- I DON'T KNOW IF YOU KEEP THIS DATA, SINCE WE'VE HAD THE LEVY, DO YOU TRACK AN INCREASE IN UNDERSERVED STUDENTS WHO ARE VISITING THE HISTORICAL SOCIETY AT ALL?

>> YES. THE TITLE 10 SCHOOLS, TITLE 9 SCHOOLS, TOP 10 SCHOOLS. THAT'S BEEN A REQUEST OF THE COMMITTEE AS WELL, OF THE LEVY OVERSIGHT COMMITTEE. WE'VE MADE AN EXTRA EFFORT OF REACHING OUT TO THE SCHOOLS THAT CAN'T AFFORD TO COME, AND WE DO HAVE A GRANT, WE GOT A GRANT FROM THE JOE WESTON FOUNDATION THAT PAYS FOR BUSES OF SCHOOLS THAT TELL US THEY CANNOT AFFORD TO TAKE A BUS. SO WE HAVE BEEN REALLY WORKING HARD REACHING OUT TO THOSE SCHOOLS TO SAY, LOOK, WE CAN PAY FOR THE TRANSPORTATION COSTS, AND SET UP A TOUR.

Commissioner Smith: HAVE THEY PARTICIPATED?

>> THEY HAVE PARTICIPATED. SCHOOL TOURS ARE UP QUITE A BIT. WE MADE A SPECIAL EFFORT WITH THE LINCOLN EXHIBIT OF REACHING OUT TO SCHOOLS, AND LOOKING AHEAD TO THE WORLD WAR II EXHIBIT, WHICH WILL RUN JUNE THROUGH SEPTEMBER OF NEXT YEAR, WORKING WITH THE SCHOOLS IN PORTLAND ACROSS THE STATE TO DRIVE A DISCUSSION ON ISSUES SURROUNDING WORLD WAR II.

Commissioner Smith: I'D LIKE TO PUT A NOTE OUT THERE TO YOU, THE REST OF MY COMMISSIONERS MAY WANT TO PARTICIPATE TOO, BUT I'D LIKE TO GO ON A TOUR WITH SOME OF THESE STUDENTS WHO ARE COMING THROUGH SO THEY HAVE AN IDEA OF WHO WE ARE, AND --

>> GREAT IDEA.

>> Commissioner Smith: AND HAVE CONVERSATION WITH THEM.

>> I'LL SEND YOU -- WE HAVE A SCHEDULE THAT COMES OUT EVERY MONTH THAT SAYS HERE'S THE TOURS OF THE MONTH AND I'LL LOOK OF ONE OF INTEREST TO YOU. GOOD IDEA. THANK YOU.

>> FINALLY, MADAM CHAIR, I THINK IT'S IMPORTANT KERRY THAT YOU SHARE YOUR THINKING AND YOUR BOARD'S THINKING ABOUT SUSTAINING FUNDING.

>> THE CO-CHAIRS AND I AND CHAIR KAFOURY AND OTHERS, WE'VE ALREADY BEGUN TO THINK OF PERHAPS A RENEWAL OF THE LEVY. THE LEVY DOES EXPIRE, THE LAST FULL CHECK WE WOULD RECEIVE WOULD BE JANUARY OF 2016, AND THEN WITH A KIND OF MAKEUP CHECK IN JUNE OF 2016, FOR SOME

EXCESS FUNDS. SO IF THE LEVY WERE TO BE A DISCUSSION ABOUT TO RENEW IT, IT WOULD BE ON THE BALLOT IN MAY OF 2016, WE'VE BEEN TOLD BY COUNTY COUNCIL AND STAFF, THAT WOULD ALLOW FUNDING TO CONTINUE UNINTERRUPTED. SO IT'S A DISCUSSION WE LOOK FORWARD TO HAVING PERHAPS NEXT YEAR WITH THE COMMISSIONERS.

Commissioner Smith: IF THE MONEY RUNS OUT IN JANUARY OF 2016 AND YOU PUT SOMETHING ON THE BALLOT MAY 2016, THAT'S AFTER THE FACT.

>> WE DO GET AN ADDITIONAL PAYMENT IN JUNE. COUNTY COUNCIL, WE RESEARCHED THIS THROUGH THE CHAIR'S OFFICE, AND COUNTY COUNCIL SAID IF IT WERE APPROVED IN MAY 2016, THAT IT WOULD KEEP GOING UNINTERRUPTED.

Commissioner Smith: SO YOU COULDN'T DO IT 2015?

>> 2015, ALSO THE COST OF DOING AN ELECTION IN 2015 IS MUCH GREATER TO THE COUNTY BECAUSE OF THE LIMITED NUMBER OF ITEMS ON THE BALLOT. SO WE --

Commissioner Smith: I DON'T MEAN TO BE POLITICAL. I'D JUST LIKE TO HAVE OTHER OPPORTUNITIES --

>> THROUGH CHAIR KAFOURY'S OFFICE, WE RESEARCHED THE ISSUE, AND THE CONCLUSION WAS MAY 2016 WOULD BE THE APPROPRIATE TIME TO PUT IT ON THE BALLOT.

Chair Kafoury: AND THIS IS A DISCUSSION WE WILL HAVE AMONGST THE COMMISSIONERS THAT WILL HAVE TO BE A VOTE FROM US. I'M HAPPY TO HAVE AARON COME TO BOARD STAFF AT SOME POINT AND HAVE A BRIEFING ON THE WHERE'S AND WHYS AND HOWS OF DATES AND NUMBERS.

Commissioner Smith: BUT WE WOULD HAVE TO VOTE TO PUT IT ON THE BALLOT TO DO THAT.

>> CORRECT. THE DECISION TO PUT IT ON THE BALLOT IS A DECISION OF THE COMMISSIONERS.

Commissioner Smith: OK. THANK YOU.

Commissioner Bailey: I THINK SOMETIMES WE TAKE OUR HISTORY AND THE ARCHIVAL OF OUR HISTORY AND THE PRESENTATION OF OUR HISTORY FOR GRANTED. IF YOU ALL WEREN'T DOING THE WORK YOU'RE DOING, I DON'T KNOW WHO ELSE WOULD. SO AS AN OREGONIAN, THANKS FOR WHAT YOU'RE DOING. APPRECIATE IT.

>> AND I KNOW THAT SOME OF YOU HAVE BEEN OUT TO GRESHAM, BUT SOME OF YOU HAVEN'T, TO SEE THE 100,000-SQUARE-FOOT WAREHOUSE WE KEEP OUT THERE.

Commissioner Bailey: SOME OF US HAVE NOT.

>> I DIDN'T THINK YOU HAD, COMMISSIONER BAILEY, SO WE'LL EXTEND THE INVITATION. HAVE THE REST OF YOU BEEN TO GRESHAM?

Chair Kafoury: I WENT, BUT IT WAS AN AUSPICIOUS TIME OF YEAR.

>> WE'LL FIND A DATE AND WORK WITH AARON TO FIND A DATE WHERE WE CAN HOST YOU AT GRESHAM AGAIN TO SEE, REALLY, YOU WON'T BELIEVE IT.

Commissioner Bailey: IS THAT WHERE THEY PUT THE ARK OF THE COVENANT --

>> THAT'S WHAT I SAY. IF YOU'VE SEEN "RAIDERS OF THE LOST ARK," IT'S EXACTLY LIKE THAT.

Vice-Chair McKeel: THANKS FOR BEING HERE. COMMISSIONER SHIPRACK AND I, I THINK, DID THE WAREHOUSE TOGETHER. WE WERE LIKE KIDS IN A CANDY STORE. WE HAD LIMITED TIME, AND WE WERE TRYING TO KEEP PUSHING IT OUT TO NOT LIMITED TIME FROM YOU ALL, BUT WE HAD OTHER COMMITMENTS. SO IT'S AN AMAZING TOUR FOR ANYBODY THAT HASN'T BEEN OUT THERE. IT'S WONDERFUL. THANK YOU FOR YOUR PRESENTATION, AND THANK YOU TO OUR EAST COUNTY PARTNERS. IT'S SO, YOU KNOW, IT'S A WONDERFUL PARTNERSHIP THAT WE HAVE GOING HERE AMONG ALL OF OUR HISTORICAL SOCIETIES, IN MULTNOMAH COUNTY AND EAST COUNTY WE KNOW IS RICH IN HISTORY, AND WE'RE HAPPY THAT YOU'RE ABLE TO SHOWCASE THAT TO THE COUNTY. I'M LOOKING FORWARD TO YOUR WORLD WAR II EXHIBIT. I THINK THAT IS JUST SO IMPORTANT THAT WE -- HOW MANY DID YOU SAY --

>> 555.

Vice-Chair McKeel: PER DAY ARE VETERANS. AND I THINK IT'S SO IMPORTANT THAT WE HONOR THAT AND I DID HAVE THE PRIVILEGE, I'VE HAD THE PRIVILEGE OF ACTUALLY SEEING TWO HONOR FLIGHTS GO OUT, ONE LEAVING PORTLAND, AND ONE COMING INTO D.C. AND IT WAS REALLY SO MOVING. THE ONE COMING INTO D.C., BECAUSE THEY WERE SO TOUCHED BY -- PEOPLE WERE JUST LINED UP THERE. PEOPLE LIKE ME, WAITING FOR MY FLIGHT TO COME, JUST CELEBRATING THEM, AND IT WAS JUST SUCH AN HONOR TO SEE ALL OF THEM COME AND PEOPLE TO REALLY HONOR THEIR CONTRIBUTIONS. SO I'M REALLY LOOKING FORWARD TO SEEING THAT EXHIBIT.

>> I WAS TELLING COMMISSIONER GORDLY BEFORE THAT WE -- MRS. HATFIELD JUST DONATED TO THE EXHIBIT LETTERS SENATOR HATFIELD WROTE TO HIS PARENTS WHEN HE WAS A SOLDIER IN WORLD WAR II, WHICH INCLUDES AN ACCOUNT OF HIS TRIP TO HIROSHIMA. HE WAS ONE OF THE FIRST PARTIES THAT WENT IN AFTER THE BOMBING WHICH CHANGED HIS LIFE FOREVER, AND MADE HIM SUCH AN ADVOCATE FOR PEACE. SHE HAS A LETTER HE WROTE DESCRIBING THAT VISIT TO HIS PARENTS. IT'S PHENOMENAL.

Vice-Chair McKeel: THAT'S AMAZING. SO THANK YOU ALL FOR THE WORK THAT YOU DO AND FOR PRESERVING OUR HISTORY AND SHOWCASING IT FOR ALL OF US. THANK YOU.

Commissioner Shiprack: I JUST WANT TO THANK THE PRESENTERS AND OUR GUESTS, AND GUEST PRESENTERS. YOU KNOW, IT IS A TAX THAT WE DON'T MIND PAYING, AND I WANT TO GO BACK AROUND THAT AND UNDERLINE THAT, BECAUSE THAT'S A WONDERFUL THING, AND NOT ALL THAT USUAL, AND IT JUST BRINGS TO LIGHT WHAT THE CONTEXT OF THE DON'T MIND PAYING PART IS, WHICH IS THAT -- LET ME TAKE A STAB AT THAT. WE'RE ALL OREGONIANS. AND I THINK FIRST AND FOREMOST WE LOVE OUR STATE, AND THAT BRINGS THIS COMMUNITY TOGETHER THAT CROSSES PARTISAN LINES, THAT CROSSES RURAL URBAN LINES, AND IF YOU WANT TO TALK ABOUT HISTORY, REALLY, IT CROSSES NECESSARILY GENDER AND CULTURAL LINES. AND SO IT'S KIND OF A PERFECT SETTING FOR US TO TAKE A LITTLE BIT OF DISTANCE MAYBE FROM WHERE WE ARE TODAY. AND HAVE AN ABILITY TO LOOK AT OURSELVES FROM MAYBE -- FROM A KIND OF DISTANT MIRROR. PLAGIARISM IS OK FROM UP HERE. I JUST -- I WANT TO REMIND YOU KERRY THAT I ALSO SERVED IN THE LEGISLATURE, THOUGH I DID ENTER THE WITNESS PROTECTION PROGRAM. BUT I THINK THAT HISTORIC MEMORY IS A REAL THING, AND I WANTED TO SAY THAT ONE OF THE STORIES THAT I'VE BEEN ABLE TO EXPLORE THROUGH THE OREGON HISTORICAL SOCIETY THAT I FIND REALLY FASCINATING IS THE STORY OF THE FORMER LONG TIME GRANT COUNTY COMMISSIONER NAMED JOAQUIN MILLER, WHO ALSO WAS KIND OF A CHARACTER BIGGER THAN LIFE IN MANY WAYS, AND WHOSE NAME WHEN HE CAME ACROSS THE PRAIRIE IN THAT HUGE WAVE OF -- THAT WAS WHAT THEY THOUGHT OF AS MANIFEST DESTINY, WHICH CARRIES SO MUCH, AGAIN, OF THE HISTORY OF OUR PLACE. AND I'M KIND OF SURPRISED NICHOLE THAT YOU'RE SO QUIET ABOUT THAT HISTORY, IT'S SUCH A PAINFUL HISTORY NOW THAT WE HAVE KIND OF THE LEISURE TO LOOK BACK ON IT. ONE OF THE THINGS THAT I FOUND INTERESTING ABOUT JOAQUIN MILLER WAS THAT HE HAD PLAGIARIZED HIS NAME FROM A BANDIT OR FREEDOM FIGHTER, DEPENDING ON WHAT PERSPECTIVE YOU SAW HIS LIFE FROM NAMED JOAQUIN MARIETTA. AND THE CALIFORNIA GOVERNOR'S OFFICE HAD PUT OUT AN EXECUTIVE ORDER FOR THE HEAD OF JOAQUIN M ARIETTA AND THIS PERSON WHO WAS THE EDITOR OF THE EUGENE DEMOCRAT FIRED BACK A LETTER THAT SAID -- THE SACRAMENTO BEE'S RESPONSE TO THEIR

NEIGHBOR CITY EUGENE WAS, IF YOU LIKE HIM SO MUCH, WHY DON'T YOU CALL YOURSELF JOAQUIN? AND SO HE DID. AND THOSE LETTERS ARE SOMEWHERE IN THE COLLECTION OF THE OREGON HISTORICAL SOCIETY, I KNOW I LOOKED, AND AS WELL AS ALL OF THOSE REALLY WONDERFUL PHOTOGRAPHS THAT YOU COLLECT, AS WELL AS ALL OF THAT AMAZING HISTORY FROM COVERED WAGONS TO THE CONTROL CENTER FOR THE NUCLEAR -- WHICH LOOKS LIKE SOMETHING OUT OF A THE SIMPSONS CARTOON. SO THANK YOU. IT JUST ENRICHES ALL OF OUR ALLEN IVERSON I THINK.

>> THIS IS AN EXCITING WEEK FOR OHS. SUNDAY IS OUR SIXTH ANNUAL HISTORY MAKING DINNER, WHERE WE HONOR LIVING OREGONIANS FOR THEIR CONTRIBUTION. THIS YEAR'S HONOREE IS AN ECLECTIC GROUP, BAN DON DUNES GOLF COURSE, DR. WALTER URBA, WHO IS THE PROVIDENCE -- WHAT DR. DRUKER IS TO OHSU. HE'S A PRIZE-WINNING CANCER DOCTOR MAKING OREGON GROUND ZERO FOR THE FIGHT AGAINST CANCER. BARBARA ROBERTS, THE ONLY WOMAN GOVERNOR OF OREGON, AND TOM WATERDALE. SO THOMAS IS GOING TO BE PERFORMING AT THE DINNER SO IT'S BOUND TO BE A GOOD TIME.

>> Chair Kafoury: THANK YOU. I'LL JUST, BEFORE WE CLOSE, ADD MY THANK YOU TO YOU AND ESPECIALLY WANT TO THANK THE COCHAIRS AND THE COMMITTEE, THE OVERSIGHT, I THINK THAT I DON'T MAYBE PEOPLE DID HAVE UNDERSTAND WHAT WE WERE DOING, THE EXTENT TO THE IMPORTANT ROLE YOU WOULD PLAY WHEN WE PUT THIS OVERSIGHT COMMITTEE INTO PLACE, BUT I DON'T THINK ANYBODY KNEW WHAT AMAZING WORK THAT YOU ALL WOULD DO AND HOW YOUR PRESENCE AND INVOLVEMENT IN OHS AND IN THE LEVY WE PUT FORWARD HAS BEEN ADDED AS YOU SAID, SENATOR, A REAL RICHNESS TO -- WOULD IT HAVE BEEN AN IMPORTANT TAX REGARDLESS, BUT I DO BELIEVE THE RICHNESS YOU'VE ADDED HAS MADE IT REALLY INVALUABLE AND I WANT TO THANK YOU FOR YOUR VOICE AND YOUR COMMITMENT TO MAKING SURE THAT OUR HISTORY REALLY REFLECTS THE HISTORY OF ALL OF OUR -- THE MEMBERS OF OUR COMMUNITY. AND IT REFLECTS THE GOOD AND THE BAD AND THAT'S THE ONLY WAY WE CAN LEARN AS WE MOVE FORWARD. I WANT TO THANK OUR FRIENDS FROM EAST COUNTY AS WELL FOR COMING OUT. THIS IS MY GOAL, I'D LIKE TO SEE ALL OF YOUR SOCIETIES AND ASSOCIATIONS AND MUSEUMS, BECAUSE I HAVE NOT BEEN. AND I LOVED THE STORIES TALKING ABOUT THE CHILDREN COMING, BUT I THINK THEY NOTICE YOU DIDN'T TALK ABOUT THEM COMING OUT TO SEE THE WINE EXHIBIT, THOUGH MY MOTHER-IN-LAW IS SHOWCASED IN A HUGE FLOOR-TO-CEILING PHOTOGRAPH WHICH WAS A LITTLE STARTLING.

>> WE HAD A VERY POPULAR EXHIBIT ON THE HISTORY OF THE OREGON WINE INDUSTRY. SO POPULAR WE KEEPING PART OF IT PERMANENTLY IN A TASTING ROOM WE HAVE THERE. AND WE'RE ALSO TRAVELING THE EXHIBIT, AND IT'S ALREADY BOOKED FOR PLACES AROUND THE STATE FOR MONTHS

AND MONTHS AND MONTHS DOWN THE LINE. SO PEOPLE LOVE OREGON WINE, AND THE EVENT WAS SO -- THE EXHIBIT WAS SO POPULAR I'VE ALREADY ASKED MY STAFF, SO IN TWO YEARS, 2016, WE'RE GOING TO HAVE AN EXHIBIT ON THE HISTORY OF OREGON BEER.

>> Chair Kafoury: THAT WON'T BE QUITE AS INTERESTING. [LAUGHTER]

>> NO.

Chair Kafoury: JUST KIDDING. I JUST WANT TO ACKNOWLEDGE WE'RE VERY FORTUNATE AS WELL TO HAVE KERRY TYMCHUK AS OUR EXECUTIVE DIRECTOR OF OHS, AND HE WAS RECENTLY NAMED IN THE PORTLAND BUSINESS JOURNAL AS THE MOST ADMIRERED NONPROFIT EXEC. SO CONGRATULATIONS. [APPLAUSE]

>> I WAS HOPING FOR HANDSOMEST, BUT DIDN'T WIN THAT ONE.

Commissioner Smith: MAYBE NEXT YEAR. I WAS GOING TO SAY SOMETHING ALONG THAT LINE AS WELL. I DO THINK YOU ARE ONE OF OREGON'S MOST SMARTEST RESIDENTS IN THE STATE OF OREGON, AND ACROSS THE UNITED STATES. AND I HAVE TO THANK YOU PERSONALLY FOR HAVING -- SHE IS ONE OF MY FAVORITE, FAVORITE AUTHORS, AND I GOT A PICTURE WITH HER. TEAM OF RIVALS IS PROBABLY ONE OF THE MOST DYNAMIC BOOKS I'VE READ, AND I LOVE IT. AND LINCOLN IS JUST ONE OF MY FAVORITE PRESIDENTS, I LOVE THE MOVIE "LINCOLN," AND I THINK THEY DID HER PROUD IN THAT MOVIE, THOUGH THERE SHOULD HAVE BEEN MORE ACADEMY AWARDS, BUT ASIDE FROM THAT, THANK YOU FOR ALL THE GOOD WORK YOU DO.
