FOR MULTNOMAH COUNTY, OREGON

ORDINANCE NO. 312

An Ordinance relating to Park activities amending Multnomah County Code Sections 10.10.130, 10.10.190(B), 10.10.200, 10.10.280, 10.10.300, 10.15.200, and repealing Multnomah County Code Section 10.15.100.

Multnomah County ordains as follows:

Sec. 1, MCC 10.10.130 is amended as follows:

No person shall bring into or operate any motor-powered watercraft, whether motorboat, motor-powered raft, or any other motor-driven water vessel [whether motor-powered or not,] upon Blue Lake waters except those boats owned by property owners adjacent to Blue Lake, and those boats or other watercraft for rent at the park. Boating activities shall be in accordance with applicable rules of the county and the State of Oregon.

Sec. 2, MCC 10.10.190(B) is amended to read:

The board may, by its order, allow [onsite] the consumption of alcoholic beverages [in golf course club] on the premises of designated facilities when duly licensed by the Oregon Liquor Control Commission.

Sec. 3, MCC 10.10.200 is amended to read:

Fireworks and explosives prohibited. No person shall bring, or have in possession, or set off or otherwise cause to explode or discharge or burn, any firecrackers, torpedo, rocket or other fireworks or explosives of inflammable material in any park, or discharge them or throw them into any park from adjacent land or highway. This prohibition includes any substance, compound, mixture or article that in conjunction with any other substance or compound would be dangerous from any of the foregoing standpoints. The Director, however, may issue a special fireworks permit in accordance with state law.

Sec. 4, MCC 10.10.280 is amended to read:

Vending and peddling restricted. No person shall expose, advertise or offer for sale any article or thing, or station or place any stand, cart or vehicle

for the transportation, sale or display of any article or thing, unless the person is a regularly licensed concessionaire acting by and under the written authority of the [board] Director.

Sec. 5, MCC 10.10.300 is amended to read:

Park hours. [Except for unusual and unforeseen circumstances and emergencies, and those parks having overnight camping sites, parks shall be generally open to the public every day of the year from 6 a.m. to nightfall in the summer and from 8 a.m. to nightfall in the winter, provided, however, that Oxbow Park shall be open from 7 a.m. to nightfall.] Parks shall be open to the public during the hours and days designated by the Director and posted near the park entrance.

Sec. 6, Park fees.

The following fees shall be collected by Multnomah County.

- a) A-frames, picnic areas, etc. at Blue Lake Park shall be as follows: see attached fee schedule.
- b) Alcohol permits at Oxbow and Blue Lake Parks: \$150.00 with \$35.00 refundable.
- c) Overnight camping fees at Oxbow Park: \$5.00 per site per night. Permit must be displayed.
- d) Entry fees at Blue Lake and Oxbow Parks: \$1.00 per car or bus.
- e) Launch fees at 43rd Street Boat Ramp: \$1.00 per launch.
- f) Service fees for special events shall be set by the Superintendent.
- g) Group user fees at Oxbow Park shall be based on group size as follows:

Up to 15	\$10
16 to 50	\$25
51 to 100	\$50

Youth camps:

Up to 15	\$10
16 to 35	\$15
36 to 75	\$25
Over 75	\$30

h) Swimming fees.

Under six (6) years of age: no charge, must be accompanied by an adult swimmer.

Six years of age or over: \$1.50 from 12:30 p.m. to 3:30 p.m.

Six years of age and over: \$2.00 from 4:00 p.m. to 7:30 p.m.

Sec. 7, MCC 10.15.100 is repealed.


Sec. 8, MCC 10.15.200 is amended to read:

Suspension of fees. Collection of any fee established by MCC 10.15.100 may be suspended by order of the [Board of County Commissioners] Superintendent of Parks for such period of time as the order may provide.




