General Information

1. What action are you requesting from the Board?

Recommend approval of the renewal of a Wrecker (Dismantler) Certificate for PNW Metal Recycling Inc. (previously Orient Auto Parts and Recycling) for the dismantling of motor vehicles. The renewal license will be valid from the date of issuance to July 31, 2020.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

PNW Metal Recycling Inc. (previously Orient Auto Parts and Recycling) is currently operating at 28425 SE Orient Drive. The most recent Wrecker (Dismantler) Certificate will expire July 31, 2018. In order to renew the license for the August 2017 through July 2020, the wrecking yard must apply for a business certificate through the Department of Motor Vehicles. In order for the certificate to be approved, the local governing body must authorize pursuant to ORS 822.140. Orient Auto Parts has been authorized by Multnomah County since 1977. A staff report is available at Multnomah County Land Use Planning detailing how the current proposal complies with County and State regulations for wrecking certificate renewals (Case T1-2015-4289). Multnomah County's approval is required on the attached DMV Application for Business Certificate. The original DMV Application and the enclosed surety bond must be returned to the business owner after the decisions has been rendered.

3. Explain the fiscal impact (current year and ongoing).

None.

4. Explain any legal and/or policy issues involved.

The most recent certificate under which PNW Metal Recycling Inc (previously Orient Auto Parts and Recycling) operates expires on July 31, 2018. In order to continue operation, the renewal must be approved.

5. Explain any citizen and/or other government participation that has or will take place.

PNW Metal Recycling Inc (previously Orient Auto Parts and Recycling) has submitted all of the materials necessary for the renewal application. County Land Use Planning staff has contacted both Multnomah County Sheriff's Office and Assessment and Taxation Office to obtain information required by MCC 15.202. No other participation by citizens or governments has taken place. To date, no complaints have been received regarding PNW Metal Recycling Inc (previously Orient Auto Parts and Recycling). Both, Land Use Planning and the Sheriff's Department recommend approval of Wrecker Renewal for PNW Metal Recycling, Inc.
