RECOMMENDATION: Social Services Division recommends that the Board of Commissioners approve Budget Modification DHS # 37.

ANALYSIS: Budget modification DHS # 37 implements adjustments to the DD Program as follows:

DD Contracts Budget: Increased by a net total of \$63,148. \$10,000 is State start-up received in Amendment #28 to the State Mental Health Grant and will be subcontracted for Community Integration Project residential start-up needs. The remaining \$53,148 is FY 87/88 Early Intervention revenue returned to the County by Portland Public Schools. This revenue will be re-contracted to existing Early Intervention providers to serve more children.

DD Case Management Budget: Reduced by (\$23,077) to reflect one-time- only adjustments in Permanent due to later than anticipated hiring of ten Case Manager II's.

BACKGROUND: Amendment #28: On July 28, 1988, the DD Case Management budget was increased by \$439,506 (Bud Mod DHS #1) for Personnel and M&S to meet the needs of additional Community Integration Project clients discharged to Multnomah County. This award was an estimate based on anticipated growth for the entire fiscal year. Now that hiring has progressed, it appears that some proposed hire dates could not be met due to the magnitude of growth and the unavailability of qualified candidates. The reduction in Case Management is re-allocated to the DD Contracts budget for start-up less the federal match amount.

Provider Payback: Portland Public Schools recently returned \$52,148 in FY 87/88 Early Intervention revenue. Due to changes in the State Contract, the County can now appropriate this revenue and re-contract it for current year. Several subcontract amendments will be forthcoming.



Commissioner McCoy said the Sheriff is in another meeting, and had requested the Board hear this matter at the end of the meeting.

* * * * *

The following discussion was held later in the meeting:

Sheriff Fred Pearce explained that in December 1988 he received information from Donald E. Londer, the Presiding Judge of District and Circuit Courts, that effective February 1 the Courts would phase out custody bailiffs in Courtrooms I and II which are the arraignment courtrooms in the Justice Center, and that by July 1 the four posts would be eliminated altogether. He further explained that these posts require seven to eight employees to fill the positions. He discussed the history of the bailiff position, and said that the law covering the responsibility for these positions states it is the responsibility of the Sheriff to provide bailiff services. Retired deputies have been sought to fill these positions on

a temporary basis, but the County cannot continue to operate in this manner, therefore, he is requesting permission to start the hiring process April 1 in order to have trained deputies to fill the positions. Deputies will also be trained by the Sheriff's Office, and will attend the Police Academy in the fall. Eighteen weeks of training is required before deputies are ready to perform regular deputy sheriff duties. He discussed populations of the arraignment courts; and said there will be no need for additional budget monies to fund these positions this fiscal year.

Commissioner Kafoury questioned whether or not the Sheriff had explored continuing a contract with the Court to provide these services.

Sheriff Pearce replied he has not because he strongly objects to contracting out services mandated to the Sheriff by law.

Commissioner Kafoury said that she feels the amount of money is a major issue, and that it would be worth the time to talk to the Courts.

Sheriff Pearce again voiced his concerns about contracting with the State for services which are County responsibility, and especially mandated services. In response to Commissioner McCoy's question, he said the Courts have been performing the function at state expense for a number of years; and it is now County expense for which the Sheriff has direct responsibility by law. He added he is willing to discuss the matter, but remains adamant in his opinion that County responsibilities should be honored.

Commissioner McCoy stated that she agrees with the Sheriff, but that if the County could save \$100,000 by continuing a contract with the Courts, she would like to do that.

Sheriff Pearce said that he would like to have more dialogue on this matter, but needs to do it soon so the positions can be included in next year's budget. He again requested the decision be made by April 1 so hiring and training can begin.





EXECUTIVE SUMMARY

TARGETING URBAN GANGS

Since 1983, there has been a steady and documented increase in both the availability and quality of heroin, cocaine, and methamphetamines in Portland and the surrounding communities. In 1987 a new element entered into the drug trafficking scene--urban gangs. While a number of local, state, and federal resources have been brought to bear on the problem, it has not been sufficient to stem the flow of crack cocaine into the inner northeast neighborhoods of Portland. During 1988, there were 68 deaths from drugs: 28 of them from crack cocaine. This is a 350% increase in cocaine deaths from the previous year.

The tri-county region has developed an overall strategy aimed at reducing the amount of illicit drug traffic in this geographic region. The Regional Organized Crime and Narcotics Task Force, composed of the chief law enforcement agencies at local, state, and federal levels, coordinates the enforcement and investigation of targeted drug traffickers. With the escalation of criminal gang activity, two additional cooperative projects were established in the summer of '88. These are:

o The Gangs Prosecution Project is a joint venture located at the U.S. Attorney's Office. Its communication equipment is supplied by the Oregon State Police. It is staffed by attorneys from the Attorney General's Office and Multnomah County District Attorney's Office, and supported by private law firms and The Oregon Community Foundation. Its charge is to prosecute gang members involved in criminal activity. The attorneys are cross-designated to operate in both state and federal court thereby utilizing the resources of the federal system.

o The State Youth Gang Strike Force spearheaded by the Oregon State Police is staffed by officers from several law enforcement agencies. The Strike Force along with Portland Police Bureau's Gang Enforcement Team and Street Crimes Unit form the investigative arm into criminal gang activity in this region. These cooperative efforts comprise the backdrop for the Targeting Urban Gangs (TUG) Project.

The goal of the TUG Project is to reduce the amount of illicit drug traffic in this geographic region through coordinated enforcement, investigation, and prosecution of targeted urban gang drug traffickers. TUG will be responsible for the

identification, arrest, and prosecution of urban gang members engaged in mid to upper levels of drug trafficking. The strategies to be employed by this project include:

- o Maintain target list of the 15-20 mid-level urban gang drug traffickers most active in crack cocaine trade in the Portland metropolitan area
- o Ensure timely court processing of all gang-related drug trafficking cases in both federal and state court systems
- o Interdict weapons trafficking by tracing and tracking the sources of all weapons confiscated in the course of the project
- o Identify the criminal intelligence analysis methods most effective in supporting the prosecution of mid-level urban street gang drug traffickers
- o Catalog strategies and tactics that are most effective in the investigation and prosecution of urban gang drug traffickers
- o Collect, maintain, analyze, and disseminate accurate information and statistical data on the gang drug trafficking networks
- o Promote community support, involvement, and assistance in reducing the amount of illicit drug trafficking in the inner northeast neighborhoods of Portland
- o Target drug houses supported by the urban gang drug traffickers and utilize both civil and criminal procedures in closing drug houses
- o Sponsor a conference highlighting the lessons learned from the TUG Project and develop a monograph from the conference that can be shared with other interested jurisdictions

The TUG Project will capitalize on existing resources and strategies employed in combating illicit drug activity in the metropolitan area. TUG will establish an organizational unit composed of a senior deputy district attorney, a criminal intelligence analyst, a legal assistant, and a clerk. This unit will be responsible for accomplishing the TUG objectives, coordinating existing resources and forging stronger connections with community programs. The TUG Project will be the magnet for attracting other organizations, private and public, to join the effort.

TARGETING URBAN GANGS
BUDGET NARRATIVE

A. Personnel

The four positions include a senior deputy district attorney, who will direct the project and supervise the existing Gangs Prosecution Project, and additional personnel. These are the criminal intelligence analyst, legal assistant, and office assistant II. The criminal intelligence analyst will work closely with the State Youth Gang Strike Force and the Portland Police Bureau's Gang Enforcement Team and Street Crimes Unit to analyze and disseminate intelligence gathered by those groups. The legal assistant and office assistant II will provide the necessary backup and clerical support to accomplish the TUG objectives. Included in this section is a 5% cost of living allowance.

B. Fringe Benefits

The fringe benefits included under the Budget Detail are those required and are the standard fringe benefits for all Multnomah County employees.

C. Travel

Investigative travel is included in this budget to allow for members of the State Youth Gang Strike Force to pursue gang connections in the LA area. Lodging and per diem is included as well as air fare.

D. Equipment

Basic office equipment including desks, chairs, file cabinets, and microcomputers, telephones and installation, and a vehicle are included in this section. The vehicle is necessary for the senior deputy who is on call and available to law enforcement agencies and must visit crime scenes.

E. Supplies

A small amount is included for miscellaneous office and microcomputer supplies.

F. Contractual

An amount is included to allow a contract with a law enforcement agency to conduct track and trace activities on all gang weapons confiscated during the course of the project.

G. Construction

None proposed in this project.

H. Other

Allowance for rental of space for TUG Project staff and costs of accessing the County Motor Pool for the criminal intelligence analyst is included in this section. Also included is the minimum expenses for developing and holding an information exchange conference designed to share with other jurisdictions the strategies and techniques most effective in the investigation and prosecution of gang cases. The conference would be open to as many as 100 representatives of law enforcement and governmental jurisdictions and would result in a monograph that can be shared with others.

In 1987, a new element entered into the drug trafficking scene--urban gangs. Fueled by the resources of organized gangs in southern California, specifically the Los Angeles and Compton areas, urban gang members began moving to Portland and establishing drug trafficking networks using local people. While a number of local, state, and federal resources have been brought to bear on this specific urban gang drug trafficking problem, it has not been sufficient to date to stem the flow of crack cocaine into the inner northeast neighborhoods of Portland. During 1988, there were 68 deaths from drug overdoses: 28 of those deaths were due to crack cocaine.

Gang member gets 4-year prison term

One of the first California gang members placed on a gang strike force's Top 10 list in Portland was sentenced to almost four years in prison Monday for helping to bring cocaine to Oregon from the Los Angeles area last year.

U.S. District Judge Malcolm F. Marsh also ordered that the prison term for Eric D. Norseweather, 19, be followed by three years of special supervised release. Norseweather was the first gang member from the Los Angeles suburb of Compton to be identified in Portland by police in December 1987.

"I'm not a criminal or anything like that, but I knew what I was doing was wrong," he told Marsh during sentencing.

Norseweather had no previous criminal convictions when he pleaded guilty Dec. 9 to a federal charge of aiding the distribution of cocaine in the Portland area from March to August 1988. His guilty plea was part of an agreement that he be sentenced to no more than four years in prison.

Court and police records showed that police contacted Norseweather in Portland at least eight times from December 1987 to August 1988, arresting him at least three times.

The last of those arrests was Aug. 24 when he was nabbed shortly after accepting a 2½-pound package of cocaine delivered by an undercover policeman posing as a driver for an overnight delivery service.

The cocaine-filled package had been intercepted after being sent from Los Angeles. Another Bloods

gang member, Troy A. Elam, was sentenced last month to five years in prison after he admitted shipping the package.

Norseweather also was arrested June 25 near Medford when Oregon State Police found three guns, nearly \$2,500 in cash and a small amount of marijuana in a car he was driving. Norseweather told police he earned the money installing windows.

Norseweather, also known by the nickname "Baby," told police on several occasions that he was a member of the West Side Pirus, a neighborhood branch of the Bloods gang that originated in Compton.

Authorities have identified the West Side Pirus as the largest among the Los Angeles-area gangs who have taken over Portland's "crack" cocaine market.

But Norseweather's attorney, Steven Jacobson, denied Monday that Norseweather was involved in gangs. Instead, he said Norseweather wanted it known that he became involved in drug selling after seeing "people around him who had expensive things and money and who obtained them illegally."

"It had nothing to do with organized gang activity," Jacobson said.

Norman W. Frink Jr., a deputy district attorney who prosecutes gang cases in federal court, said Norseweather was "intimately involved" with some of the major gang members who came to Oregon from California.

Norseweather's arrest in August marked the first action by the Oregon State Police Youth Gang Strike Force investigating gang crime in the Portland area, and Norseweather and Elam were among the first

gang members placed on the unit's Top 10 list, said state police Lt. John Downey, commander of the strike force.

Downey said that list named mid-level gang members targeted for prosecution in federal court, where pretrial detention and longer prison sentences were available.

And although members of Norseweather's and Elam's families angrily told The Oregonian they were sure the two men were not gang members, Downey disagreed.

"I don't know that there's been a family yet that's admitted their child was a gang member," Downey said.

In another gang case Monday, Marsh sentenced Jeffrey Williams of Compton to almost three years in prison. Williams, 21, was convicted in December of possessing crack cocaine in Portland and intending to sell it. He also was ordered to have a three-year term of supervised release after his imprisonment.

a. BACKGROUND INFORMATION

Portland, Oregon, is the largest metropolitan area in the state of Oregon. It is located in Multnomah County, which has a population of 570,500. The total SMSA population figures for the area show over 1.3 million people. This includes the population of Clark County in Vancouver, Washington, which is directly north of Portland, Oregon, and the two counties bordering Multnomah County to the east and west--Clackamas and Washington Counties respectively. Portland is a medium-sized city without intensive racial and ethnic tensions, but it is not without significant economic and social problems, particularly as they relate to the minority population.

b. PROBLEM STATEMENT

Drugs and their relationship to crime is of deep concern to this community. Multnomah County has 21% of Oregon's population. During 1987 the residents of Multnomah County were victims of 74% of the robberies, 47% of the murders, 39% of the rapes and 83% of the assaults in the state. A National Institute of Justice study conducted in June, 1987, and January, 1988, found that 76% of the arrestees in Multnomah County tested positive for one or more drugs: 36% of the arrestees tested positive for two or more drugs. In 1987 there were 113 drug addicted babies born in Portland hospitals. In the first ten months of 1988 there were 171 drug addicted babies born in Portland hospitals. According to the Uniform Crime Reports for 1986, Oregon ranks third in the nation per capita for burglary. In 1987 Oregon was third in the nation in the number of methamphetamine labs seized and third in the number of weapons confiscated in connection with these seizures.

There is strong evidence of escalating criminal gang activity in the Portland metropolitan area. In April, 1987, Portland Police Bureau officers began tracking gang related incidents. In May and June of 1988 there was a dramatic increase in gang related criminal activity. Of the 431 incidents that occurred between April of 1987 and July of 1988, over one-third took place during the months of May and June of 1988. In the last six months of 1988, the Portland Police Bureau recorded another 771 gang related incidents. These included: 111 robberies, 367 assaults, 85 weapons violations, 23 drive-by shootings, 6 homicides, 66 cases involving threats, trespass and vandalism, and 113 cases of drug abuse. Most of this criminal gang activity is taking place in the northeast neighborhoods of Portland. Six of the ten neighborhoods in that geographic area fall below the Portland median household income of \$14,804. Three of the ten neighborhoods rank lowest in terms of median household income in Portland. Although Blacks make up 7.6% of the

total population of Portland, almost two-thirds of the Black population live in inner northeast Portland. For the past several decades the unemployment rate for Blacks has consistently been at least twice as high as the unemployment rate for the total population.

While the most visible groups have been Black gangs, there are other emerging gangs involved in drug trade in this area. Motorcycle gangs are heavily involved in trafficking of methamphetamine and marijuana. Motorcycle gangs, the Outsiders, Gypsy Jokers, and Brother Speed, are involved in moving "meth" throughout the state and into other jurisdictions via I-5 and I-84, the major traffic corridors.

Southeast Asian gangs are also present with the Portland Police Bureau having identified approximately 150-200 gang members. This group includes Filipinos, Laotians, Cambodians, Thais, Vietnamese, and some Chinese. The groups are known as Halo, Halo Boys, Pinoy Boys, Solo Brothers, Brotherhood of the Law, and VTM (Viet Trouble Makers). There are also White Supremist gangs in the area with about 75 known members. These are known as the East Side White Pride, POWAR (Preservation of White American Race), Youth Hitler, and Northern Hammer Skins. The Black gangs with between 650 and 800 members and associates have the largest membership according to the Portland Police Bureau. Bloods number approximately 150 members with 250 associates and Crips have 170 members and almost 200 associates. There is a great deal of mobility among the gang members, with frequent travel to and from the LA area.

Information available from the Portland Police Bureau for the first 21 days of 1989 shows that the criminal gang activity continues. In the first three weeks of the year, there have already been 25 assaults, 16 robberies, 15 cases of vandalism, 3 weapons, 1 homicide, 8 drive-by shootings, and 11 instances of drug abuse involving gang members. The most notable changes that are taking place in the Portland area have to do with an upswing in the number of Californians who are locating in northeast Portland. This is evidenced by the increasing instances of graffiti and the number of assaults over "colors." Street intelligence also indicates that the gang activity, particularly related to crack cocaine drug trade, is spreading out from the inner northeast area. They also confirm a new trend developing which is the very active involvement of young women in gang activity.

c. RESPONSES TO THE PROBLEM TO DATE

Regional Organized Crime and Narcotics Task Force

The tri-county region has developed an overall strategy to reduce the amount of illicit drug traffic in this geographic region. It has done this by establishing the Regional Organized Crime and Narcotics Task Force (ROCN). ROCN is composed of the chief law enforcement agencies, for investigation and prosecution at the local, state, and federal levels. It coordinates the enforcement, investigation, and prosecution of targeted drug traffickers. It utilizes the Drug Enforcement Administration's Geographic Drug Enforcement Program (GDEP) criteria and targets cases classified as GDEP I and II. Using resources from the Bureau of Justice Assistance and the Anti-Drug Abuse Act of 1986, the Task Force has been successful in seizing large quantities of drugs, arresting 150 people, and disrupting several major drug trafficking networks. In November, 1988, with the Riverside Organized Crime and Narcotics Task Force in California, ROCN was responsible for the largest cocaine seizure in the history of Oregon--77 lbs. Since this initial effort began in late 1986, it has developed strong, coordinated, and effective working relationships among local, state, and federal law enforcement agencies. In 1987, a Financial Investigative component was added to the ROCN Task Force. This enables ROCN to investigate and prosecute complex financial cases resulting in the seizure of profits of major drug traffickers. Refer to Appendix A for organizational chart and ROCN membership list.

With the rapid escalation of criminal gang activity and drug trafficking, two other projects have also been initiated to combat drugs and gangs in the Portland metropolitan area. These are the Gangs Prosecution Project, operated by the Multnomah County District Attorney's Office and the State Youth Gang Strike Force, directed by the Oregon State Police. These two projects represent a coordinated effort directed at eliminating criminal gang activity. They are described below.

The Gang Prosecution Project

This project was begun in July of 1988 because of a dramatic increase in criminal gang activity in Portland. It is staffed by a Multnomah County Deputy District Attorney, an Assistant Attorney General on loan from the Oregon Department of Justice, and a legal clerk funded by a grant from the Carl J. and Alma Johnson fund of The Oregon Community Foundation and private donations from area law firms. The Gangs Prosecution Project is located in space donated by the United States Attorney's Office. Both lawyers are cross-designated to prosecute cases in state and federal court. The Oregon State Police donated equipment

for the project and supplied investigative resources through the State Youth Gang Strike Force. The attorneys are on call to law enforcement agencies and work closely with Portland Police Bureau's Gang Enforcement Team and the Northeast Neighborhood Coalition's Gang Task Force.

In the first five and one-half months of operation, 24 persons were indicted in the federal system and 2 defendants were convicted and sentenced to federal custody. The majority of the defendants indicted in the federal system are in custody. Part of the Gang Prosecution Project included establishing a tracking system within the District Attorney's Office whereby all gang related cases are quickly identified and prioritized. Cases in progress include 120 felony cases, 174 misdemeanor cases, and another 46 gang related juvenile cases. It was recognized early on that the Gangs Prosecution Project could not handle every gang related case, only those federal cases and the most serious state felony cases. Definitions of gang membership and criteria for federal prosecution are included in Appendix B. These guidelines are followed by all law enforcement agencies. In addition, the Multnomah County Sheriff's Office has adjusted its release matrix to include gang membership as an element. The result is that gang members are now being held in local detention. On February 9, 1989, 64 gang members were in custody in Multnomah County. The State v. Norseweather case, cited earlier in this application, is an example of the results that can be achieved by this multijurisdictional approach.

State Youth Gang Strike Force

In early August, 1988, Governor Neil Goldschmidt announced a criminal justice package which included state actions aimed at combating gangs in the Portland metropolitan area. That package included the formation of the State Youth Gang Strike Force which was developed to assist the Portland Police Bureau and other law enforcement agencies in the tri-county area in dealing with gang and drug crimes. Refer to Appendix C for organizational chart, membership listing and gang targets. In addition, they have a liaison with the FBI, other units within the Portland Police Bureau, the Seattle Police Department, King County Police Department, Compton Police Department, the Los Angeles Police Department, the Los Angeles Sheriff's Office, IRS, and the PAINT team at Portland Airport, WISN, and liaison with community groups and organizations interested in the gang problem. They are co-located with ROCN and report their activities on a quarterly basis to the ROCN control group. The Strike Force focuses on mid- and upper-level gang members involved in drug trafficking and criminal activity. They currently have 15 to 20 individuals targeted. These are members of the Bloods and Crips gangs, all of whom are from California.

d. ASSISTANCE NEEDED

Even in the first few months of operation, it is clear that while significant resources have been directed at this problem of criminal gang activity, it is not enough. While the State Youth Gang Strike Force has redirected state and local resources at the problem, they are lacking the capacity to perform adequate analysis of the intelligence they have gathered. The two attorneys assigned to the Gangs Prosecution Project are overwhelmed by the sheer volume of cases developing in the area, are in trial continually, and not immediately available to consult with law enforcement. The ability to prosecute cases in the federal system, thereby accessing federal pretrial detention and post-sentencing incarceration has been a key part of the Portland anti-drug gang strategy and should be continued.

Adding the Targeting Urban Gangs Project to the regional strategies already in place will complete the circle of effective drug enforcement in the Portland metropolitan area and provide the needed resources to focus on all the major elements of drug trafficking in the region. Refer to Appendix D for chart displaying the array of resources for enforcement and prosecution.

e. GOAL AND OBJECTIVES

The goal of Targeting Urban Gangs (TUG) is to reduce the amount of illicit drug traffic in this geographic region through coordinated enforcement, investigation, and prosecution of targeted urban gang drug traffickers. The strategy used to accomplish this goal includes the following objectives:

- o Maintain target list of the 15-20 mid-level urban gang drug traffickers most active in crack cocaine trade in the Portland metropolitan area
- o Ensure timely court processing of all gang-related drug trafficking cases in both federal and state court systems
- o Interdict weapons trafficking by tracing and tracking the sources of all weapons confiscated in the course of the project
- o Identify the criminal intelligence analysis methods most effective in supporting the prosecution of mid-level urban street gang drug traffickers
- o Catalog strategies and tactics that are most effective in the investigation and prosecution of urban gang drug traffickers

- o Collect, maintain, analyze, and disseminate accurate information and statistical data on the gang drug trafficking networks
- o Promote community support, involvement, and assistance in reducing the amount of illicit drug trafficking in the inner northeast neighborhoods of Portland
- o Target drug houses supported by the urban gang drug traffickers and utilize both civil and criminal procedures in closing drug houses
- o Sponsor a conference highlighting the lessons learned from the TUG and develop a monograph from the conference that can be shared with other interested jurisdictions

2. RESULTS OR BENEFITS EXPECTED:

Between the Gangs Prosecution Project, the State Youth Gang Strike Force, the Portland Police Bureau's Gang Enforcement Team, and the Northeast Youth Gang Task Force, many local, state, private, and public resources have been directed at the problem of criminal gang activity in this urban area. Additional resources are needed. These include: Additional prosecution capability, intelligence analysis, and backup support. These capabilities, added to the current operation, will enable law enforcement to target and track a higher level of dealer and supplier involved in drug trafficking. Criteria for the targets for this project are not unlike DEA's Geographic Drug Enforcement Program criteria (GDEP I and II). The State Youth Gang Strike Force will focus on those gang members who deal in pounds and kilos, the mid- to upper-level dealer, in an effort to move further up the ladder and establish links to gang leaders and major suppliers.

In the first few months of their operation, the Strike Force has been able to identify mid-and upper-level dealers with connections to gang leaders living in Compton and LA. These direct links to original gangs in Compton and other parts of California need to be explored further and cases need to be developed for effective prosecution. The California gang leaders are heavily involved in businesses, frequently own their own hotels, auto dealerships, limousine services and other businesses. Resources are needed to provide the more sophisticated analysis of intelligence and financial information with regard to their drug dealings and other businesses.

3. APPROACH

a. ACTION PLAN

The TUG Project capitalizes on existing resources and strategies and builds on current cooperative arrangements. It draws together the Multnomah County District Attorney's Gang Prosecution Project and taps the resources of the State Youth Gang Strike Force. It will do this by establishing an organizational unit composed of a senior deputy district attorney who will direct the resources of TUG and be responsible for the completion of the proposed objectives. In addition to this position, there will be an intelligence analyst responsible for the synthesis of intelligence data currently being collected by the State Youth Gang Task Force and dissemination of that information to the investigating teams. A legal assistant and office clerk will complete the project by supporting the work of the senior deputy and his/her staff.

The TUG Project will have the ability to draw on the resources of the District Attorney's Victim Assistance Program. An element common to gang cases is victim and witness intimidation. The Victims Assistance Program has strong ties with the Northeast Neighborhood Coalition Youth Gang Program and together these programs have been instrumental in not only locating witnesses but also in achieving their continuing cooperation throughout the criminal justice system process. In addition, independent efforts are under way to secure an additional deputy district attorney position to be located at the juvenile court in Multnomah County. The charge to that component will be a more focused prosecution of juvenile criminal gang cases. Those activities will be coordinated with TUG.

Recommendations from the California Council on Criminal Justice "State Task Force on Youth Gang Violence" and the experience of other law enforcement agencies point to the establishment of specialized units for corralling criminal gang activity. The recommendations generated by two recent workshops support this approach. Both the Gang Information Sharing Seminar of November, 1988, in Portland, Oregon, and the Symposium on Youth Gangs of January, 1989, in Los Angeles, endorse specialized units. The criminal justice system is oriented toward identifying and prosecuting individuals for specific crimes and does not easily accommodate itself to the group nature of gang crime. The difficulty of effectively prosecuting gang crime contributes to fewer convictions and lesser sanctions than the serious nature of the situations warrants or that the community expects. Specialized prosecution units have been used effectively with other classes of offenders such as career criminals and drunk drivers. This approach, coupled with specialized investigative units, holds high promise for

dealing with urban gang drug trafficking. TUG will also be positioned to forge stronger ties with community programs. The anticipated benefit from this aspect of the project will be twofold. It will increase the likelihood of witness cooperation in gang investigations and prosecutions and provide information links with prevention and treatment programs.

b. IMPLEMENTATION TIMELINE AND PROJECT ACTIVITIES

c. DATA TO BE COLLECTED

The data to be collected, but not necessarily limited to, will include:

1. Number and type of gang cases referred from law enforcement for prosecution.
2. Number and types of gang drug trafficking cases under investigation.
3. Number and types of gang drug trafficking cases prosecuted in federal court.
4. Number and types of gang drug trafficking cases prosecuted in state court.
5. Number and types of community and neighborhood briefings sponsored by TUG.
6. Types and sources of weapons confiscated in the course of the TUG Project.

Two tracking systems are in place to collect data on intake and processing. One maintains information on gang cases moving through the federal court system and the other tracks gang cases in the state court system.

d. OTHER KEY ACTORS

The TUG Project represents a blending of a number of resources from a wide array of law enforcement and other organizations. These include the U.S. Attorney's Office, the Office of the Governor, the Oregon State Police, the Multnomah County District Attorney's Office, the Portland Police Bureau, the Portland Public Schools, the Northeast Neighborhood Coalition, the Attorney General's Office, The Oregon Community Foundation, and private law firms.

The rapidly escalating criminal gang activity in the Portland metropolitan area has forged cooperative working arrangements and information sharing among all of these organizations. These organizations will continue to seek

solutions to this continuing problem. Policy makers have experienced a rapid learning curve since the summer of '88 when criminal gang activity showed dramatic increases. Spurred by the sweeps and other law enforcement techniques utilized in the Los Angeles area, many of the gang members, particularly the West Side Pirus, moved to the Portland area and established immediate connections. This community's response was rapid and has been credited with containing the problem to some degree.

Each of the previously mentioned organizations have contributed resources or staff to focus on the problem. Other organizations such as the Housing Authority of Portland, Tri-Met, and Multnomah County Department of Justice Services are interested in working on the issue as well. The Oregon Division of Corrections has designated a supervisor with responsibility for chairing the staff group working with gang members under supervision by the Division. The TUG Project will work with the Division to formalize gang-specific probation agreements. The TUG Project offers the potential for a more directed use of all these resources and can be the magnet for attracting other organizations, private and public, to join the effort.

4. GEOGRAPHIC LOCATION

The location of the TUG Project will be the Portland metropolitan area within Multnomah County, the largest urban county in the state of Oregon. Because urban gang members sometimes establish drug trafficking networks within the urban area, yet live in adjacent suburban counties, the TUG Project, like ROCN, has a tri-county approach. Lawyers engaged in prosecuting these targeted gang members will be cross-designated to serve in state courts in adjoining counties. Refer to Appendix E for a map of the geographic location.

5. BIOGRAPHICAL INFORMATION FOR PROGRAM OPERATION OF TUG

Included are curriculum vitae for Michael D. Schrunk, District Attorney for Multnomah County, and Chairman of the ROCN Control Group; Michael Brown, deputy district attorney for Multnomah County, currently in charge of the Gang Prosecution Project; and Lieutenant John Downey of the Oregon State Police, director of the State Youth Gang Strike Force. ASSURANCES

The Applicant hereby assures and certifies compliance with all Federal statutes, regulations, policies, guidelines and requirements, including OMB Circulars No. A-21, A-102, A-110, A-122, A-128, and A-87, and E.O. 12372, that govern the application, acceptance and use of Federal funds for this federally-assisted project. It will comply with the provisions of 28 CFR applicable to grants and cooperative agreements including Part 18, Administrative Review Procedure; Part 20, Criminal Justice Information Systems; Part 22, Confidentiality of Identifiable Research and Statistical Information; Part 23, Criminal Intelligence Systems Operating Policies; Part 30, Intergovernmental Review of Department of Justice Programs and Activities; Part 42, Nondiscrimination/Equal Employment Opportunity Policies and Procedures; Part 61, Procedures for Implementing the National Environmental Policy Act; Part 63, Floodplain Management and Wetland Protection Procedures; and Federal laws or regulations applicable to Federal Assistance Programs.
13. It will comply, and all its contractors will comply, with the non-discrimination requirements of the Justice Assistance Act or Victims of Crime Act (as appropriate); Title VI of the Civil Rights Act of 1964; Section 504 of the Rehabilitation Act of 1973 as amended; Title IX of the Education Amendments of 1972; the Age Discrimination Act of 1975; and the Department of Justice Non-Discrimination Regulations 28 CFR Part 42, Subparts C, D, E, and G.
14. In the event a Federal or State court or Federal or State administrative agency makes a finding of discrimination after a due process hearing on the grounds of race, color, religion, national origin or sex against a recipient of funds, the recipient will forward a copy of the finding to the Office of Civil Rights Compliance (OCRC) of the Office of Justice Programs.
15. It will provide an Equal Employment Opportunity Program if required to maintain one, where the application is for \$500,000 or more.





Purpose

To prosecute in the federal or state court gang affiliated young adults charged with criminal offenses; e.g., drug distribution cases and crimes of violence, and to prosecute in state court gang affiliated juveniles charged with criminal offenses.

Criteria

1. Cases meet "gang affiliated" definition used by Portland Police Bureau:

- o Gang membership or association established by law enforcement agency
- o Evidence of colors or tattoos
- o Gang involvement named by defendant or victims
- o Reliable informant confirms gang association
- o Type of criminal activity typically associated with gangs (e.g., drive-by shootings)

2. Offenses prosecuted in federal court include but are not limited to:


- o Distribution of or possession with intent to distribute five or more grams of crack (cocaine base) or 500 or more grams of cocaine or 100 grams of heroin
- o Possession or use of a firearm to facilitate a drug transaction
- o Distribution of controlled substances within 1000 feet of a school
- o Armed Career Criminal cases (possession of a firearm by a person previously convicted of a combination of 3 or more crimes of violence, including burglary, or serious drug offenses)
- o Any cases not involving minimum mandatory penalties involving possession with intent to distribute or distribution of controlled substances where the defendant's record is sufficiently serious to warrant substantial incarceration





Organizational Array of Gang/Drug Enforcement and Prosecution Resources in Portland Metropolitan Area





LEGAL ASSISTANT

The legal assistant position is responsible for assisting deputy district attorneys and others in preparing cases for trial. This position requires substantial independent action. This position is supervised by the deputy district attorney IV.

Example of Duties:

1. Dictates court orders, drafts the order from the attorney's work sheet, proofreads and distributes copies.
2. Prepares new cases for trial, obtains all necessary information from varying sources.
3. Maintains trial docket, keeps a daily record of all cases set for trial, enters new information on each case, maintains record on each case of pleas, kind of trial, case dismissals, charges and sentences.
4. Ensures the issuance of subpoenas on cases and the reissuance of subpoenas on cases which are set-over.
5. Responds to questions from victims, witnesses, attorneys, outside agencies, and others on procedures, cases status, trials dates; provides miscellaneous information.
6. Prepares and records monthly unit statistics, prepares forms, reports, correspondence and other materials, as necessary.

OFFICE ASSISTANT II

Provides clerical support for TUG. Responsibilities include, but are not limited to, the following: Sets up office routines, maintains statistical information and case files, determines need for and orders supplies and materials, types forms, correspondence, and reports originated by others, assembles materials and performs some analysis of standard data. The office assistant II is a position requiring an intermediate level of proficiency.

JOB DESCRIPTIONS

TUG TEAM CAPTAIN

This Deputy District Attorney IV position is responsible for directing the day-to-day activities of the TUG Project. This senior level position requires substantial criminal trial experience, including complex federal and state narcotics trafficking cases.

Example of duties:

1. Directs the activities of the other deputy district attorneys involved in prosecuting criminal gang activity cases.
2. Supervises the criminal intelligence analyst and the support personnel engaged in promoting the objectives of the TUG Project. Reports to the chief deputy of circuit court in the Multnomah County District Attorney's Office, coordinates with the State Youth Gang Strike Force, and maintains liaison with the ROCN Task Force, community groups, and other law enforcement agencies.
3. Provides status reports to the ROCN Task Force regarding progress of cases, targets for investigation, case preparation and outcomes.
4. Directs all stages of case preparation and prosecution, provides legal expertise and consultation to member agencies on task force cases and areas covering rules of evidence, search and seizure, electronic surveillance, undercover operations, charging instruments, grand jury investigations in both federal and state courts.
5. Maintains strong, constructive relationships with law enforcement agencies, the U.S. Attorney's Office, the Attorney General's Office, and other ROCN Task Force member agencies to facilitate achieving the overall goal of TUG.

JOB DESCRIPTIONS

Criminal Intelligence Analyst - The role of the criminal intelligence analyst is to evaluate intelligence information and develop inferences about criminal activities. The analyst must synthesize available information, using probability concepts, concepts of link analysis, association matrices, link diagrams, organizational analysis, telephone toll data, tracking and tracing money and commodity flows, net worth assessment, and other tools and techniques of processing intelligence information. The analyst will communicate data and findings to investigators and prosecutors engaged in targeting urban gang members.

Example of duties:

1. Case development - Maintains liaison with law enforcement agencies and other groups and organizations to develop leads on potential narcotics activity, solicits intelligence from a variety of local, state, and federal sources dealing with illicit drug activity, and recommends cases to the TUG team captain for formal ROCN Control Group approval.

2. Case investigation - Utilizes intelligence information to assist in the planning, organizing, and continuation of investigations into urban gang members. Synthesizes and disseminates intelligence information.

3. Documents the analysis of intelligence data and recommends activities and directions for the investigative team. Aids in pretrial and trial proceedings.

4. Seizure/forfeiture recommendations - Provides basis to support legal proceedings for seizure and forfeiture of assets derived from illicit narcotics activity.

5. Knowledge and skills - The criminal intelligence analyst must be familiar with rules of evidence, legal methods of obtaining information, field investigation techniques, including interviewing and procedures regarding asset, seizure, and forfeiture, link analysis techniques, event flow analysis, and commodity flow charting.

Ordinance No. _____

An ordinance establishing the Children's Task Force and the Great Start Committee. Multnomah County ordains as follows:

SECTION 1. FINDINGS

- A. The Governor has announced the beginning of a "Children's Agenda" and has included some additional funds for children in his 1989-91 budget.
- B. In anticipation of those requests being approved by the Legislature, Multnomah County should begin the planning process for how those funds should be maximized.
- C. The Board of County Commissioners is responsible for appointing a Children's Task Force (CTF) and Great Start Committee (GSC).
- D. The CTF will be the coordinating body for reviewing new Children's Agenda programs in the County. The recommendations of the Great Start Committee will be reviewed by the CTF and approved by the Board of County Commissioners before being submitted to the state.
- E. Prevention intervention and treatment programs for children 0 to 7 remains one of the Board's top priorities.

SECTION 2. CHILDREN'S TASK FORCE CREATED

A. The CHILDREN'S TASK FORCE is hereby created. It shall consist of nine positions:

Leader's Roundtable
Three representatives

Juvenile Services Commission
Three representatives

Additional Appointments
Three other representatives appointed to achieve a balanced committee reflecting the following:
the racial, ethnic and geographic composition of the county, providers, advocates, parents, health professionals, school districts, state agencies serving youth, and labor

B. Members of the Task Force shall be appointed in accord with the Home Rule Charter.

SECTION 3. STAFFING AND MEETINGS

A. The Children's Task Force will initially be staffed by the Leader's Roundtable and Youth Program Office. Staff is welcome to pursue funding options for providing dedicated staff to assist with the CTF and GSC.

B. Task Force meetings will be subject to the Oregon Open Meetings Law.

SECTION 4. DUTIES

The Children's Task Force will:

1. oversee the implementation of the Children's Agenda
2. report recommendations of the Great Start Committee to the Board of County Commissioners for their approval.
3. coordinate the new Children's Agenda programs developed by the County, CSD, SRI, and JSC
4. attempt to involve the business community and citizens in efforts to expand the impact of the new programs
5. be the contact point for the state for the Children's Agenda, including serving as
 - a clearing-house for agency rules and regulations
 - a forum for discussion of legislation and policy
 - a central point for the discussion of state and local program elements
 - a check-off point for local DHR contracts affecting children
 - a plan to stimulate and use volunteer efforts
6. use the Juvenile Services Commission's youth planning process as the first step towards developing a county wide comprehensive youth plan

SECTION 5. GREAT START COMMITTEE CREATED

A. The GREAT START COMMITTEE is hereby created. It shall consist of twelve positions:

Juvenile Services Commission Prevention Committee (8)

Four current JSC members

Four at large members representing the Health Division, special education, early intervention services, and the Governor's Child Care Committee

Four additional representatives appointed to achieve a balanced committee reflecting the following:
the racial, ethnic and geographic composition of the county, advocates, mental health providers, health professionals, and parents of small children

B. Members of the Task Force shall be appointed in accord with the Home Rule Charter.

SECTION 6. STAFFING AND MEETINGS

A. The Great Start Committee will be staffed by the Youth Program Office.

B. Committee meetings will be subject to the Oregon Open Meetings Law.

SECTION 7. DUTIES

A. The Great Start Committee will:

1. Develop specific programs for county block grant money from the state designed to address prevention and remediation services for children from prenatal period through age six.
2. Additionally, coordinate with appropriate county staff the development of proposals in the following areas:
 - a. Primary Care Health Clinics
 - b. High Risk Infant Screening/Followup
 - c. Emotionally Disturbed Children

SECTION 8. PLAN

A. The Children's Task Force and the Great Start Committee will meet as needed until January 1, 1990. After January, they should meet quarterly or as needed. They should attempt to develop a consensus plan about how to consolidate and streamline the existing network of youth planning committees.

SECTION 9. ADOPTION

A. This ordinance, being necessary for the health, safety, and general welfare of the people of Multnomah County, shall take effect on April 1, 1989, pursuant to Section 5.50(1)(a) of the Charter of Multnomah County.


