1. What action are you requesting from the Board?

Board convenes as the Multnomah County Library District (MCLD) Board.

Request Board approval of appointment of Sarah Alibabaie to the Multnomah County Library Advisory Board, Position 3. Ms. Alibabaie's term will run from July 1, 2012 through June 30, 2016.

Request Board approval of appointment of Rob Edmiston to the Multnomah County Library Advisory Board, Position 4. Mr. Edmiston's term will run from July 1, 2015 through June 30, 2019.

Request Board approval of appointment of Lois Leveen to the Multnomah County Library Advisory Board, Position 5. Ms. Leveen's term will run from July 1, 2015 through June 30, 2019.

Request Board approval of appointment of Elliot Zais to the Multnomah County Library Advisory Board, Position 11. Mr. Zais's term will run from July 1, 2013 through June 30, 2017.

Nominees for the Library Advisory Board are advanced to the MCLD Board after being approved for recommendation by current board members. There are 17 members, including two youth members (between the ages of 13-17). Once appointed to the Library Advisory Board by the MCLD Board, non-youth members are appointed to four-year terms. These candidates have met the criteria for membership on the board, including interviews with current board members.

Ms. Alibabaie, Mr. Edmiston, Ms. Leveen and Mr. Zais have indicated their willingness to be appointed, and the Library Advisory Board has voted to recommend their appointments.
