My name is Jon Gramstad and I'm with Gimme Shelter Portland.

As Commissioners, your job is to create County policies and approve a budget to fund them. As such, your primary obligation to County citizens is fiduciary. I'm here to ask you four questions which need to be answered BEFORE you approve the proposed FY2019 Budget for Multnomah County Animal Services.

First:

The recent follow-up of the 2016 MCAS audit has been completed but not publicly released. How can you make an accurate and informed assessment of performance results and financial needs of this agency without any knowledge of the results of that audit?

For example - Multnomah County Auditor Steve March published the results of the initial April 2016 Animal Services Finances audit with the following edict on the cover - "Follow Sound Financial Policies". One of several disturbing findings detailed in his report was the fact that funds donated to MCAS were not being spent on the donors' intended purpose and in most cases could not be tracked. Given that MCAS has received hundreds of thousands of dollars in the past decade, it is crucial to determine if this problem has been corrected.

Second:

Animal intake numbers, the prime factor in determining agency workload, have been decreasing dramatically. 2010 intake was 8,919, 2017 just 5,600. How do you justify the 3% budget increase and added staff the agency is requesting when workload has been reduced?

Third:

The sale of pet licenses is of critical importance to creating an easy and fair source of revenue, allowing pet owners to support the services they value. MCAS publicly announced its goal of selling 100,000 licenses yearly reaching 91,542 in 2011. In 2017 that number fell to 58,000 and this budget projects a further drop to 50,000 in FY2019. Why are license sales numbers plummeting and why are you allowing this major source of funding, mandated by the laws of Multnomah County, to be lost?

And finally:

What happened to the money approved by this Commission in the FY 2015 Budget - Program #78015 - which gave MCAS \$700,000 from the General Fund to plan and design building modifications and why is the agency now asking for \$250,000 to fund a Master Plan which essentially duplicates that program?

I'm here because I love animals. I want MCAS to be adequately staffed and funded but I also want it to perform at the highest standards.

This budget is indicative of an agency with substandard planning, organization and performance which is effecting not only the well-being of animals but its standing the the community.

Your intervention and oversight is needed. You can begin with a detailed review of this proposed budget.

We engage tens of thousands of people a year in multi-faceted ways in Multnomah County. We want our criminal justice system to continually strive to be more effective, fair, and transparent.

Budgets are a reflection of our values and vision for what kind of outcomes we want to see in our communities. We are joining together to ask you to commit to working with us and the District Attorney's (DA) office over the next year to develop and adopt a meaningfully new framework for the DA's budget. We fundamentally believe that Multnomah County should set a higher bar for the performance measures embedded in the DA budget to help the county assess that office's work and the impact of the tens of millions of dollars in public resources spent annually.

Dear Chair and Commissioners,

For the record my name is Kate Gonsalves and I'm the Political Director at the Oregon Justice Resource Center.

The Oregon Justice Resource Center is a public interest law firm that represents currently and formerly incarcerated Oregonians and advocates for criminal justice reform. We operate and administer several distinct projects that provide direct representation to Oregonians on a range of issues who otherwise would not have access to legal services. OJRC works to transform the criminal justice system including working to challenge excessive sentences, over-incarceration and those disproportionately impacting people of color, immigrants and justice involved women.

Tonight, as you weigh budget priorities I'm here to elevate two issues:

- 1) Investing in community supports while decreasing reliance on incarceration.
- 2) New metrics for measuring success in the Multnomah County District Attorney's budget.

On the first point, it's evident that the tremendous human and fiscal costs of over-incarceration are not confined within our county jail cells. Instead, they are reflected in funds directed away from competing priorities such as support programs run by the community groups and nonprofits represented here tonight. In a county with shelters and treatment programs at capacity, too often vulnerable populations cycle between the streets, emergency rooms and jails without addressing root causes.

Moving the county towards smarter holistic approaches to improve community well being is urgent work. We commend you and other Multnomah County elected officials for making notable progress to decrease reliance on incarceration despite a climate of fear mongering originating from the federal government. Stakeholders have worked hard to shutter empty jail dorms saving millions of taxpayer dollars while maintaining public safety. Redirecting these limited funds away from jailing people towards innovative accountability approaches such as the Law Enforcement Assisted Diversion

(LEAD) a pre booking harm reduction program takes political courage. We recognize the progress made under the MacArthur Grant and lend our support to further reduce our reliance on incarceration while withstanding mounting political pressures to slip backwards.

Secondly, with the recognition that public budgets reflect societal priorities, we lend our support for the ACLU initiative to set a higher bar for the District Attorney budget in creating new performance measures that more holistically assess community values and wellbeing. How we measure the health of our communities cannot be measured in conviction rates, cases processed or other outputs. New metrics are necessary to gauge and reflect progress around community values such as equity, fairness and restorative approaches. Without new performance measures and transparency, practitioners, the public and policy makers have little understanding of whether county prosecution approaches advance or hinder broader community priorities and wellbeing.

For these reasons, on behalf of the Oregon Justice Resource Center we thank you for your commitment to spending where it matters by reducing our reliance on incarceration. In the year ahead we invite you to join community partners in reenvisioning new District Attorney budget metrics for measuring success. We urge you to continue to prioritize and expand funding for forward thinking alternatives to incarceration such as harm reduction diversion programs, restorative approaches and community supports provided by culturally competent service providers. In doing so we can more effectively address root causes while strengthening Multnomah communities.
