

Marx Street; thence South 88° 36' 24" West, 505.64 feet along the said southerly line of N. E. Marx Street to the true point of beginning of Lot 3, Block 1; Thence continuing South 88° 36' 24" East, 709.37 feet along said southerly line; thence South 4° 36' 21" West, 279.78 feet; thence South 76° 06' 00" East, 370.00 feet to the westerly line of N. E. 122nd Avenue; thence southerly along a curve to the left 235.16 feet, said curve having a radius of 1,472.41 feet and a central angle of 9° 09' 03", the chord of said curve bears South 4° 23' 33" East and has a length of 234.92 feet; thence South 81° 01' 55" West, 10.00 feet; thence South 2° 47' 33" East, 93.11 feet to the northerly right-of-way line of the Union Pacific Railroad (O.W.R. & N. 

SURVEY NARRATIVE:

THE SURVEY WAS STARTED BY RECOVERING THE INITIAL POINT OF THE PLAT OF "FLOOD OAK" (BRASS PIPE IN CONC.). PLAT DISTANCES AND BEARINGS WERE USED TO RECOVER THE CORNERS SHOWN. A 5/8"x30" IRON ROD WAS SET IN THE CENTER OF AN EXISTING DRIVEWAY AND THE DISTANCES AND ANGLES WERE MEASURED TO ADJUST THE PROPERTY TO CORRESPOND TO THE DRIVEWAY CENTERLINE. PROPERTY DESCRIPTIONS WERE PREPARED FOR LOTS 2 & 3, BLOCK 1, TO REFLECT THE LOT LINE ADJUSTMENT THAT RESULTED FROM THIS SURVEY.
