He previously directed the Kirwan Institute for the Study of Race and Ethnicity at Ohio State University and the Institute on Race and Poverty at the University of Minnesota. He is a nationally recognized scholar on race, poverty, and regional equity and the author of *Racing to Justice: Transforming our Concepts of Self and Other to Build an Inclusive Society*.
