**RESOLUTION NO. 2012-068**

Authorizing the Private Sale of a Tax Foreclosed Property to Maria White.

**The Multnomah County Board of Commissioners Finds:**

- a. Multnomah County acquired through the foreclosure of liens for delinquent real property taxes, certain real property located in Multnomah County, more particularly described in a copy of a proposed deed, attached as Exhibit A (the "Property").
- b. The Property has a real market value of \$2,000 on the assessment roll prepared for the County, consistent with the requirement of ORS 275.225(1) (a).
- c. Although no written confirmation from the City of Portland was obtained, the County is confident that the location and size of the Property make it unsuitable for the construction or placement of a dwelling thereon under applicable zoning ordinances and building codes, as provided under ORS 275.225(1) (b).
- d. The County has received payment in the amount of \$1,500 from Maria White, an amount the Board finds to be a reasonable price for the Property in conformity with ORS 275.225.


**The Multnomah County Board of Commissioners Resolves:**

BEFORE SIGNING OR ACCEPTING THIS INSTRUMENT, THE PERSON ACQUIRING FEE TITLE TO THE PROPERTY SHOULD CHECK WITH THE APPROPRIATE CITY OR COUNTY PLANNING DEPARTMENT TO VERIFY THAT THE UNIT OF LAND BEING TRANSFERRED IS A LAWFULLY ESTABLISHED LOT OR PARCEL, AS DEFINED IN ORS 92.010 OR 215.010, TO VERIFY THE APPROVED USES OF THE LOT OR PARCEL, TO DETERMINE ANY LIMITS ON LAWSUITS AGAINST FARMING OR FOREST PRACTICES, AS DEFINED IN ORS 30.930, AND TO INQUIRE ABOUT THE RIGHTS OF NEIGHBORING PROPERTY OWNERS, IF ANY, UNDER ORS 195.300, 195.301 AND 195.305 TO 195.336 AND SECTIONS 5 TO 11, CHAPTER 424, OREGON LAWS 2007, SECTIONS 2 TO 9 AND 17, CHAPTER 855, OREGON LAWS 2009, AND SECTIONS 2 TO 7, CHAPTER 8, OREGON LAWS 2010.

The true consideration for this conveyance is \$1,500.

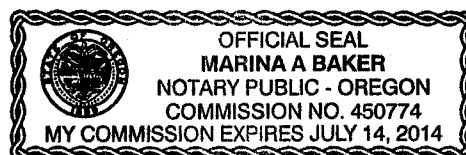

**Legal Description:**

A tract of land in the Southeast One-Quarter of Section 11, Township 1 South, Range 2 East, of the Willamette Meridian, Multnomah County, Oregon, more particularly described as follows:  
Commencing at a point in the West line of the Alonzo Gates Donation Land Claim in Section 11, Township 1 South, Range 2 East of the Willamette Meridian, which point is the intersection of the above West line and the South line of the above donation land claim in Section 12, extended Westerly; thence North along the West line of the above donation land claim 660 feet; thence South 89°28' East 1056 feet to the true point of beginning; thence South 89°28' East 132 feet; thence South 330 feet; thence North 89°28' West 132 feet; thence North 330 feet to the true point of beginning.
