1. What action are you requesting from the Board?

The department is requesting board approval of budget modification DCA-19-16 reclassifying a Project Manager to Contract Specialist Sr (position #717455, PO 78048-16).

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

This modification reflects Class Comp decision #3265; a reclassification request initiated by management. This vacant position within the Contracts, Procurement, & Strategic Sourcing Division of the Department of County Assets (DCA) is requested for reclassification from a Project Manager (Non-Represented) to a Contracts Specialist Senior in order to support the volume of contracts for DCA's Hub client base – DCA, DCM, Non-D, including the Chair and Commissioners.

This position will be responsible for developing and administering complex contracts and agreements; providing oversight on the most complex development of services and supply contracts as well as formal and informal solicitations; coordinating a variety of special projects involving inter-divisional and inter-agency agreements such as cooperative and intergovernmental contracts; providing research and analysis on special areas or customer needs; providing ongoing analysis and reporting related to contracts; monitoring and supporting contract activities; reviewing contracts to ensure conformance with statutes, regulations, policies, and procedures; facilitating meetings between internal/external customers and vendors to resolve issues; and developing and monitoring proposals to ensure funding sources and contracts align and comply with scope and

schedule of contract. The program offer affected is 78048-16

3. Explain the fiscal impact (current year and ongoing).

Personnel expenses are reduced by \$1,090, offset by an increase in supplies. In subsequent fiscal years, the reclassified position will be subject to approved cost of living adjustments (COLA). The current top step of the new classification is 13.3% low than the current classification's top step. It is anticipated that in subsequent fiscal years the new classification will be funded within the department's budget
