Authorizing the Private Sale of a Tax Foreclosed Property R218212 to Gene M. Monnin, Jr.

The Multnomah County Board of Commissioners Finds:

- a. Multnomah County acquired through the foreclosure of liens for delinquent real property taxes, certain real property located in Multnomah County, more particularly described in a copy of a proposed deed, attached as Exhibit A (the "Property").
- b. ORS 275.225 allows the County to sell County owned property, including property acquired through tax foreclosure, at a private sale if that property meets certain conditions with respect to value and the applicable zoning and building codes.
- c. The Property has a real market value of \$200 on the assessment roll prepared for the County, consistent with the requirement of ORS 275.225(1)(a).
- d. Although no written confirmation from the City of Portland was obtained, the County is confident that the location and size of the Property make it unsuitable for the construction or placement of a dwelling thereon under applicable zoning ordinances and building codes, as provided under ORS 275.225(1)(b).
- e. The County has received payment in the amount of \$125 from Gene M. Monnin, Jr., an amount the Board finds to be a reasonable price for the Property in conformity with ORS 275.225.

The Multnomah County Board of Commissioners Resolves:

1. The County Chair is authorized to execute a deed, in substantial conformance with the deed attached as Exhibit A, conveying the Property to Gene M. Monnin Jr., in consideration of \$125.

Legal Description:

That portion of Tract 1, MIDLAND ACRES TRACTS, in the County of Multnomah and State of Oregon, described as follows:

Beginning at the intersection of the South line of Southeast Long Street, as described in the deed to Multnomah County, Oregon, recorded October 10, 1961, in Book 2084, page 697, with the Southerly prolongation of the West line of Block 3, NEWSOMS ADDITION; thence Southerly along said Southerly prolongation of the said West line to the intersection of the North line of that property described In that certain Mortgage to Dorothy B. Adams, recorded March 22, 1962, in Mortgage Book 2192, page 8, Mortgage Records in Multnomah County, Oregon; thence Westerly along said Northerly line, (which line is part of a 50 foot radius curve, the center of said curve being the Southwest corner of Lot 3, Block 3, NEWSOMS ADDITION) to the Northwest corner of the property described in said Mortgage Book and the true point of beginning of the property to be described; thence continuing along said curve to the South line of S. E. Long Street; thence East along said South line to a point on a line which is a Northerly projection of the West line of the property described in said Adams Mortgage referred to above; thence South to the true point of beginning.
