Chair Cogen and Multnomah County Commissioners:

I am unable to attend tomorrow's hearing in person to offer public comment, but I did not want to miss an opportunity to address the Urban and Rural Reserves item on your agenda.

As a resident of Multnomah County, I have been participating and attentively following the reserves process

which occupied a good deal of your time and thought as well as that of all of the Core-4 participants over the past two years. I am so impressed with the work Multnomah County commission (YOU) accomplished on behalf of your constituents and in cooperation with the other counties and Metro to adopt appropriate and defensible reserves all the way through to the LCDC approval. You are to be commended for the good work that was done throughout the process. As a result, our county sits with a balanced map of rural and urban reserves. Multnomah County participated, in good faith, with the other parties involved and now, because Washington County is modifying their reserves map, the whole process, hard work, and designations appear to be at risk for approval when back in the hands of LCDC.

I urge you to take an aggressive stand to uphold the work that has been done to date by Multnomah County and the Core-4, and do everything possible to keep enforcement of the Urban and Rural Reserves in place NOW. One of the purposes of making the designations was to serve as an overall guide when it comes to UGB expansion by Metro. In order to properly protect the precious rural reserves, I am hoping that the reserves conclusions provided by Multnomah County and approved earlier by LCDC will be in full force and effect when Metro draws the UGB lines. Any other option will not only put the entire regional reserves at risk, but it will prove to have been an huge waste of time, effort, and money with no meaningful outcome. Please do not let this happen to the thoughtful work you've done to date on designating Urban and Rural Reserves. If you must, work solely with Metro to adopt the rural reserves designated for Multnomah County to provide some degree of protection for farmland and natural features in our immediate area.

Thank you for thinking and acting proactively to protect the rural reserves and hard work completed to date.
