- a. In Resolution 2010-118 approved on August 26, 2010 approved an exemption to increase the contract amount with LRS Architects to include design work **association** with the Information Technology Data Center to an amount not to exceed \$1,600,000.

See the second resolution section k.; an extra "to" is in the sentence

- k. In order to comply with the land use decision conditions and to facilitate in part the required right of way dedications, the County will need to negotiate certain issues with the current tenant on site with **to** respect to the lease covering that tenancy.
