During the week of July 21st through July 27th, 2013, the American Probation and Parole Association is sponsoring 2013 Pretrial, Probation, Parole and Supervision Week. The Department of Community Justice's probation and parole officers, juvenile court counselors, juvenile custody services specialists, corrections counselors and technicians, community works leaders, support personnel and all the other DCJ staff that support them, – as well as our volunteers and interns – these staffs play an essential role in our public safety system. They use best practices to deliver supervision, sanctions, and treatment resources to improve public safety and address the factors that drive crime. They work in partnership with law enforcement and community agencies towards a shared vision of a safer community. DCJ staff respect victims' rights and work to provide services and protection for victims. They advocate for the restoration of communities harmed by crime and delinquent behavior.

They selflessly put themselves in potential danger when they visit offenders in the community or while supervising offenders in detention. Often they are the only support system an offender may

have. DCJ would like to publicly recognize the work of pretrial, probation and parole officers, juvenile court counselors; juvenile custody services specialists, community works leaders, corrections counselors and technicians and all the staff which support them for enhancing public safety in our community.
