In this home, Lisa appreciates the long-term relationships she has developed. A couple of years ago, a group of middle-schoolers spent their evenings at Albina studying and hanging out. When they were getting ready to graduate, they excitedly told her where they were going to high school. "Hey Library Lady," they called her. It was their term of endearment, she says.

Even though she's a supervisor, Lisa still makes time to interact with patrons to do reference checks for the books they're seeking. That part of her job helps her stay fresh and provides insight into what her colleagues experience every day on the job.

Lisa has served on the library's Disability Accommodations Group, which evaluates and recommends ways to enhance library services for patrons with disabilities. She also sat on the Diversity Steering Committee, which fosters a work culture that values people and the differences they bring to the workforce.

But his career here goes back much farther. Jim has spent that career improving his skills and striving for better ways to conduct business. He's found many ways to do that since joining the county in 1993 as an Engineering Technician Aide in the transportation survey department.

Early on, Jim wanted to advance his technical skills and took night and weekend classes to learn autocad and how to use survey instruments. He also wanted to "figure out a way" to read surveys more quickly. After just a year at the county, Jim told a supervisor he had more potential that wasn't being used.
