The Universal Declaration of Human Rights

The Universal Declaration of Human Rights (UDHR) is a milestone document in the history of human rights. Drafted by representatives with different legal and cultural backgrounds from all regions of the world, the Declaration was proclaimed by the United Nations General Assembly in Paris on 10 December 1948 (General Assembly resolution 217 A) as a common standard of achievements for all peoples and all nations. It sets out, for the first time, fundamental human rights to be universally protected and it has been translated into over 500 languages.

(1) Everyone has the right to a standard of living adequate for the health and well-being of himself and of his family, including food, clothing, housing and medical care and necessary social services, and the right to security in the event of unemployment, sickness, disability, widowhood, old age or other lack of livelihood in circumstances beyond his control.

(2) Motherhood and childhood are entitled to special care and assistance. All children,

whether born in or out of wedlock, shall enjoy the same social protection ●

Re: We demand for your ***“Immediate Resignation”*** from the Multnomah County Board of Commissioner because of your reprehensible conduct.

Dear Chairwoman Kafoury:

Greetings. On January 01, 2018, our agency was notified of a nauseated, gut and heart wrenching incident involving you calling Commissioner Loretta Smith out of her name that occurred at Multnomah County Commissioner’s meeting on December 21, 2017. The allegation is as follows: It’s been alleged that on Thursday, December 21, 2017, while at the Multnomah County Commissioner’s meeting, and as the Chairperson for the meeting, you called Commissioner Loretta Smith a ***“BITCH.”***
