1. What action are you requesting from the Board? What is the department/agency recommendation?

This is a Board briefing on the proposed FY 2005 Multnomah County Capital Improvement Program. Dave Boyer (CFO) will report on the status of various certificates of participation, bond funds and debt capacity. Doug Butler (Facilities) will describe the Facilities 5-year CIP, asset management and seismic projects. Representatives from the Library Department will describe completion of the Hillsdale Library and the FY 2005 Library Capital Program. The Sheriff's Office will present an update on the Wapato Jail project and Transportation will present info on the FY 2005 Road and Bridge programs.

2. Please provide sufficient background information for the Board and the public to understand this issue.

This is the annual Capital presentation detailing the proposed FY 2005 Multnomah County Capital Program. Representatives from several departments will describe the status of their capital programs and discuss some of their funding solutions and issues.

The capital projects along with the costs will be included in the proposed budget and is subject to Board review, modification and approval. Information provided will describe the FY 2005 proposed Capital Program by County Fund and provide the recommended financial plan for completing them.

One specific outcome is to inform the Board about what capital projects will not be built next year to retrofit buildings and bridges to prevent earthquake damage. Last year the Board adopted Resolution 03-94 stating that the Board should consider what seismic projects need to be done and specifically what it will not be completing each year as part of the annual Budget process.

In addition to seismic projects, the Board will be briefed on the proposed FY 2005 capital programs for all County funds.

5. **Explain any citizen and/or other government participation that has or will take place.**

On June 10, 2004, the Board will adopt the FY 2005 County budget. With that approval the FY 2005 Capital budget will adopted as a part of the budget. The public can comment on the capital budget a public hearings conducted by the Board as part of the budget process.

SUBJECT: Capital Budget for Certificates of Participation and Bond Funds/Debt Capacity

CERTIFICATES OF PARTICIPATION AND BOND FUNDS - SUMMARY

This is a recap on the status of the various Certificates of Participation (COP) and Bond Funds.

The County currently has three capital COP and bond proceeds available for capital projects. The balances reflected below incorporate previous action taken by the Board in reallocating monies between projects or from interest earnings. There are no new projects being suggested for FY 2005.

There are two statutory limits on County borrowing and a County policy on outstanding debt limits. The most restrictive, the County policy, would limit additional bonding to approximately \$12,000,000 in 2004-05.

FUND 2504 - BUILDING PROJECT FUND

2000 COP issue: Original issue: \$61,215,000 - Balance remaining - \$1,044,500

- **Assessment and Taxation. \$550,000.** (Original Budget \$756,590). This amount is needed to update the system to the latest version.
- **IBM Mainframe \$149,500.** (Original amount allocated \$1,034,000) These funds are needed to complete the IBM mainframe migration for the Sheriff, District Attorney and Health systems.
- **Yeon Safety \$150,000.** (Original Budget \$4,810,000). The balance remaining is needed for project completion.
- **Web development. \$195,000.** (Original Budget \$300,000). The balance remaining is still needed for project completion.

FUND 2506 - LIBRARY CONSTRUCTION FUND

1996 Library Bond Fund. Original issue \$29,000,000 - Balance remaining - \$1,700,000

- The 1996 bond is being used to finance the building or renovation of various branch libraries, new and improved information technology and other library system projects. This amount includes interest and the funds will be needed for the library projects.

FUND 2500 – JUSTICE BOND PROJECT FUND

1996 Public Safety Bond. Original issue \$79,700,000 - balance remaining after internal loan is \$12,193,000

- **Wapato Jail. \$3,700,000 (Represents bond funds only).** (Original Budget \$43,880,000 plus \$866,000 reallocated and \$970,000 that reallocated by the Board in fiscal year 2004). In addition to bond funds the County will receive \$10,845,000 from SB 1145 funds and \$873,061 SB 1145 funds remaining from the Inverness Jail project.
- **Detention Center Electronics and Fire Alarm. \$3,588,000** (Revised Budget approved by the Board during the development of the FY 2002/03 Budget is \$4,641,500). The balance remaining is needed for project completion. In addition to bond funds, an additional \$2,000,000 will be provided by grant funds to complete this project and the City of Portland will provide approximately \$700,000. It is expected that this project will take two plus years to complete.
- **IBM Mainframe \$4,905,000.** The original amount allocated was \$4,265,000 and was included in the FY 2004 Adopted Budget. These funds are needed to complete the IBM mainframe migration for the Sheriff and District Attorney. About \$1,680,000 of the total loan amount of \$6,585,000 was spent in FY 2004 and the cash flow was covered by other projects that have not yet been completed.

Proposed 2005 Financing/Internal Loan: Carried Forward From FY 2004: \$4,265,000. These funds were included in the 2003/2004 budget to complete the funding for the migration off of the IBM mainframe. This project has begun with existing money and the final financing funds will not be needed until FY 2005 so the financing has been delayed. This financing would be paid for with the savings generated from being off the mainframe plus an additional amount needed from the General Fund in the amount of about \$400,000 and would be paid off over a five year period. The following are the costs for each project.

1. **IBM mainframe migration. \$6,585,000 (Public Safety Bond Fund 2500)**

COURTHOUSE REPLACEMENT & EAST COUNTY COURT FACILITY.

As required in Resolution 04-028 adopted by the Board on March 11, 2004 the County will be moving forward with the various task forces to develop strategies for the financing and construction of the downtown Courthouse, renovation of the historic Courthouse, upgrades to the Justice Center and work on the East County court facility. At the current time it is not anticipated that the County will not be required to expend any capital funds on these projects during fiscal year 2004/2005.

OUTSTANDING DEBT AND DEBT CAPACITY

There are two statutory limits on County borrowing and a County policy on outstanding debt limits. The most restrictive, the County policy, would limit additional bonding to approximately \$12,000,000 in 2004-05.

ORS 287.054 provides a debt limit on voter approved general obligation bonds of 2% of the real market value of all taxable property within the County's boundaries. The following table represents the debt capacity at June 30, 2004

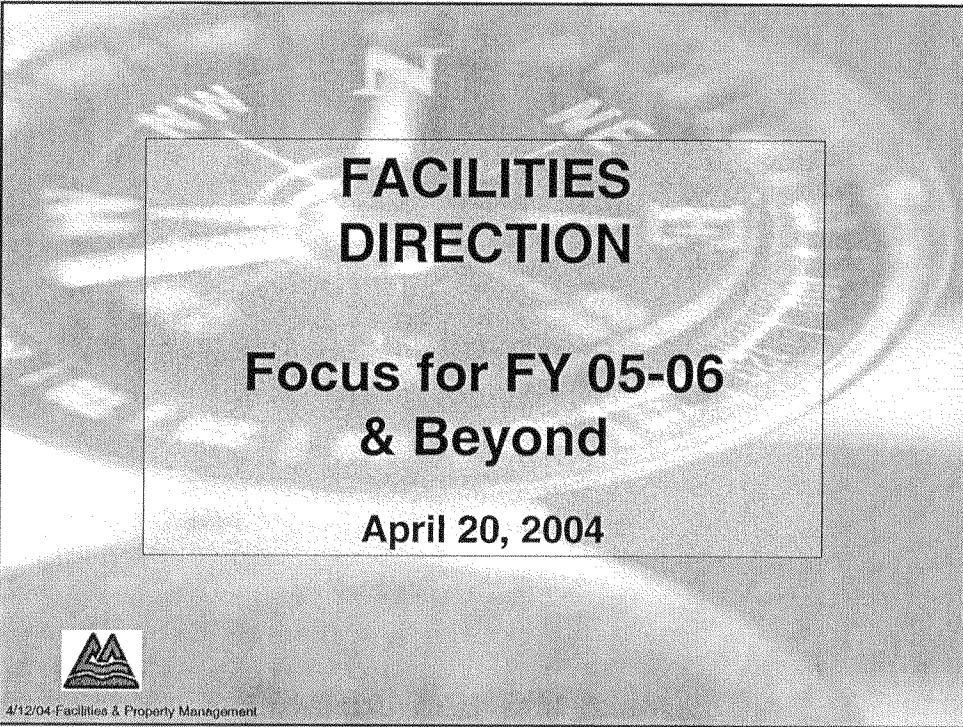
ORS 287.053 provides a debt limit on full faith and credit bonds of 1% of the real market value of all taxable property within the County's boundaries. The following table represents the debt capacity at June 30, 2003.

In addition to statutory debt limits, the County's Finance and Budget Policy, adopted by the Board, further limits our debt on non voter approved COP's and Bonds to an annual debt payment amount that will not exceed 5% of the County's General Fund Budget. As of June 30, 2004, the County will have \$117,696,000 in outstanding debt subject to the 5% test, and we are authorized to have about \$128,000,000 of outstanding debt that is subject to the County's debt policy. The real issue related to this amount is the ability to pay the debt service. Any additional debt incurred will further reduce discretionary funds that could be used for other services.

Bridge seismic retrofits are prioritized with other bridge capital needs and available financial resources.

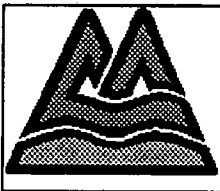

CERTIFICATES OF PARTICIPATION AND BOND FUNDS - SUMMARY

This is a recap on the status of the various Certificates of Participation (COP) and Bond Funds.

The County currently has three capital COP and bond proceeds available for capital projects. The balances reflected below incorporate previous action taken by the Board in reallocating monies between projects or from interest earnings. There are no new projects being suggested for FY 2005.

There are two statutory limits on County borrowing and a County policy on outstanding debt limits. The most restrictive, the County policy, would limit additional bonding to approximately \$12,000,000 in 2004-05.

FUND 2504 - BUILDING PROJECT FUND

2000 COP issue: Original issue: \$61,215,000 - Balance remaining - \$1,044,500

- **Assessment and Taxation. \$550,000.** (Original Budget \$756,590). This amount is needed to update the system to the latest version.
- **IBM Mainframe \$149,500.** (Original amount allocated \$1,034,000) These funds are needed to complete the IBM mainframe migration for the Sheriff, District Attorney and Health systems.
- **Yeon Safety \$150,000.** (Original Budget \$4,810,000). The balance remaining is needed for project completion.
- **Web development. \$195,000.** (Original Budget \$300,000). The balance remaining is still needed for project completion.

FUND 2506 - LIBRARY CONSTRUCTION FUND

1996 Library Bond Fund. Original issue \$29,000,000 - Balance remaining - \$1,700,000

- The 1996 bond is being used to finance the building or renovation of various branch libraries, new and improved information technology and other library system projects. This amount includes interest and the funds will be needed for the library projects.

FUND 2500 – JUSTICE BOND PROJECT FUND

1996 Public Safety Bond. Original issue \$79,700,000 - balance remaining after internal loan is \$12,193,000

- **Wapato Jail. \$3,700,000 (Represents bond funds only).** (Original Budget \$43,880,000 plus \$866,000 reallocated and \$970,000 that reallocated by the Board in fiscal year 2004). In addition to bond funds the County will receive \$10,845,000 from SB 1145 funds and \$873,061 SB 1145 funds remaining from the Inverness Jail project.
- **Detention Center Electronics and Fire Alarm. \$3,588,000** (Revised Budget approved by the Board during the development of the FY 2002/03 Budget is \$4,641,500). The balance remaining is needed for project completion. In addition to bond funds, an additional \$2,000,000 will be provided by grant funds to complete this project and the City of Portland will provide approximately \$700,000. It is expected that this project will take two plus years to complete.
- **IBM Mainframe \$4,905,000.** The original amount allocated was \$4,265,000 and was included in the FY 2004 Adopted Budget. These funds are needed to complete the IBM mainframe migration for the Sheriff and District Attorney. About \$1,680,000 of the total loan amount of \$6,585,000 was spent in FY 2004 and the cash flow was covered by other projects that have not yet been completed.

Proposed 2005 Financing/Internal Loan: Carried Forward From FY 2004: \$4,265,000. These funds were included in the 2003/2004 budget to complete the funding for the migration off of the IBM mainframe. This project has begun with existing money and the final financing funds will not be needed until FY 2005 so the financing has been delayed. This financing would be paid for with the savings generated from being off the mainframe plus an additional amount needed from the General Fund in the amount of about \$400,000 and would be paid off over a five year period. The following are the costs for each project.

- 1. IBM mainframe migration. \$6,585,000 (Public Safety Bond Fund 2500)**

COURTHOUSE REPLACEMENT & EAST COUNTY COURT FACILITY.

As required in Resolution 04-028 adopted by the Board on March 11, 2004 the County will be moving forward with the various task forces to develop strategies for the financing and construction of the downtown Courthouse, renovation of the historic Courthouse, upgrades to the Justice Center and work on the East County court facility. At the current time it is not anticipated that the County will be required to expend any capital funds on these projects during fiscal year 2004/2005.

OUTSTANDING DEBT AND DEBT CAPACITY

There are two statutory limits on County borrowing and a County policy on outstanding debt limits. The most restrictive, the County policy, would limit additional bonding to approximately \$12,000,000 in 2004-05.

ORS 287.054 provides a debt limit on voter approved general obligation bonds of 2% of the real market value of all taxable property within the County's boundaries. The following table represents the debt capacity at June 30, 2004

In addition to statutory debt limits, the County's Finance and Budget Policy, adopted by the Board, further limits our debt on non voter approved COP's and Bonds to an annual debt payment amount that will not exceed 5% of the County's General Fund Budget. As of June 30, 2004, the County will have \$117,696,000 in outstanding debt subject to the 5% test, and we are authorized to have about \$128,000,000 of outstanding debt that is subject to the County's debt policy. The real issue related to this amount is the ability to pay the debt service. Any additional debt incurred will further reduce discretionary funds that could be used for other services.
