Request Board approval of the appointment of Robert Liberty as Multnomah County's representative to the Columbia River Gorge Commission (CRGC). County representatives must be residents of the county they are appointed to represent. CRGC Commissioners serve four year terms. Mr. Liberty's term will begin March 19, 2015 and will conclude March 19, 2019.

The Columbia River Gorge National Scenic Area Act of 1986 mandates protection and enhancement of the scenic, natural, cultural and recreational resources of the Columbia River Gorge; and to protect and support the economy of the area by encouraging growth to occur in urban areas and allowing future economic development consistent with resource protection. This Act established the CRGC, which consists of thirteen members appointed by the states of Oregon and Washington, six counties and one non-voting representative from the U.S. Forest Service.
