RESOLUTION NO. 98-168

Expressing Gratitude to the Members of the East County Facilities Siting Committee for Serving on the Committee, Accepting the Report of the Committee and Directing the Facilities and Property Management Division to Commence Negotiations for Land Acquisition for the East County Facilities Projects Construction

The Multnomah County Board of Commissioners Finds:

- a. The present facility housing the Department of Health Services East County Clinic and the Aging and Disability Services Department East County Senior Center is not in condition for long range continued use.
- b. The present facility housing the Sheriff's Office enforcement and administration is not in condition for long range continued use.
- c. The present facility housing the Gresham Circuit Court is inadequate to support the long-range need of the Court.
- d. The District Attorney and Juvenile and Adult Community Justice could more effectively serve the citizens of East Multnomah County from facilities located in East County.
- e. A Public Involvement Plan for siting of East County Facilities for the East County Clinic, East County Senior Center, Sheriff's Office Enforcement, Gresham Circuit Court, Juvenile and Adult Community Justice and District Attorney was developed in accordance with the County's Facilities Siting Public Involvement Manual and Policy.
- f. A Siting Advisory Committee was appointed by the Chair, the process of public involvement set forth in the Plan was completed and a report of the East County Facilities Siting Process, including the Siting Advisory Committee's recommendations as to sites for the said Facilities has been submitted to the Board.


The Multnomah County Board of Commissioners Resolves:

1. The East County Facilities Siting Report and the sites recommendations of the Siting Advisory Committee are accepted and will be utilized in moving forward with the East County Facilities projects.
2. Gratitude of the Board is extended to the members of the Siting Advisory Committee, Sandra Carter-Templeman, Greg DiLoreto, Royal Harshman, Gerald B. 3. The Department of Environmental Services, Facilities and Property Management Division, is directed to commence negotiations for acquisition of the land for East County Facilities projects in accordance with the Report of the public facility siting process and recommendations of the Siting Advisory Committee. The Division shall report back to the Board on the status of such negotiations not later than November 15, 1998.


