## General Information

### 1. What action are you requesting from the Board?

As requested by Commissioner Judy Shiprack, the Multnomah County Local Public Safety Coordinating Council Justice Reinvestment Steering Committee will brief the Board of County Commissioners on the Multnomah County Justice Reinvestment Program (MCJRP), which was launched on July 1, 2014.

### 2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

The presentation will cover a brief overview of the MCJRP program, which was given to Multnomah County cities (Gresham, Troutdale, Fairview, and Portland) throughout the fall. Each Multnomah County Commissioner and the Chair were also given the presentation individually, and this briefing allows the Justice Reinvestment Steering Committee to present to the Board as a whole and to the public.

This presentation does not yet impact future Program Offers, however, future justice reinvestment funds (amount to be determined) may be integrated into County Department program offers if the MCJRP program is expanded. The purpose of this briefing is to

provide an update of the offenders served through the MCJRP program and the communication accomplished with local jurisdictions.

**3. Explain the fiscal impact (current year and ongoing).**

While this APR has no direct fiscal impact, it is anticipated that the County will receive justice reinvestment grant funds in 2015-2017 (as indicated, the amount is to be determined by the state). The Justice Reinvestment Subcommittee of the Local Public Safety Coordinating Council will work with the LPSCC Executive Committee and the Board of County Commissioners to ensure wise spending and investment of the funds.

**4. Explain any legal and/or policy issues involved.**

Multnomah County is impacted by the state's decision to not grow the prison population. The local public safety system is required to be responsive and develop policies and practices that meet this goal, while reducing recidivism, having good outcomes for offenders and keeping the community safe.

**5. Explain any citizen and/or other government participation that has or will take place.**

LPSCC conducts open, collaborative meetings. Meeting attendees include all elected and appointed public safety leaders, public safety partners, community service and treatment providers, the business community, and community members.
