R-1 RESOLUTION Authorizing an Extension of Time for Development of the Morrison Property Disposition Plan. Presented by Commissioner Maria Rojo de Steffey.

COMMISSIONER ROJO MOVED AND COMMISSIONER CRUZ SECONDED, APPROVAL OF AN AMENDED RESOLUTION. COMMISSIONER ROJO EXPLANATION OF THE RESOLUTION AMENDMENTS, WHICH ADDS FINDING F. AS FOLLOWS: "THE CHINESE BENEVOLENT COMMUNITY ASSOCIATION IS WORKING WITH THE COMMUNITY TO HONOR THE CHINESE MEN, WOMEN AND CHILDREN WHO WERE BURIED IN LONE FIR CEMETERY. THE ASSOCIATION IS ACTIVELY INVOLVED IN FUND RAISING EFFORTS TO BUILD A MEMORIAL HONORING THESE INDIVIDUALS." AND AMENDING RESOLVE 2. AS FOLLOWS: "COMMISSIONER ROJO DE STEFFEY IS DIRECTED TO BE THE COUNTY LIAISON FOR THE COMMUNITY COMMITTEE AND WILL CONTINUE TO WORK WITH THE BUCHMAN NEIGHBORHOOD ASSOCIATION, THE FRIENDS OF THE LONE FIR CEMETERY AND THE CHINESE BENEVOLENT COMMUNITY ASSOCIATION DURING THIS SIX MONTH PERIOD." COMMISSIONER ROJO ADVISED ON JANUARY 4, 2005 THE REMAINS OF THE CHINESE MEN, WOMEN AND CHILDREN WHO WERE BURIED IN LONE FIR CEMETERY WILL BE BLESSED BY A BUDDIST MONK. COMMISSIONER ROJO THANKED FACILITIES AND PROPERTY MANAGEMENT DIRECTOR DOUG BUTLER FOR HIS WORK. MARY ANN SCHWAB TESTIMONY IN SUPPORT OF FUNDRAISING COMMITTEE ACTIVITIES AND PLANS. CHRISTINA WALSH TESTIMONY IN APPRECIATION FOR GIVING THE COMMUNITY TIME TO RAISE MONEY AND DEVELOP A PLAN FOR SITE IMPROVEMENTS. CHAIR LINN AND COMMISSIONER NAITO EXPRESSED THEIR APPRECIATION FOR THE LEADERSHIP OF COMMISSIONER ROJO AND COMMENDED THE COMMUNITY AND CHINESE BENEVOLENT COMMUNITY ASSOCIATION FOR COMING FORWARD TO DEVELOP A COMMUNITY-DRIVEN PLAN WHICH WILL PRESENT A CONCEPT DESIGN AND FINANCIAL STRATEGY FOR THE SURPLUS COUNTY PROPERTY, INCLUDING DEMOLITION OF THE MORRISON BUILDING AND SITE IMPROVEMENTS AND BUILDING A MEMORIAL IN HONOR OF THE EARLY CHINESE BURIED IN THE CEMETERY.
