The above-described portion of S.E. Hawthorne Blvd. is a regularly dedicated street, and the same has been constructed and improved according to Multnomah County specifications under Project Agreement No. 5180. The work was paid for by Granum Construction Co., 12208 S.E. Market St., Portland, OR 97233, and the County Engineer has recommended to the Board that said portion of said S.E. Hawthorne Blvd. be taken over as a county road, and the Board being fully advised,

IT IS HEREBY ORDERED that that portion of S.E. Hawthorne Blvd., from a point 140.73 feet westerly of S.E. 209th Ave., westerly 140.94 feet, be and the same hereby is established as a county road, in accordance with ORS 368.016(2)(c) and with the center line and right of way boundary lines as dedicated by the plat of Stanwood, Blks 9 & 10 and fractional Blks 7 & 8, recorded 10-27-72, in Book 1203, Page 46, in the Plat Records of Multnomah County, Oregon, and deed of dedication to the public recorded July 10, 1981, in Book 1536, Page 1761, in Deed Records of Multnomah County, Oreogn. Said S.E. Hawthorne Blvd. being all in Section 4, T1S, R3E, W.M. The right of way to be 50.00 feet in width.


FURTHER ORDERED, the County Surveyor is hereby directed to file a map of same as required by law.






