Dear Mr. Bacher,

Thank you for meeting with me last week to discuss and review the Hillhurst right of way. As noted, this right of way was established over 100 years ago and does not benefit from any established roadways suitable for either wildland or structural firefighting. Even if roadways were to be created in the future, grades encountered in many locations would be well beyond fire district standards. Based on these findings, the fire district has no objection vacating the Hillhurst right of way.

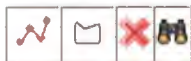
