ORDINANCE NO. 537

An Ordinance relating to the Plenary Committee membership and duties, amending Multnomah County Code Sections 2.50.130(A), (B), (C), (D) and 2.50.140.

Multnomah County ordains as follows:

SECTION 1. AMENDMENT.

A. M.C.C. 2.50.130 is amended as follows:

2.50.130 Membership and staff.

- (A) The committee shall consist of thirteen (13) members, to include: [the twelve (12) elected officials,]
(1) The Multnomah County Board of Commissioners;
(2) The County Executive, pending seating of Board Chair;
(3) The County Sheriff;
(4) The District Attorney;
(5) The Multnomah County Auditor;
(6) [The County Clerk] Department directors as defined by M.C.C. 2.30.010(3);
(7) The Director of the Office of Citizen Involvement. [The County Tax Assessor;]
[[8) The Clerk of the District Court.]
- (B) [A member] The Chair of the Board of County Commissioners [as designated by the Presiding Officer] shall act as the Chair of the Plenary Committee.
- (C) The committee shall be supported by personnel as designated by [a Plenary Coordinator and the staff of the member of the Board designated as] the Chair of the Plenary Committee.
- (D) A quorum of the Plenary Committee shall consist of 7 officials, three of which shall be other than members of the Board.

B. M.C.C. 2.50.140 is amended as follows:


2.50.140 Powers and duties of the committee.

- (A) The committee shall meet [at least once each quarter] from time to time but at least semi-annually in order to discuss legislative, financial matters, [and] policy issues, and matters referred to it by standing committees of the Board of County Commissioners.
- (B) The committee shall advise the Board of County Commissioners on all matters it has discussed.
- (C) The committee may be called together for the purpose of discussing issues on an emergency basis.
- (D) Meetings of the Plenary Committee may be called by the Chair or any three members of the committee.


