## General Information

### 1. What action are you requesting from the Board?

The Assessor is requesting the Board approve the private sale of a tax foreclosed property to the adjacent owner Gene M. Monnin, Jr.

### 2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

The subject property R218212 was foreclosed on for delinquent property taxes and came into County ownership on September 19, 2001. The adjacent property owner at 11310 SE Long St. contacted the County about purchasing the contiguous strip at private sale per ORS 275.225. The Property conforms to the requirements in ORS 275.225 in that (1) it is not suitable for construction or placement of a dwelling (it is approximately 200 square feet), and (2) has a real market value of less than \$15,000 (estimated real market value is \$200). The adjacent owner offered to purchase the strip for \$125 from the County and plans to consolidate the parcel into his main account.

This action affects our Program Offer 72038 by placing a tax foreclosed property back onto the assessment roll.

### 3. Explain the fiscal impact (current year and ongoing).

The private sale will allow for recovery of the delinquent taxes, fees, and expenses, totaling \$107.81. The sale will also reinstate the property onto the tax roll.

### 4. Explain any legal and/or policy issues involved.

The parcel will be deeded "As Is" without guarantee of clear title and is authorized under ORS 272.225.
