Proclaiming January 29, 2015 as Kathleen Todd Appreciation Day in Multnomah County, Oregon

**The Multnomah County Board of Commissioners Finds:**

- a. Kathleen Todd has been with Multnomah County and the Office of Citizen Involvement since July, 1996.
- b. Kathleen has been the Executive Director of the Multnomah County Office of Citizen Involvement since 2003.
- c. Kathleen has served under five elected Multnomah County Chairs and two Interim Chairs.
- d. Since 1996, Kathleen worked with 12 different volunteer Citizen Involvement Committee Chairs and Executive Committees while recruiting and supporting more than 1,000 volunteers serving on 10 independent Citizen Budget Advisory Committees.
- e. Kathleen was responsible for initiating and facilitating the national award winning Department Review program providing input and recommendations on citizen participation in department policy decisions.
- f. Kathleen was instrumental facilitating and supporting for the national award winning Outreach & Diversity Workshops that provide best practices for inclusive outreach from a variety of community organizations serving disparate communities.
- g. Kathleen facilitated and supervised the national award winning Traveling Recruitment & Education Campaign promoting the work done by and volunteer opportunities available through Multnomah County.
- h. Kathleen, along with the Citizen Involvement Committee, has coordinated and supported the Gladys McCoy Award selection process and recognition event since 1995.
- i. Kathleen is a founding member of the Multnomah County Vital Aging Network and has served as Chair since 2011.

- j. In 2009, Kathleen was awarded the “Sy Award” by the Multnomah County Citizen Involvement Committee in recognition of her tireless work on behalf of equitable community engagement and social justice.
- k. Kathleen was responsible for shepherding the OCI and CIC through several tumultuous years that included totally rebuilding the department and the volunteer committee.
- l. Kathleen has been engaged in facilitating citizen and neighborhood involvement for more than 30 years at the city, the county, and the neighborhood level.
