Chair Diane Linn convened the meeting at 6:10 p.m., with Vice-Chair Lisa Naito, Commissioners Serena Cruz, Lonnie Roberts and Maria Rojo de Steffey present.

CHAIR LINN ANNOUNCED THERE WILL BE AN ADDITIONAL PUBLIC BUDGET HEARING AT 9:30 AM ON TUESDAY, NOVEMBER 27, 2001 IN THE COMMISSIONERS BOARDROOM AT THE MULTNOMAH BUILDING; THAT THE BOARD WILL VOTE ON THE BUDGET REBALANCING BUDGET MODIFICATIONS AT ITS REGULAR BOARD MEETING ON THURSDAY, NOVEMBER 29, 2001; AND THAT SHE WILL RELEASE HER EXECUTIVE BUDGET ON TUESDAY, NOVEMBER 20, 2001. CHAIR LINN ADVISED SHE WILL ALSO PRESENT INFORMATION ON COST NEUTRAL INITIATIVES INCLUDING EMERGENCY PREPAREDNESS, OFFICE OF COMMUNITY SCHOOL PARTNERSHIPS AND HIRING PRACTICES AND PROCUREMENT.
