‘Grants’ requiring front-end resources

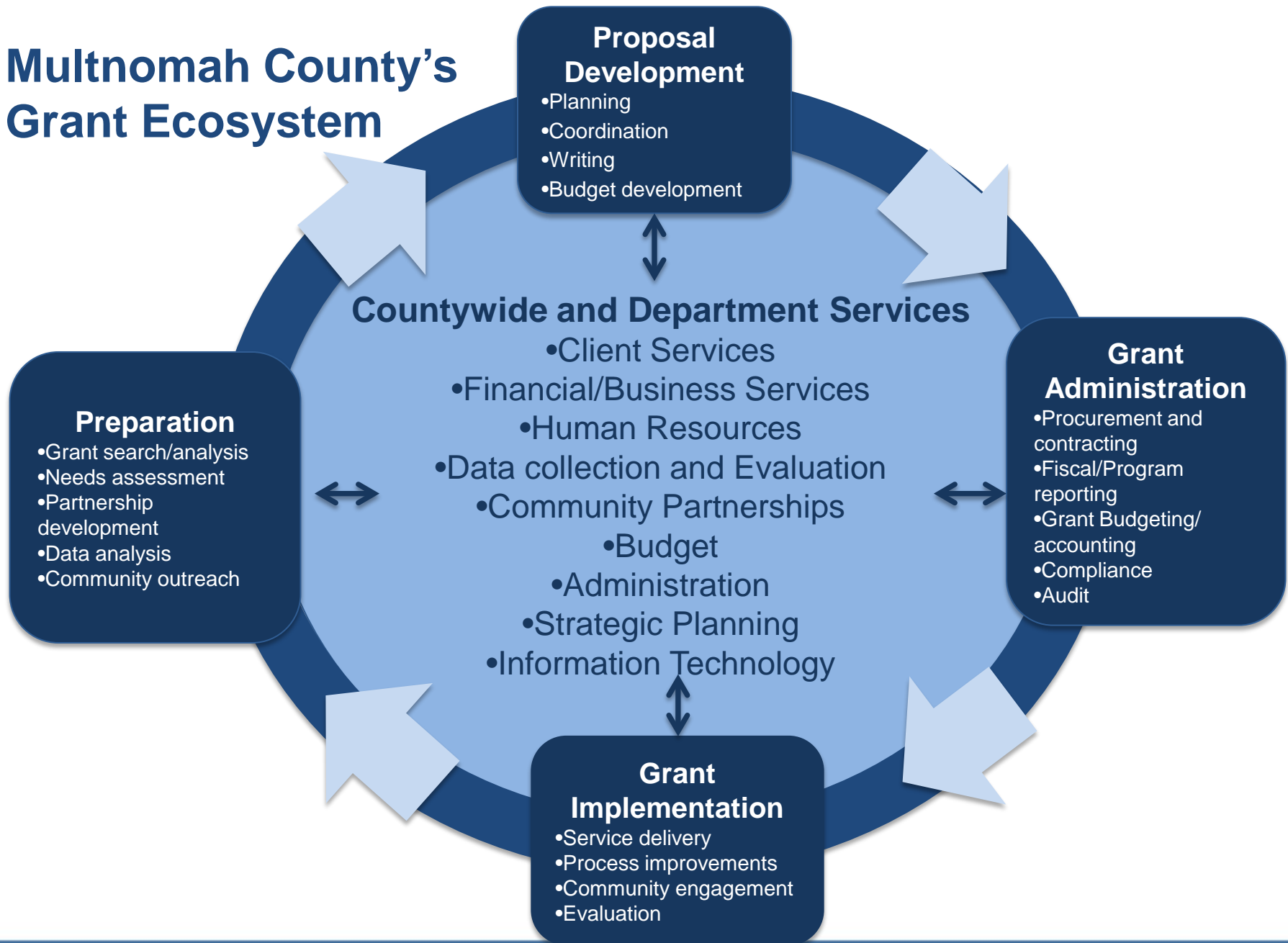
- Competitive Grants (require an NOI)
- Renewal/continuation (covered by an existing NOI)
- Formula grants that require an application process

‘Grants’ not requiring front-end resources

- Formula funding that comes to department as a strict pass-through
- Subcontracts
- Intergovernmental Agreements (IGA)
- Fee for Service
- Medicaid/Medicare
- State Formula Funds
- Other

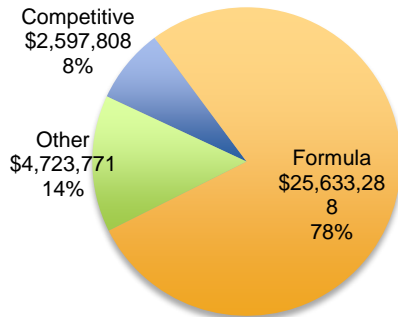


Grant Funding by Department

FY 17 Adopted Budget

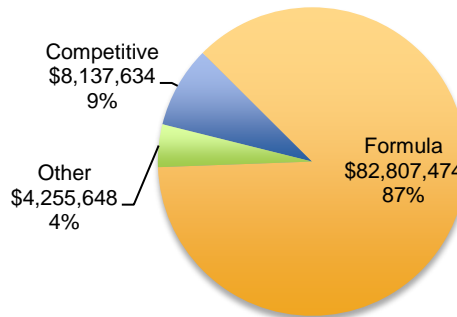

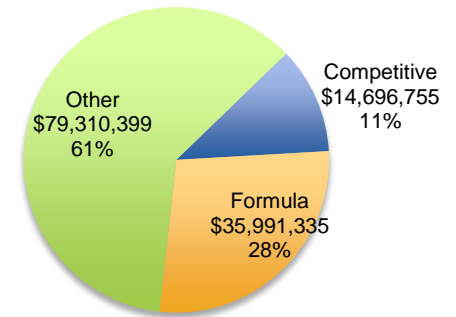

Total non-CGF: \$95,200,576



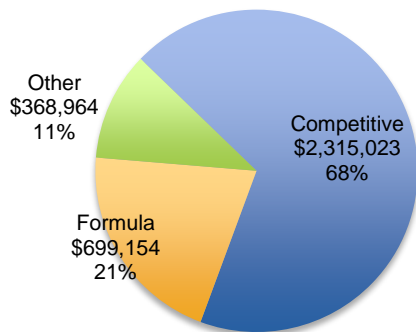

Total non-CGF: \$129,998,489



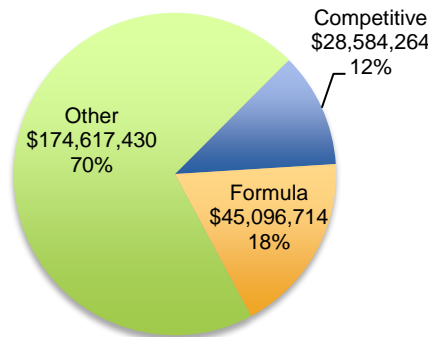

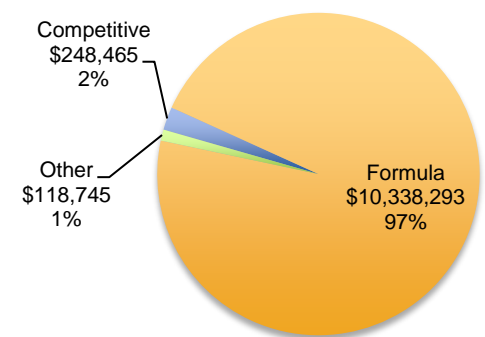

Role of Competitive Grants

Innovation: Fund innovations to enhance services, improve outcomes and/or foster quality improvements.

Expansion: Expand programs or access by leveraging existing funding sources.

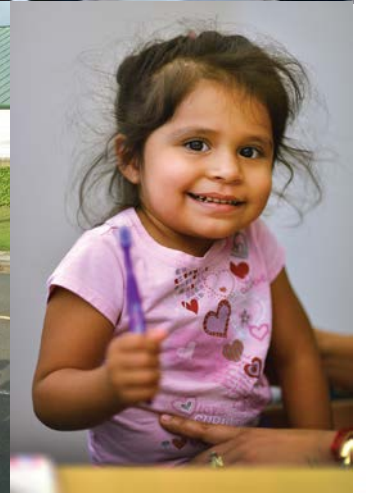
Collaborations: Involve intensive collaboration and distribution of funding across departments and/or jurisdictions.

Specialized Programming: Long-term grants to fund stand-alone programs aligned with county priorities.

Community partner supports: Utilizing county resources to support partner efforts to secure funding for county priorities.



Multnomah County Grants at Work



Opportunities

- Strong national reputation in multiple program areas.
- Successful history of cross-departmental collaboration.
- Increased emphasis on data-driven decision making.
- Strong internal and external partnerships are in place.



Constraints

- Unstable federal and state funding.
- Limited ability to predict funding opportunities and/or eligibility.
- Short grant turn-around requires up-front planning and nimble response teams.
- Opportunities may not make sense from a Cost/Benefit perspective.
- Limited access to on-going funding.



Next Steps

- Actively engage in ERP roll-out to align and streamline cross departmental tracking and reporting.
- Build on departmental collaboration to strengthen programs and approaches.
- Support departmental efforts to increase capacity through facilitating access to training and shared expertise.
- Work towards sustainable front and back end capacity across departments.
