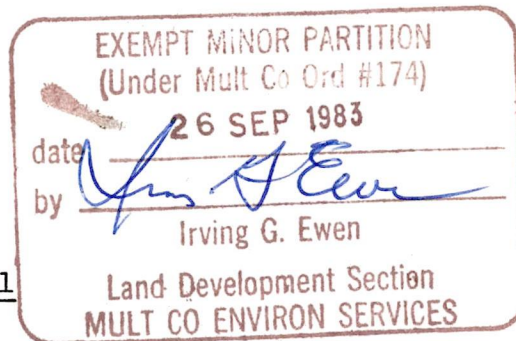

North 13°15' East, 136.6 feet to a point;

thence North 59°51'56" East, 91.27 feet to a point;

thence North 45°13'45" East, 83.58 feet to a point;

thence North 2°22' West, 78.6 feet to a point on the
Meander Line of the Willamette River;

thence South 87°45' East, along said Meander Line, 20.00 feet
to a point;

thence continuing along said Meander Line, South 76°45' East,
254.6 feet to a point described as the northeasterly corner
of the westerly 10 feet of Lot I;

thence South 13°15' West, along the easterly line of said
westerly 10 feet, 314 feet ± to the northeasterly corner of
that tract described in Book 970, Page 400, deed records
of Multnomah County;

thence North 76°45' West, along the north line of said
tract, 110.0 feet to the northwest corner;

thence South 13°15' West, 127.45 feet to a point on the

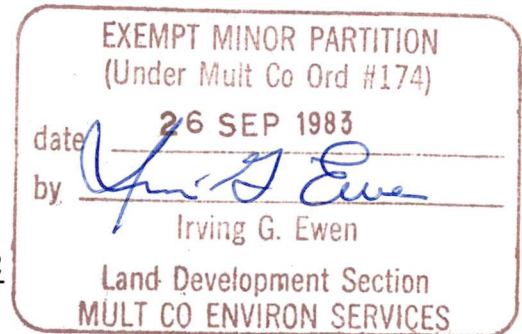

Beginning at the southeast corner of said Tract D;

thence, along the easterly line of said Tract D,
North 13°15' East, 136.6 feet;

thence North 59°51'56" West, 91.27 feet to a point on the easterly line of that tract as conveyed to Susan Reese, recorded in Book 1629, Page 300, Multnomah County deed records;

thence, along the easterly line of said Reese tract,
North 45°13'45" East, 83.58 feet to a point;

thence North 2°22' West, 78.6 feet to a point on the Meander Line of the Willamette River;

thence North 87°45' West, along said Meander Line,
80.00 feet to a point;

thence continuing along said Meander Line, northwesterly
33.41 feet to a point;

thence South 39°09' West, 145.9 feet to a point on the northerly right-of-way line of the S.P.R.R. right-of-way, 30 feet wide;

thence southeasterly along said right-of-way, 35.5 feet to a point on curve on the northerly line of S.W. Riverwood Road;

thence southeasterly on arc of a 75 foot radius curve to the right, 66.5 feet to a point;

thence continuing southeasterly along said north line 196.76 feet to the point of beginning.

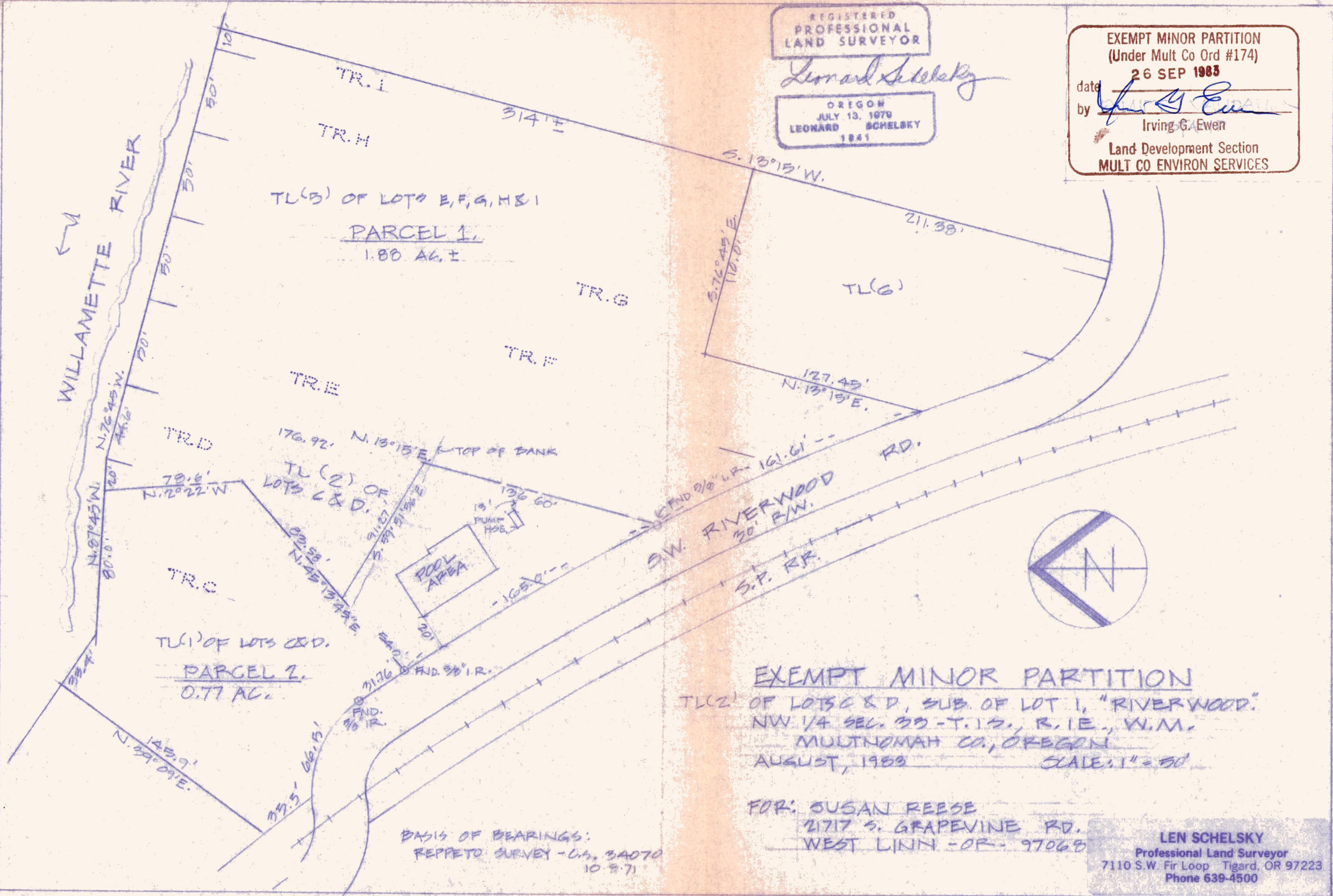
