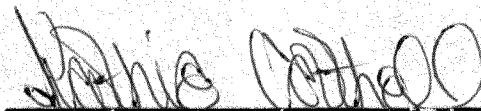

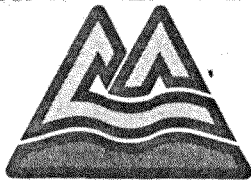

RETROACTIVE LEASE AGREEMENT: Aging Services Division's Long Term Care East and Nursing Facility branches initially were to move to the renovated David Douglas site at the beginning of the new fiscal year. That timeline has been delayed (See Harold Holub's August 2, 1988 letter, attached). Therefore, Holub has prepared the attached addendum to continue the branches' former lease at 4531 S.E. Belmont, which expired June 30, 1988, until the forthcoming move can take place.

RECOMMENDATION: The Aging Services Division recommends County Board approval of the attached lease amendment with the State of Oregon Facilities Management Division for the period of July 1, 1988 through December 31, 1988.

ANALYSIS: This lease amendment extends the current lease for a maximum six months in order to house the Aging Services Division's East and Nursing Facility branch offices until the remodeling of the David Douglas building is completed and the branches can relocate to that site. The lease contains a cancellation clause whereby the agreement may be terminated by the County after providing 60 days notice to the State of Oregon. (Holub

indicated that the State is eager to have use of the Belmont facility and anticipates no problem in giving the State even less than 60 days notice when we are certain the David Douglas site is nearing readiness for occupancy).

The lease extension continues at the same monthly rental rate as the initial lease. Funding is provided by federal Title XIX dollars.

BACKGROUND: At such time as the branch offices move to the David Douglas site, they will be co-located with Human Solutions Inc. District Center.

An Ordinance relating to Fees and amending MCC 5.10. [Bracketed items deleted and underlined items added.]

Multnomah County Ordains as follows:

Section I. Amendment

MCC 5.10.520 and 5.10.540 are amended to read:

[COUNTY MANAGEMENT] GENERAL SERVICES

5.10.520 Fee to service districts for County accounting services. The director of the [Office of County Management] Department of General Services is authorized and instructed to establish and collect fees chargeable to service districts for which the County provides accounting and related financial management services and for which the County provides automated data processing time and services, which shall be equal to the actual cost incurred by the County for providing these services, as determined by the Director.

5.10.540 Fee for services [of Data Processing Authority] Information Services Division. For the services of the [Data Processing Authority] Information Services Division in connection with gathering, preparing and providing requested information, a fee shall be charged which shall be equal to the actual cost of providing the services, as determined by the Director of the [Office of County Management] Department of General Services after consulting with the Director of the [Data Processing Authority] Information Services Division, plus an additional amount equal to 15 percent of the actual cost to defray the expenses of developing and expanding information base and access systems, provided that the fee charged by the [Data Processing Authority] Information Services Division to any governmental agency or unit shall be equal to the actual cost of gathering, preparing and providing the information only.

Section II.

5.10.560 is added to read:

5.10.560 Interest Charges on Accounts Receivable invoices. The Finance Division shall ensure that bills for all services performed by the County and all County Accounts Receivable, are collected. Except where prohibited by law, contract or agreement, interest of one and one half percent per month will be charged on all bills which remain unpaid for more than 30 days after the initial billing date.

Section III. Adoption.

This Ordinance, being necessary for the health, safety, and general welfare of the people of Multnomah County, shall take effect on the thirtieth (30th) day after its adoption, pursuant to Section 5.50 of the Charter of Multnomah County.

ADOPTED this 13th day of October, 1988, being the date of its second reading before the Board of County Commissioners of Multnomah County, Oregon.

SUBJECT: Recommendation to Ratify Amendment #18 to the State Mental Health Grant and Accompanying Budget Modification

RECOMMENDATION: Social Services Division recommends that the Board of County Commissioners ratify Amendment #18 to the State Mental Health Grant reflecting the contract period of July 1, 1988 through June 30, 1989. Further, we recommend approval of the accompanying budget modification DHS # 6 appropriating the additional revenue.

ANALYSIS: The amendment impacts our three program areas--Developmental Disabilities, Mental and Emotional Disabilities, and Alcohol and Drug. Specific action in each program includes:

DD Program--Early Intervention services for DD children are reduced by five slots for a net decrease of \$17,325. There is sufficient unallocated Early Intervention revenue and no providers will be impacted.

MED Program--Community Support Services for the Homeless Mentally Ill are increased by \$216,143 to implement a federally funded demonstration project for mentally ill persons with possible A&D abuse problems incarcerated in the Multnomah County Detention Center. \$11,834 of this total is designated for program support of the demonstration grant. At this point, \$4,500 has been allocated--\$2,000 for expenditures of project staff to travel to Washington, D.C. per federal grant requirements and \$2,500 for a personal services agreement to provide grant evaluation services. \$7,334 is unallocated at this point pending implementation of the project and identification of specific project support needs. \$204,309 will be subcontracted to Central City Concern, Mental Health Services-West and Burnside Projects.

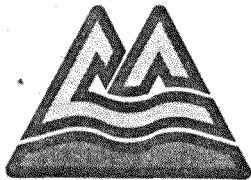
A&D Program--Drug Detox slot rates are increased and rounding errors are corrected for a net increase of \$4,038. CODA's contract will be amended to implement the new Drug Detox slot rates.

Budget Modification DHS #6 appropriates this revenue in corresponding program budgets. \$7,334 in MED Community Support Services revenue is unallocated pending County programmatic decisions and will be appropriated in a future budget modification.

BACKGROUND: DD Early Intervention slots are allocated to Multnomah County based on an estimated number of children eligible for services. In a recent count conducted by the State, it appears that there are fewer eligible DD children in Multnomah County than what our allocation was based on. This amendment revises our contract to reflect the data.

In the fall of 1987, the MED Program Office submitted two separate grant proposals for available Stewart B. McKinney revenue. Both proposals were selected for funding. Revenue for the first proposal, a shelter for homeless mentally ill, was received in the spring of 1988, and is operated by Central City Concern. Case management and outreach portions of the proposal are provided by Mental Health Services-West. Amendment #18 awards funding for the second proposal, services for mentally ill with possible A&D problems in correctional facilities. Services for this specific demonstration grant include case management and mental health treatment to 30 individuals referred from Multnomah County Detention Center; 15 pre-paid housing units managed and staffed to deliver support services consisting at a minimum of training in daily living skills, recreation, socialization, involvement in self-help groups and alcohol and drug referral. These services will be subcontracted to Central City Concern, Mental Health Services-West and Burnside Projects. A temporary exemption from the County's competitive bid process was granted on 12/87 to become effective upon contract implementation.

In Amendment #4 to the State Mental Health Grant (10/1/87), funding for a new service element--Drug Detox--was awarded to the County. The service rate has been determined to be insufficient and County requested an increase. This amendment implements our request. In addition, rounding errors which occurred in the original 88/89 allocations for various service elements are being corrected per County's request dated 5/26/88.

DD Contracts budget is reduced by (\$17,325) in Early Intervention services. Five slots are transferred back to the State as a result of the State's revised count of eligible children in Multnomah County.

MED Operations budget is increased a net total of \$4,500 in Education and Training (\$2,000) to travel to Washington, D.C. per federal homeless grant requirements and Professional Services (\$2,500) to evaluate the federal homeless grant program.

MED Contracts budget is increased by \$204,309 in Community Support Services for the Homeless to implement a demonstration project for mentally ill persons with possible A&D abuse problems incarcerated in the Multnomah County Detention Center.

A&D Contracts budget is increased a net total of \$4,308 to increase Drug Detox rates and correct rounding errors in the original contracted service rates.

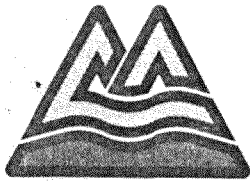

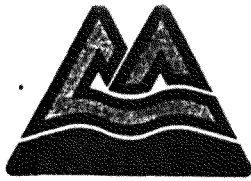

RECOMMENDATION: Social Services Division recommends that the Board of County Commissioners ratify Amendment #19 to the State Mental Health Grant reflecting the contract period of July 1, 1988 through June 30, 1989. Further, we recommend approval of the accompanying budget modification DHS #___ appropriating the additional revenue.

ANALYSIS: This amendment awards \$500 in start-up revenue for Eastco Diversified Services to cover costs associated in converting Work Activity Center slots to Supported Employment slots to serve five Community Integration Project clients. Expenditures of this revenue must occur prior to October 1, 1988. As a result of this amendment, funding from the State Mental Health grant now totals \$10,584,893 for DD services and a net grant total of \$24,085,362 for FY 88/89.

Budget modification DHS #___ appropriates the \$500 start-up revenue in the DD Contracts budget under Pass Through.

BACKGROUND: Eastco Diversified Services submitted a request and start-up budget for expenditures associated with converting vocational slots on August 25, 1988. The State approved this budget and implemented Amendment #19 awarding the revenue.

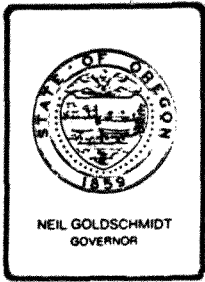

Notes

1. This amendment awards \$500 in DD 43 start-up funds in 1988-89 to convert 5 Work Activity Center and/or Sheltered Services slots to Supported Employment.

This action increases the 1987-89 agreement to \$50,904,625.

Special Conditions

DD 43 start-up funds are subject to the following special conditions:

- 19.1 These start up funds cannot be used for ongoing services. Operating funds for the converted services will remain at the rate and in the service elements currently included in the Intergovernmental Agreement.
- 19.2 Funds must be expended prior to September 30, 1988.
- 19.3 Services converted to supported employment must meet the criteria, measures, and standards of Special Education and Rehabilitation Services (OSERS) federal guidelines. These include:
 - a. Paid employment for at least 20 hours per week.
 - b. Integrated settings where no more than eight people with disabilities work together and which are not immediately adjacent to other programs serving persons without disabilities. The settings should be where persons without disabilities, who are not paid caregivers, are present.
 - c. Ongoing support is available through the use of public funds for interventions, directly related to sustaining employment. This will include onsite visits at least two times monthly.
 - d. Service recipients are persons with severe disabilities, who require ongoing support. Also, they are persons who previously have not been served or served successfully by Vocational Rehabilitation, because of the lack of ongoing service needed to sustain employment after time-limited rehabilitation services are completed.

County and Division recognize that compliance with OSERS guidelines summarized above may require variances from Oregon Administrative Rules governing Activity Centers (OAR 309-47-000 through 060) and Sheltered Services Programs (OAR 582-10-010 through 025). County shall determine what, if any, variances are needed for services converted to supported employment, and shall request such variances following procedures described in Part III of this Agreement.

- 19.4 County must submit a progress report using the form provided and included in this Amendment as Exhibit II. The report must be received by Division no later than October 31, 1988.
- 19.5 Funds are subject to requirements in Exhibit I, "Special Conditions for Start-up Funds".

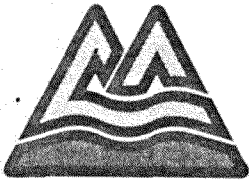
RECOMMENDATION: Social Services Division recommends that the Board of County Commissioners ratify Amendment #19 to the State Mental Health Grant reflecting the contract period of July 1, 1988 through June 30, 1989. Further, we recommend approval of the accompanying budget modification DHS #11 appropriating the additional revenue.

ANALYSIS: This amendment awards \$500 in start-up revenue for Eastco Diversified Services to cover costs associated in converting Work Activity Center slots to Supported Employment slots to serve five Community Integration Project clients. Expenditures of this revenue must occur prior to October 1, 1988. As a result of this amendment, funding from the State Mental Health grant now totals \$10,584,893 for DD services and a net grant total of \$24,085,362 for FY 88/89.

Budget modification DHS #11 appropriates the \$500 start-up revenue in the DD Contracts budget under Pass Through.

BACKGROUND: Eastco Diversified Services submitted a request and start-up budget for expenditures associated with converting vocational slots on August 25, 1988. The State approved this budget and implemented Amendment #19 awarding the revenue.

State contract amendments reflect the entire contract period (July 1-June 30) and are not considered retroactive.

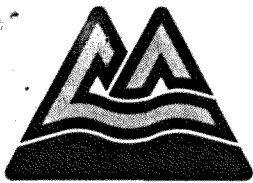

Retroactive: This contract is being submitted late because it was just received in this office.

Recommendation: The Health Division and the Department of Human Services recommend County Chair approval and County Board ratification of this \$20,000 Intergovernmental Revenue Agreement with State Childrens Services Division for the period October 1, 1988 to September 30, 1989.

Analysis: This project partially provides funds for the weekly in-home visits by Community Health Nurses to 50 pregnant youth through the youngster's ninth month of pregnancy. The project monitors the number of teenage women who deliver healthy normal birthweight babies; infants who develop normal growth during the first year of life; and parents who demonstrate nurturance and caring for babies. The Division has \$20,000 in FY88-89 expenditure and revenue budgets for this project.

Background: This contract has been renewed annually since May, 1986. The contracts are directed toward child abuse prevention.

CONTRACTOR: MULTNOMAH COUNTY HEALTH DEPT. DATE: September 15, 1988

I. Services

- A. The Contractor agrees to provide the services described as follows, and in any attachments hereto, in accordance with the terms and conditions stipulated in the contract and its attachments:

The "Family Enhancement" program will provide weekly in-home visits by nurses and trained volunteers to 50 pregnant youth through the youth's ninth month of pregnancy. in accordance with the objectives and evaluation criteria outlined in the attached EXHIBIT I.

It is agreed that the Contractor shall employ NCAST Scales, (Teaching and Feeding Scales), to measure pre/post gains made by clients served in the Contractor's program. At least one professional staff employed by the Contractor shall be trained and able to properly use these scales. All costs of training such staff in the use of NCAST scales will be reimbursed outside this contract.

- B. Services will be provided at 426 S.W. Stark, Portland, Oregon.
- C. The Contractor will submit evaluation reports by the following dates: January 15, 1989, April 15, 1989, July 15, 1989 and October 15, 1989. Outcome data will be required to be included in the evaluation report due July 15, 1989 if the Contractor is applying for continued funding.

II. Consideration

- A. As consideration for the services provided by the Contractor during the period beginning October 1, 1988 and ending September 30, 1989, the Division will pay to the Contractor, by check(s), an amount not to exceed \$20,000 at the rate of \$1,666.66 per month.
- B. Payment for services after June 30, 1989 shall be subject to authorization by the Oregon Legislative Assembly.
- C. Payment will be made by the Division to the Contractor monthly, on or after the first of each month following the month in which the services were performed, subject to receipt by the Division of the billing.

III. Billing

Billings will be submitted monthly to the Accounting Services Section, Children's Services Division, 198 Commercial Street S.E., Salem, Oregon 97310.

GENERAL PROVISIONS

1. Extent of Agreement

This contract contains all the terms and conditions agreed upon by the parties. No other understandings, oral or otherwise, regarding the subject matter of this contract, shall be deemed to exist or to bind any of the parties hereto.

2. Captions

The captions or headings in this agreement are for convenience only and in no way define, limit, or describe the scope or intent of any provision of this agreement.

3. Approval by Executive Department

Executive Department approval of this contract, and any amendments to this contract, is required in accordance with OAR 122-20-015 before the contract or amendment is binding on the parties and before any work may begin under the contract or amendment.

4. Payment as Sole Monetary Obligation of the Division

The contractor is engaged as an independent contractor. Payment as provided herein shall be the sole monetary obligation of the Division. Unless otherwise specified, the responsibility for payment of all operating costs, federal, state, county or city taxes/assessments and any other charges imposed by law upon employers shall be the sole responsibility of the Contractor.

5. Safeguarding of Client Information

The use or disclosure by any party of any information concerning a recipient of services purchased under this contract, for any purpose not directly connected with the administration of the Division's or the Contractor's responsibilities with respect to such purchased services, is prohibited, except on written consent of the Division, or if the Division is not the recipient's guardian, on written consent of the recipient's responsible parent, guardian, or attorney.

6. Equal Rights

The Contractor agrees to comply with all applicable requirements of Federal and State Civil Rights and Rehabilitation statutes, rules, and regulations.

7. Fiscal Responsibility, Records, Controls, Reports and Monitoring Procedures

The Contractor agrees to maintain fiscal records consistent with accepted accounting practices and controls, which will properly reflect all direct and indirect costs and funds expended in the performance of this contract, and all revenue received for programs under this contract. The Contractor shall make these records available at reasonable times upon request to state and federal personnel, and other persons authorized by the Division.

8. Retention of Records

The Contractor agrees to retain all books, records, and other documents relevant to this contract for three years after final payment is made under the contract or all pending matters are closed, whichever is later. If an audit, litigation or other action involving the contract is started before the end of the three-year period, the records shall be retained until all issues arising out of the action are resolved or until the end of the three year period, whichever is later. The Division, a Federal funding agency, the Comptroller of the United States, the Secretary of State of the State of Oregon, or any of their duly authorized representatives, shall have access to any books, documents, papers, and records of the Contractor which are pertinent to the services performed under this contract, for the purpose of making audits, examinations, excerpts and transcriptions. The Contractor agrees to include this provision in any Subcontracts which may be authorized.

9. Subcontracting

Unless subcontracting is authorized elsewhere in the contract, the Contractor shall not enter into any subcontracts for any of the work contemplated under this contract without obtaining prior written approval from the Division, which approval shall be attached to the original contract. Prior written approval shall not be required for the purchase by the Contractor of articles, supplies and services which are incidental but necessary for the performance of the work required under this contract. Approval by the Division of a subcontract shall not result in any obligations of the Division in addition to the agreed rates of payment and total consideration. Any subcontracts which the Division may authorize shall contain all requirements of this contract, and the Contractor shall be responsible for the performance of the subcontractor.

10. Renegotiation or Modification

Any alterations, variations, modifications to or waivers of provisions of this contract shall be valid only when they have been reduced to writing, duly signed, and approved by the Contractor and the Division and attached to the original of this contract.

11. Excuses for Nonperformance

Neither party to this contract shall be held responsible for delay or failure in performance of the activities required herein when such delay or failure is due to causes beyond the control and without the fault or negligence of the party. Such causes may include, but are not restricted to, fire, flood, epidemic, strikes, acts of God or the public enemy,

unusually severe weather, legal acts of public authorities, or delays or defaults caused by public carriers, which cannot reasonably be forecast or provided against. Either party may terminate the contract after reasonably determining that such delay or failure will prevent continued performance of the contract, and after giving written notice to the other party of the cause, its effect on contract performance, and effective date of termination. If the contract is so terminated, the obligation of the Division shall be limited to payment for services provided in accordance with the contract prior to the date of termination.

12. Remedies

If the Contractor fails to provide the services or perform any of the other requirements under the contract, and such failure is not excused under the paragraph titled "Excuses for Nonperformance", the Division, after giving the Contractor written notice of such failure, may withhold part or all of the Contractor's payment for the services until such failure is corrected. If the Contractor does not correct such failure within a reasonable time allowed by the Division, the Division may terminate the contract in accordance with the clause titled "Termination". However, this paragraph, and any actions taken or not taken under it, shall not affect the Division's rights under the "Termination" clause.

13. Termination

- a. This contract may be terminated by mutual consent of both parties, or unilaterally by either party at any time upon 60 days notice to the other party in writing and delivered personally or by certified mail. The Division may also unilaterally terminate this contract effective upon delivery of written notice to the Contractor, or at such later date as may be established by the Division, under any of the following conditions:
 1. If funds, specifically authorized by Legislative acts, do not become available in amounts sufficient to allow for purchase of the stated quantity of services. When possible and when agreed upon by the parties, the contract may be modified in accordance with the paragraph entitled "Renegotiation or Modification" to accommodate a reduction in funds.
 2. If federal or state laws, regulations or guidelines are modified or changed in such a way that the services are no longer allowable or appropriate for purchase under this contract or no longer qualify for the funding proposed for payments authorized by this contract.
 3. If any license or certificate required by law or regulation to be held by the Contractor to provide the services required by this contract is for any reason denied, revoked, not renewed, or changed in such a way that the Contractor no longer meets requirements for such license or certificate.

Termination under this clause shall be without prejudice to any obligations or liabilities of either party already reasonably incurred prior to such termination, except that the Contractor shall be solely responsible for its obligations or liabilities after the termination date which obligations or liabilities result from the Contractor's failure to provide for termination of, or exercise the right to terminate, its commitments. No right of action or damages shall accrue to the benefit of the Contractor if the contract is terminated under this clause.

- b. The Division, by written notice of default (including breach of contract) to the Contractor, may terminate this contract:
1. If the Contractor fails to provide the services called for by this contract within the time specified herein or any extension thereof granted by the Division; or
 2. If the Contractor fails to perform any of the other requirements of this contract; or
 3. If the Contractor so fails to perform the work required in the contract that performance of this contract in accordance with its terms is endangered, and after receipt of written notice from the Division specifying such failure, the Contractor fails to correct such failure within 10 days or such longer period as the Division may authorize.

If the contract is terminated under this clause, the Division's obligations shall be limited to payment for services provided in accordance with the contract prior to the date of termination, less any damages suffered by the Division. The rights and remedies of the Division in this clause related to defaults (including breach of contract) by the Contractor shall not be exclusive and are in addition to any other rights and remedies provided to the Division by law or under this contract.

14. Waiver of Default

Waiver of any default shall not be deemed to be a waiver of any subsequent default. Waiver of breach of any provision of the contract shall not be deemed to be a waiver of any other or subsequent breach and shall not be construed to be a modification of the terms of the contract unless stated to be such in writing, signed by an authorized representative of the Division, and attached to the original contract in accordance with the paragraph entitled "Renegotiation or Modification".

15. Severability

The parties agree that if any term or provision of this contract is declared by a court of competent jurisdiction to be illegal or in conflict with any law, the validity of the remaining terms and provisions shall not be affected, and the rights and obligations of the parties shall be construed and enforced as if the contract did not contain the particular term or provision held to be invalid.

16. Rights in Materials Delivered Under the Contract

To the extent the Contractor has the right to do so, the Contractor grants to the Division a royalty-free, nonexclusive and irrevocable license to use all materials delivered under this contract in any manner and for any purpose whatsoever including to reproduce, publish, disclose, deliver, perform and dispose of, and to have others do so.

17. Clean Air Act, Clean Water Act, and EPA Regulations

If the amount of this contract, including all amendments thereto, exceeds \$100,000, the Contractor agrees to comply with all applicable standards, orders, or requirements issued under Section 306 of the Clean Air Act (42 U.S.C. 1857 (b)), Section 508 of the Clean Water Act (33 U.S.C. 1368), Executive Order 11738, and Environmental Protection Agency regulations (40 CFR Part 15). The Contractor shall report any violations to the Division and to the U.S.E.P.A. Assistant Administrator for Enforcement (EN-329). The Contractor agrees to include this provision in any subcontracts exceeding \$100,000 which may be authorized.

18. Assignment of Contract

The Contractor shall not assign or transfer its interest in this contract without prior written approval of the Division which shall be attached to the original contract. Any such assignment, if approved, is subject to such conditions and provisions as the Division may deem necessary. No approval by the Division of any assignment or transfer of interest shall be deemed to create any obligation of the Division in addition to the agreed rates of payment and total contract consideration.

19. Workers Compensation Insurance - ORS Chapter 656

The Contractor agrees to comply with the Workers Compensation Law - ORS Chapter 656 - and to provide workers compensation insurance and keep it in force during the term of the contract for all employees covered by the law. The Contractor further agrees to indemnify and hold harmless the Division against any and all damages, loss, costs and expenses which the Division may sustain, incur, or be required to pay, as a result of the Contractor's failure to provide such insurance for its covered employees providing services under this contract.

20. Funds Authorized and Available

The Division certifies that at the time of signing this contract sufficient funds are authorized and available or are anticipated to be available for expenditure to finance costs of this contract within the Division's current appropriation or limitation.

21. Recovery of Overpayments

If billings under this contract, or under any other contract between the Contractor and the Division, result in payments to the Contractor for which the Contractor is not entitled under the terms of such contract, the Division, after giving written notification to the Contractor, may

withhold from payments due to the Contractor under this contract such amounts, over such periods of time, as are necessary to recover the amount of overpayment.

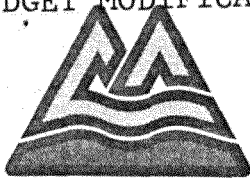

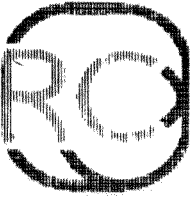

Barbara Donin, Chair's Office, reported that Laurence Kressel, County Counsel, had advised that a Resolution could be substituted for the proposed Ordinance.

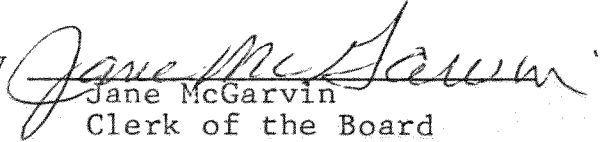

An ordinance establishing a task force to recommend rules and criteria governing access to the workplace and access to payroll deduction.

Multnomah County ordains as follows:

Section 1. Findings

1. County employees have historically participated in financial aid to a variety of social needs.
2. County employees should have the opportunity to donate to charitable funds, federations and social service agencies by authorizing payroll deductions to such agencies.
3. The County's payroll system can only accommodate a finite number of payroll deductions.
4. An equitable system for determining which charitable organizations should be permitted to participate in the payroll deduction system needs to be developed.
5. Clear guidelines need to be developed for determining the subsequent level of access to the workplace.

Section 2. Membership of Task Force

- A. There is hereby established a Task Force on Charitable Solicitations.
- B. The Task Force shall consist of the following with legal advice being provided by County Counsel:

1. one representative from Finance
2. one representative from Employee Services
3. one representative from the Board of County Commissioners
4. one representative from the County Chair
5. one representative from non-exempt employees
6. one representative from DHS, DES and DJS
7. one citizen representative

Section 3. Duties of the Task Force

A. The task force shall consider the following issues when formulating recommendations for the Board's consideration:

1. Administrative cost to the County
2. Impact on the County's ability to conduct business focusing particularly on potential disruption to the workplace
3. Criteria for determining which organizations can participate
4. Relevant legal issues
5. Employee attitudes toward expanded program
6. Approaches being used by other jurisdictions
7. Time frame for campaigns

B. The task force shall present its recommendations to the Board of County Commissioners no later than January 31, 1989.

Section 4 Adoption

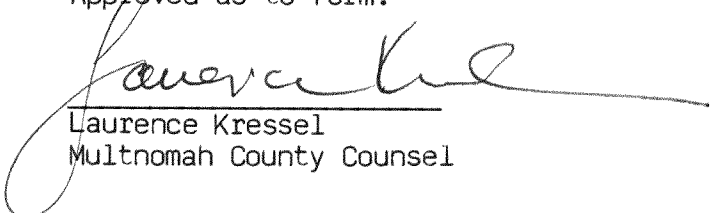

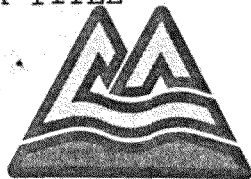
