

BEFORE THE BOARD OF COUNTY COMMISSIONERS  
FOR MULTNOMAH COUNTY, OREGON  
ORDINANCE NO. 386

An Ordinance establishing a Joint County/City Public Safety Commission.

Multnomah County Ordains as follows:

SECTION 1. Public Safety Commission

- A. Examine the findings of previous studies on reducing crime and assess the feasibility of crime reduction measures,
- B. To examine the following areas of concern:
  - . defendant-offender relationships and concerns
  - . youthful offenders and defendants
  - . family violence
  - . victim assistance and restitution
  - . community involvement and education
  - . law enforcement and public service agencies
- C. To present the draft public safety policy to the community in a series of hearings during the Spring of 1984.
- D. To develop a comprehensive public safety policy,
- E. To transmit a report to the County Commission and the City Council within one year of convening,
- F. To monitor the implementation of the Public Safety Policy.

SECTION 2. Membership of the Commission

The Commission shall consist of 30 members from Multnomah County who have special interest or ability in areas of criminal justice and crime prevention. Representatives from all major communities within Multnomah County, including but not limited to, Portland, Gresham, and unincorporated east Multnomah County shall be included in the membership. In addition, one seat will be guaranteed for a representative from the Justice Coordinating Council.

Members of the public wishing to be considered for membership on the Commission must submit applications no later than August 1, 1983 to the County Executive.

### SECTION 3. Selection Process

Members of the Commission shall be jointly appointed by the County and the City. The County Executive or his designee and one County Commissioner or his designee and two members of the City Council shall form a sub-committee which shall review applications against stated criteria. Appointments shall be made pursuant to the County Charter. The current liaison to the Justice Services Department shall serve on the subcommittee.

The following criteria is suggested for use by the sub-committee when reviewing applications. The sub-committee, however, will finalize selection criteria:

- . willingness to accept time commitment
- . community experience/involvement
- . interest in and/or involvement with the criminal justice system
- . live or work within Multnomah County
- . references

### SECTION 4. Terms and Compensation

The Commission will be convened for two years beginning September 15, 1983. It will spend one year in policy development and one year in implementation. Commission members will not be compensated financially for their time or expenses.
